The Financial Bid of the prospective Bidder will be considered only if the Technical Bid of the Bidder is found qualified by the Tender Evaluating Authority, WBSEDCL. The decision of the Tender Evaluating Authority, WBSEDCL will be final and binding in this respect. Bidder's Representative may remain present during Opening of Tender.
- 7. Tenders shall remain valid for a period not less than 180 (One Hundred Eighty) days from the date of opening of Financial Bid. Tender with shorter validity period shall be rejected as non-responsive.
