Chief Engineer & Project Manager, Rammam Hydel Project, Stage - II, WBSEDCL, Lodhamahat, Darjeeling-734201 from bona-fide eligible, resourceful and experienced contractors of WBSEDCL / WBSETCL or any other Government Organizations, for Maintenance Contract for "ROUND THE CLOCK MAINTENANCE OF HT / LT LINES, COMMUNICATION SYSTEM AND OTHER ELECTRICAL SYSTEMS AT VARIOUS OUTSIDE POWER HOUSE ESTABLISHMENTS UNDER THE PROJECT AREA OF RAMMAM HYDEL PROJECT ST-II, WBSEDCL FOR TWO (02) YEAR FROM APRIL, 2026 TO MARCH, 2028 with a provision for further extension of one year based on satisfactory performance and as per agreed rates" at Rammam Hydel Project, Stage-II, WBSEDCL, Lodhamahat, Darjeeling-734201.

1. **Name of Work:** "ROUND THE CLOCK MAINTENANCE OF HT / LT LINES, COMMUNICATION SYSTEM AND OTHER ELECTRICAL SYSTEMS AT VARIOUS OUTSIDE POWER HOUSE ESTABLISHMENTS UNDER THE PROJECT AREA OF RAMMAM HYDEL PROJECT ST-II, WBSEDCL FOR TWO (02) YEAR FROM APRIL, 2026 TO MARCH, 2028 with a provision for further extension of one year based on satisfactory performance and as per agreed rates"
2. **Estimated Amount:** Rs. 63,91,693.00/- (Rupees sixty three lakh ninety one thousand six hundred ninety three only), without GST
3. **Earnest Money:** Rs. 1,59,792.00/- (Rupees one lakh fifty nine thousand seven hundred ninety two only)
4. **Eligibility Criteria:** The Bidder must possess minimum eligibility criteria as mentioned below:
  - a. The bidder should have a registered office anywhere in India.
  - b. The bidder(s) should satisfy the following minimum eligibility criteria as under:

The bidder must have successfully completed any of the following during last 07 (seven) years, reckoned from the date of publication of this tender.

Three (03) similar works each costing not less than the amount equal to 40% of the estimated value of the tender,

Or,

Two (02) similar works each costing not less than the amount equal to 50% of the estimated value of the tender,

Or,

One (01) similar work each costing not less than the amount equal to 80% of the estimated value of the tender

**Note:**

- Work experience certificate from private individual shall not be considered.
- Similar work means: "Satisfactory execution of line erection/maintenance work of 11 kV overhead line or above voltage level as well as electrical work in Service building / Staff quarters / Offices / Road & colony lighting / LT installation."
- c. Annual turnover should be at least Twenty (20) Lakh Rupees in any financial year during the last Three (03) years.
- d. The bidder should submit MSME certificate if they fall under the said category.
- e. Electrical Contractor License
  - The Contractor must have Valid Electrical Contractor's License along with valid Supervisory Competency Certificate fulfilling qualified parts under Sl. No. (1), (2), (4), (6A), (7A) and (11) of Form - B issued by the State Government, failing which tender would be considered ineligible.
  - The work shall be carried out by the contractor, having valid Electrical Contractor's License for carrying out installation work under the direct supervision of the persons holding valid certificates of competency issued by the State Government.
  - The successful bidder shall furnish the names and particulars of the certificate of competency of supervisor and workmen to be engaged for carrying out this work.
- f. The bidder must possess & submit the following documents along with the bid.
  - Proof of experience as per Sl. No. 4.b above
  - Valid Electrical Contractor's License along with valid Supervisory Competency Certificate as per Sl. No. 4.e above
  - Employees' Provident Fund (Registration).
  - GST Registration Certificate and furnish of last 2 (two) years GST return.
  - Trade License
  - Up to date P. Tax challan.
  - PAN No. & IT Return for last three (03) years.
  - Balance sheets for last three (03) financial years
  - MSME Certificate, if applicable

The Bidder shall produce original copy of the documents i.r.o. eligibility criteria, if so required by WBSEDCL. Any discrepancies found by the tender inviting authority may lead to rejection of the bid and forfeiture of the earnest money.

Necessary Earnest Money Deposit (EMD) should be submitted through online only. The Interested bidders may submit the bids online at <https://wbtenders.gov.in>. Bids are to be submitted online only. All the documents in support of bid are also to be scanned and uploaded along with the tender document. Bid submitted/sent by any other mode will not be accepted.

## 7. Scope of Work:

Round the clock Maintenance of HT / LT lines, Communication System and other Electrical Systems at various Outside Power House Establishments under the project area of Rammam Hydel Project St-II, WBSEDCL for two (02) year from April, 2026 to March, 2028 with a provision for further extension of one year based on satisfactory performance and as per agreed rates

For detailed scope of work, the bidders are requested to go through Cl. No. 4 of SCC.

**8. Validity:** The tender shall be valid for one hundred and eighty (180) days from the date of opening of technical bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of Earnest Money Deposit (EMD).

**9. Conditional / Incomplete tender will not be accepted under any circumstances.**

**10.** During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other document submitted by the Bidder is incorrect / manufactured / fabricated, or false at any stage, that bidder would not be allowed to participate in the tender and his Tender will be rejected with forfeiture of earnest money and legal action may be taken against him.

**11.** The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s). WBSEDCL reserves its right to take decision keeping its financial interest.

**12. WBSEDCL reserves the right to:**

- Amend the scope of work to be tendered.
- Reject any or all the offers without assigning any reason whatsoever at any time prior to the Award of Contract, without thereby incurring any liability to the affected bidder(s); and
- Cancel the bidding process and reject all bids, without assigning any reasons thereof.

WBSEDCL will not be liable for any such actions. However, the bidder(s), who wish to seek reasons for such decision of cancellation / rejection, shall be informed by WBSEDCL unless its disclosure reasonably could be expected to affect the sovereignty and integrity of India; the security, strategic, scientific or economic interest of the State; relation with foreign state or lead to incitement of an offence. In such case, the Earnest money submitted by the bidder(s) will be refunded to the bidder without any interest.

**13.** WBSEDCL reserves the right to assess the bidders' capacity and capability to perform the contract and may relax the qualifying requirements at any stage, if required.

**14.** No price preference will be allowed to any agency / supplier / contractor based on the size of the company or its geographic location. Co-operative Society / MSME will not be considered with separate status.
