#### 3.0 SUBMISSION OF TENDER:

### 4.0 ELIGIBILITY CRITERIA OF THE BIDDER:

#### 4.1 Technical:

A bidder shall be considered technically eligible, with experience of having successfully completing Electrical Wiring works of similar nature of works with a focus on electrical substation and building complex work during last 5 years subject to fulfilment of the following criteria

- Three similar completed works costing not less than the amount equal to 40% of the estimated cost.
  Or
- ii) Two similar completed works costing not less than the amount equal to 50% of the estimated cost.

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

#### Credentials:

- i) the bidder must have the credential and experienced manpower for having AMC for Wiring work of aforesaid buildings for not less than 3 years in total as per contract.
- ii) Manpower should be eligible with valid License to work permit for doing the scheduled job and must have work experience of such kind of job for about 3 years.

### 5.0 Commercial & Financial:

- a) The average annual turnover of the bidder during last three years shall not be less than 30% of the estimated cost.
- b) Working capital in the year, proceeding the year of bid submission shall not be less than 30% of the estimated cost.
- c) In case documents certifying credit facility from a scheduled bank is submitted, the requirement given in clause 5 (b) shall be judged by adding available credit facility and working capital taken together.
