- ii. Average annual turnover during last three years shall not be less than 30% of the estimated cost. [Non-statutory Documents].
- iii. Working capital in preceding year of bid submission shall not be less that 30% of the estimated cost. [Non-statutory Documents].
- iv. In case documents certifying credit facility from a scheduled Bank is submitted, the requirement given in 3. (iii) shall be judged by adding available credit facility and working capital taken together. [Non-statutory Documents].
- v. Annual Audited Financial Report for last 3 (three) years to be submitted for verification in respect of bidders for whom audit of accounts is mandatory (3CA/3CB and particulars are reported in the Form 3CD u/s 44AB of Income Tax Act'1961).
