NOTICE INVITING e-TENDER

West Bengal State Electricity Distribution Company Limited (WBSEDCL) acting as West Bengal State Designated Agency (WBSDA) for Bureau of Energy Efficiency (BEE), MoP, GoI, intends to hire an Agency for providing 03 (three) nos. Technical Manpower to assist WBSDA for carrying out jobs related to Conservation of Energy within West Bengal for 01 (one) year. In this connection, the Chief Engineer, Planning, Investigation & Design Department, WBSEDCL, being the Nodal Officer of WBSDA, invites e-tender in two parts from bona fide agencies having experiences of similar job of Providing technical manpower as stated in the eligibility criteria mentioned in 'Clause No.-5 of Instructions to Bidders (ITB)' of this tender:

TERMS AND CONDITIONS OF THE TENDER NOTICE:

1. **Registration of Bidder:** Intending eligible bidders, desire to participate in the tender will have to be enrolled and registered with the Government of West Bengal e-procurement system and may download the tender document from the website <https://wbenders.gov.in> directly with the help of *Digital Signature Certificate (DSC)*. The tender can be searched by typing WBSIEDCL in the search engine provided in the above-mentioned website.
2. **Digital Signature Certificate (DSC):** Bidders willing to take part in the process of e-tendering are required to obtain valid Digital Signature Certificate (DSC) issued from any agency authorized by *Controller of Certifying Authority (CCA)*, Govt. of India. The registration should be in the name of bidder, whereas DSC holder may be either bidder himself or his duly authorized person. Tenders shall be submitted online and intending bidders should download the tender documents from the website stated above, directly with the help of the DSC. This is the only mode of collection of tender documents. Details of submission procedure are given in 'Clause No.-9&10 of Instructions to Bidders (ITB)'.
3. **Contract Performance Security:** The contract performance security for the successful bidder shall be as per 'Clause No.-13 of General Conditions of Contract (GCC)'.
4. **Bid Submission:** Technical Bid and Financial Bid are to be submitted online through the website <https://wbenders.gov.in> with the help of the *Digital Signature Certificate (DSC)* within the stipulated date and time.
5. The financial proposal of the prospective bidder will be considered only if the technical proposal of the bidder is found qualified by the tender inviting authority. The decision of the tender inviting authority will be final & binding on all concerned and no challenge against such decision will be entertained. In any circumstance or whatever may be the outcome of the present invitation of the bid, cost of the bidding will not be reimbursed/refunded by WBSIEDCL (WBSDA). The list of techno-commercially qualified bidder(s) along with the ones whose bids are not qualified will be displayed in the website.
6. **Bid Validity:** Bids shall remain valid for a period not less than **180 (One hundred eighty)** days from the date of opening of *FINANCIAL BID*. If the bidder withdraws the bid before the period of bid validity, the earnest money to be deposited by him will be forfeited forthwith without assigning any reason thereof.



10. No conditional bid and/or incomplete bid will be accepted under any circumstances.
11. The intending bidder(s) are to quote their *rates* online as per specified format.
12. **Disqualification of Bidders:** Any evidence of unfair trade practices including over charging, price fixing, cartelization etc. as defined in various statutes, will automatically disqualify the bidders even if, the bidders meet the eligibility criteria described in '*Clause No.-5 of Instructions to Bidders (ITB)*'. Details in this respect are given in the '*Clause No.-16 of Instructions to Bidders (ITB)*'.
13. No agent is allowed to participate in the tender. Original agency will only be allowed in the tender.
14. **Amendment of the Bid Documents:** The tender inviting authority reserves the right to modify, amend or supplement the tender document. Any corrigendum, notification concerning this tender will be published in the e-tender portal <https://wbtennders.gov.in> and it will be treated as part and parcel of the tender. The bidders are, therefore, advised to follow the website for such corrigendum, notification etc.
