3.0 SUBMISSION OF TENDER:

The tender will be submitted in two bid systems i.e. Techno-Commercial bid & Financial bid, online only through the Website www.wbtenders.gov.in

4.0ELIGIBILITY CRITERIA OF THE BIDDER:

4.1 Technical:

The bidder must have successfully completed construction of similar nature of work having contract value not less than 50% of the estimated cost in a single contract during last three years for <u>sl. no.1.</u> in a single order. All the required License and enlistment must be produced for such kind of Works.

4.2 Commercial & Financial:

- 4.2.1 The average annual turnover of the bidder for best two years out of the financial years 2020-21,2021-22, 2022-23 shall be minimum 8(Eight) lakhs for sl.no.1, (Annexure-I).
- 4.2.2 The working capital and credit facility taken together either for 2018-19,2019-20,2020-21, 2021-22 shall be minimum 9 (Nine lakhs for sl.no.1,(Financial Capability proof certificate from bankers, one year from date of Publication of NIT).

RTGS/NEFT Payment: On selection of RTGS/NEFT as the payment mode, the e-procurement portal ii. will show a pre-filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.

B) GENERAL INSTRUCTIONS FOR ONLINE PAYMENT OF EMD:

The bidder will have to mandatorily pay through Net-banking facility once Net-banking mode is opted for payment.

Status of NEFT/RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.). As such bidders opting to pay through NEFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicacy.
