Specification -

- 1. Fixed Contact (i) Should be made from Electrolytic Copper Strip 50 MM X 3 MM Jaw type to be electro-silver plate with 8 Micron deposit. (ii) Fixed contact guard to be made from MS Strip 50 MM X 1.5 MM (16 SWG) shaped properly and galvanized & (iii) 2 NOS stainless steel springs made from 16 SWG wire shall be used at both ends of the fixed contact through 6 MM dia. 90 mm long stainless steel stud threaded at both ends and provided with stainless steel nuts, check nuts and flat washer. The contact pressure should not be less than 90 KG.
- 2. Moving Contact (i) Shall be made from 20 MM dia hard drawn electrolytic copper rod. (ii) One end of the rod shall be flattened up to 175 MM in length by drop forging and provided with a hole for fixing on the post insulator. (iii) The other end is to be bent suitably for making contact into the fixed contact jaw. (iv) The palmed portion of the copper rod should have minimum 28/30 MM width X 8 MM thickness.
