- 1. In the event of e-filling intending bidder may download the tender document from the website https://wbtenders.gov.in directly with the help of Digital Signature Certificate.
- 2. Both Technical Bid and Financial Bid should be submitted in technical and financial folder concurrently duly digitally signed by the Tenderer through the website https://wbtenders.gov.in.
- Technical Document and Financial Bid should be submitted online on or before as per the "Date & Time Schedule" stated in SI No.-07.
- 4. The FINANCIAL OFFER of the prospective tenderer will be considered only if the TECHNICAL DOCUMENT of the tenderer found qualified by the Tender Inviting Authority. The decision of the Tender Inviting Authority will be final and absolute in this respect. The list of Responsive and Non-Responsive Bidders will be displayed in the portal.

5. Eligibility criteria for participation in the tender:

Bonafide, experienced & resourceful Suppliers/Manufacturers who have successfully supplied the tendered items/similar items to WBSEDCL / other Power Utilities / other Public / Government Departments on earlier occasions. Requisite Purchase Order & store receipt copy needs to be submitted with the Offer proving the successful delivery of the items.

- Instruments should be calibrated from any NABL accredited Laboratory. Calibration certificate should bear NABL logo in each page. Calibration results shall comply with the specifications.
- · Guarantee period should be at least 12 months.
- Bids will be accepted only after meeting the technical requirement as per specification and demonstration. All intending Bidders are required to produce valid copies of Professional Tax (PT) Clearance Certificate along with PAN Card, Annual Audited Financial Report for last 3 years / IT return for 3 years (3CA and 3CB if applicable) / IT return for 5 years for unaudited accounts, GST Registration Certificate(including HSN

- 7. Bids shall remain valid for a period not less than 120(one hundred twenty) days after date of Bid opening of tender. Bid valid for a shorter period shall be rejected by the Tender Inviting Authority as non-responsive. If the tenderer withdraws the bid before the period of bid validity without giving any satisfactory explanation for such withdrawals, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
- 8. Specification of materials: Control Panel for loss measurement should be as per technical specification enclosed herewith.

10. Earnest Money/Bid Guarantee:

A bidder desirous of taking part in a tender invited by offices of WBSEDCL shall login to the e-Procurement portal of Government of west Bengal https://wbtenders.gov.in using his login Id and password.

The bidder shall select the tender to bid and initiate payment of EMD amount. Exemption from deposition of EMD shall not be allowed under any circumstances. No Interest shall be payable by WBSEDCL on the above bid guarantee.

Following payment options are available for paying EMD amount through online mode:

- a. Net-banking through Payment Gateway
- b. RTGS/NEFT Payment: On selection of RTGS/ NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the prefilled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.

EMD amount need to be paid in online mode. Any other mode of payment will not be accepted.

11. General Instructions for Online Payment:

- The bidder will have to mandatorily pay through Net-banking facility once Net banking mode is opted for payment.

- c. In case actual EMD amount as per NIT is more than the one shown in E-tender Portal, bidders will have to opt for NEFT/RTGS mode (challan mode). In that case the total actual EMD amount is to be paid only through NEFT/RTGS mode (challan mode).
- d. The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.

12. Refund/Settlement of EMD Amount:

- a. For unsuccessful bidders, EMD amount submitted against the tender shall be refunded automatically, through an automated process, by NIC portal on receipt of updated status of any bid.
- b. The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.
- c. For any queries related to payments and refunds, bidders will have to communicate with ICICI Customer Support, viz, 033- 40267512/ 13, since payment gateway facility used by Etender portal is maintained by ICICI.
- 13. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of the Bid, the Tender Inviting Authority reserves the right to accept or reject any / all offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by the Bidder at the stage of Bidding.
- 14. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in "Instruction to bidders" stated in Section "A" before tendering the bids.
- 15. No Conditional Bid / Incomplete Tender will be accepted under any circumstances.
- 16. At any stage during scrutiny, if it is found that the credential or any other papers which the Bidder uploaded during Bidding process, found incorrect / manufactured / fabricated, that bid will be considered a nonresponsive and outright rejected with forfeiture of Earnest Money and action will be taken as per norms of WBSEDCL in force.
 - 17. Before issuance of Letter of Acceptance / Work order/ Purchase Order, the tender accepting authority may verify the credential & other documents of the lowest bidder so uploaded online if found necessary. If it is found such document incorrect / manufactured / fabricated, Letter of Acceptance / Work order will not be issued in favour of the bidder under any circumstances and action will be taken accordingly.
- 18. The Tender Inviting Authority reserves the right to cancel the NIT due to unavoidable circumstances and no claim in this respect will be entertained.
- 19. The company shall no way be held responsible or liable for any accident, miss hap of any worker during the execution of the work, any loss or damage cause to any equipments of WBSEDCL during execution shall have to be compensated in full as per direction of the Tender Inviting Authority.
- 20. Standard safety norms as prescribed in the rules and regulations of WBSEDCL have to be religiously followed.
- 21. Liquidated damages @ 1/2% of the value of the materials plus GST as applicable of the particular lot offered and/or delivered beyond the schedule delivery period for each week of delay or part thereof upto 10(ten) weeks and @ 1% of the value plus GST as applicable per week beyond 10 weeks subject to maximum of 10% of the particular lot plus GST as applicable will be charged on the bill for non completion of work in time. The mobile number of the bidders has to be mentioned.
