The intending tenderers should submit their application in duplicate, along with attested copies of credentials demonstrating satisfactory performance, supported by payment certificates for the execution of similar works completed at any time during the preceding seven years. The credentials must include:
 - At least one contract with a value of not less than 80% of the tendered amount, or
 - Two contracts, each with a value of not less than 50% of the tendered amount, or
 - Three contracts, each with a value of not less than 40% of the tendered amount.

In addition, the following documents must be submitted:

- Up-to-date Income Tax returns for the last three years
 - Professional Tax challan for the last month
 - Valid Trade License
 - GST Registration number with current returns/challans
 - PAN Card
 - EPF registration number with the latest challans
 - ESI registration number with the latest challans

10. Security period for the work is 06 months from the date of completion, the intending bidder may please note that an amount equal to 10 % of the value of the bill will be deducted from the R.A. Bill & Final bill as security deposit will be refunded after completion of security period from the date of the completion of the work.


