All categories of intending Bidders shall have satisfactorily completed at least one work of similar nature under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government of executed value not less than 80% of the estimated cost at any time during the preceding three years on single contract value. Completion Certificate from the concerned Statutory Body of Central / State Government will be treated as valid credential.
2. To purchase the Tender Document the intending bidder will have to submit his/her application (in duplicate) along with self-attested copies of (a) PAN card, (b) GST registration certificate, (c) Professional tax enrolment and payment certificate, (d) EPF Registration certificate & latest Challan of depositing EPF, (e) ESI Registration certificate & latest challan of depositing ESI & (f) Income Tax Return (for last 03 Financial Year) on or before **22.06.2023 upto 03.00PM**. Originals shall have to be produced for verification on demand.
3. Neither prospective Bidder nor any of the constituent partners had been debarred to participate in any Tender by any Government Department / Semi- Govt. /Govt. Undertakings / Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarment will be considered as disqualification towards eligibility.
4. The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.



5. The Tender Document will be available at the office of the undersigned on **27.06.2023 & 28.06.2023** between 11.00AM to 02.00PM after obtaining clearance from the undersigned or his authorized representative.
6. The Tender document will not be sent by post and will not be issued on the date of opening.
7. Dully filled Tender documents should be submitted in sealed covers super-scribing on its body THE NAME OF WORK, TENDER NOTICE NO, DUE DATE OF OPENING OF TENDER AND NAME OF THE BIDDER within **03.07.2023 till 02.00PM** and will be opened on same day at **03.00PM** at this office in presence of the attending bidders or their authorize representative.
8. Tender Fee shall have to be deposited in the form of demand draft/Bankers Cheque on-any Scheduled Commercial Bank payable at Bankura & drawn in favour of "West Bengal State Electricity Distribution Company Limited". Exemption from deposition of Tender fee shall not be allowed under any circumstances.
9. The tender shall remain valid for 180(One hundred eighty) days from the date of opening of the tender.
10. The intending bidder may please note that successful bidder shall have to submit authenticated valid documents regarding compliance of all applicable labour laws and the rules there of.
11. The intending bidder may please note that an amount equal to 3% of construction cost/value of bill will be deducted from R/A bills & Final bill as Security Deposit which is refundable after completion of Security Period from the date of completion of the work.
12. Security Period for the work is 06 Months from the date of completion of the work.
13. GST will be paid extra. Payment of GST will be as per rules/Statutes prevailing during the execution of the contract.
14. The WBSEDCL does not bind itself to accept the lowest bid and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without signing any reason whatsoever.
15. If the above mentioned office happens to be closed on the date of receipt of application and/or on the date of issue of the Bid Documents and / or on the date of receipt / opening of Bid documents, the next working day (except Saturday) at the same time and venue shall be applicable for the said purpose.
16. Additional Performance Security: If the lowest bidder's bid found to be within the range of -20% to -80% of the estimated value, the bidder shall have to furnish an Additional Security amounting to 10% of the tendered amount. The Additional Performance Security shall be submitted in the form of Bank Guarantee from any schedule bank before issuance of Work Order.
