- (ii) All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax Receipt Challan, P.F. Registration number with current P.F. enrolment fees challan and current return/challan, GST Registration no. with current return/challan (if any) of, E.S.I. Registration no (for execution of works in ESI coverage area) with current return/challan, PAN Card and Income Tax Return for last three Assessment Years i.e. 2023-24,2022-23,2021-22 in respect of the prospective Bidder. Proprietorship Firm (Trade License). Partnership Firm (Partnership Deed, Trade License). Ltd Company (Incorporation certificate, Trade License). - (iii) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt./Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. - (iv) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. - (v) No conditional / Incomplete Tender will be accepted under any circumstances.
