- (i) All categories of intending Bidders who have satisfactorily completed **similar nature of works during last 5 (five) year** under the authority of State/Central Government, State/Central Government Undertaking, Statutory Bodies constituted under the statute of Central/State Government with valid copies required documents. Similar nature of work would means works related to electrical item installation (upto 415 volts).
- (ii) All categories of intending Bidders shall have to submit valid copies
 - a. GST Registration certificate,
 - b. PAN Card,
 - c. Trade License.
 - d. IT returns (Last 3 years)

Any documents in original if asked may have to be produced at the time of collection of tender documents for verification and a copy of it is to be submitted with the tender document.

4. Neither prospective Bidder nor any of the constituent partners had been barred to participate in any Tender by any Government Department/Semi-Govt./Govt. Undertaking/ Enterprise etc during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. A declaration in this respect shall have to be submitted by the bidder (as per annexure - II).
5. The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. A declaration in this respect shall have to be submitted by the bidder (as per annexure - II).
6. Bidders have to quote rates for all of the items as per Price Schedule format in Section-B. Tender documents should be dropped in the tender box in a sealed envelope with tender no. and date of opening prominently written outside the envelope. No conditional / Incomplete Tender will be accepted under any circumstances. In no condition, tender documents will not be issued/ received by post.
7. Intending bidders may visit the site giving prior intimation to the office before submission of tender.
8. **Scope of Work:**
The Scope of work comprises of renovation of LT Distribution Panel along with supply and fixing of accessories and components as required and carrying out all electrical connection suitable for 100 A. 415 V, 3-phase, 4-wire, 50 Hz, Copper bus bar along with required number of incoming and outgoing feeders (Detailed in Scope of work at Section - D)
9. **Bid Guarantee (Earnest Money deposit):**
The bid must be accompanied by earnest money deposit (EMD) of **Rs.2122** (Rupees two thousand one hundred and twenty two only) for the above mentioned work as bid guarantee, failing which the bid shall be considered as non-responsive and hence liable for rejection. Bid guarantee (EMD) shall be submitted in a separate sealed envelope payable either through **Banker's Cheque (BC)/CTS 2010 compliant Demand Draft (DD)** issued from any scheduled bank approved by RBI in favour of "WEST BENGAL STATE ELECTRICITY DISTRIBUTION COMPANY LIMITED " payable at Siliguri. Bid guarantee of the successful bidders shall be converted into initial part of security deposit for the contract.
