Scope of work:

Scope of work shall be as defined hereunder: -

- 1. The agency/firm must provide maintenance services of all FXS/FXO Gateway, Voice Routing, Network Routing and Network Switching and related equipment installed at PPSP Site.
- 2. The parts for which services could not be provided shall be provided by PPSP. The defective parts removed shall become the property of PPSP, if replaced from the existing hardware's. Defective parts shall be registered and mentioned in the stock register.
- 3. The agency / firm shall provide service for all spares (Hardware) which cover under the contract as well as any other need or service without any extra charges. Maintenance, configuration, and firmware up gradation of FXS/FXO Gateway, Voice Devices, Network Switches will be responsibility of the agency / firm.
- 4. The Technician/Expert will note the complaint received by mail with the name of complainant, details and date of complaint and allot a complaint no. to complainant who will be indicated in the call report or Logbook.
- 5. In case of any complaint, the Technician/Expert shall attend to the fault with immediately and rectify the problem within 48 business hours.
- 6. If there is any type of problem in a system which could not be rectified within 48 hours, the clear reason, solution & time for the rectification of the problem should be mentioned by the agency/firm engineer by mail through mail or on the call report/Log Book.
