- II. **Price:** Price should be firm inclusive of all incidental charges. GST value and percentage to be written separately in quotation. However GST will be applicable as per law of land at the time of placement of order. STDS will be deducted as per norms.
- III. **Payment:** 97% Payment will be made within 45(Forty Five) days after submission of the Bill. Bills in triplicate along with challan in triplicate and advance pre-receipt copy with revenue stamp must be given by the Agency, gurantee/warranty certificate and completion report dully certified by the supervising officer. Payment will be made through R.T.G.S/N.E.F.T (R.T.G.S/N.E.F.T charge to be borne by the Agency). Balance 3 % shall be kept as security deposit towards performance Guarantee which will be released after expiry of guarantee/ warrantee period with satisfactory performance.
