3. Eligibility criteria for participation in tender:

- The bidder must have successfully completed similar works during last 7 (Seven) years from the date of this Notice Inviting Tender under the authority of State/Central Government, State/Central Government Undertakings, Statutory Bodies constituted under the statute of Central/State Government, subject to fulfillment of the following criteria:

(a) **Three similar** completed works each having executed cost not less than 40% of the total estimated cost in a single contract,

OR

(b) **Two similar** completed works each having executed cost not less than 50% of the total estimated cost in a single contract,

OR

(c) **One similar** completed work each having executed cost not less than 80% of the total estimated cost in a single contract. [Non-statutory Documents]

- Average annual turnover during last three years shall not be less than 30% of the estimated cost. [Non-statutory Documents].
- Working capital in preceding year of bid submission shall not be less than 30% of the

- iv. In case documents certifying credit facility from a scheduled Bank is submitted, the requirement given in 3. (iii) shall be judged by adding available credit facility and working capital taken together. [Non-statutory Documents].
 - v. **Annual Audited Financial Report** for last 3 (three) years to be submitted for verification in respect of bidders for whom audit of accounts is mandatory (3CA/3CB and particulars are reported in the Form 3CD u/s 44AB of Income Tax Act'1961). For those whose audit of accounts is not mandatory, they shall submit copy of **IT returns, Balance Sheet, P&L Statements** along with related enclosures **for last five years**. [Non-statutory Documents].
 - vi. All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax receipt Challan, Up to date valid Professional Tax receipt Certificate, E.P.F. Registration, Up to date E.P.F. Challan (at the latest, by at least Three months from the date of floating of Tender), E.S.I. Registration (If applicable), Up to date E.S.I. Challan (at the latest, by at least Three months from the date of floating of Tender), GST Registration Certificate, Up to date GST return copy (at the latest, by at least Three months from the date of floating of Tender), PAN Card, Valid Trade License in respect of the prospective Bidder and Income Tax Return for last three years, Information (If any) regarding any past and current litigation with WBSEDCL/WBSETCL/Govt/PSU in which bidder is involved, the party's concerned and disputed amount.

Such debarring will be considered as disqualification towards eligibility. **(A declaration in this respect has to be furnished by the prospective bidders) on Rs. 100 non-judicial stamp duly notarized by Notary Public.** [Non-statutory Documents]
 - ix. The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. **(A declaration in this respect has to be furnished by the prospective bidders).** [Non-statutory Documents]
 - x. No conditional / Incomplete Tender will be accepted under any circumstances.

5. No mobilization advance and secured advance will be allowed.
6. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a single job, all his offers will be rejected for that job.
7. Bid shall remain valid for a period not less than 180 (one hundred eighty) days from the last date of submission of Technical Bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).
