Terms and Conditions:

1. **Delivery Period:** Within 45 Days from placement of order.
2. **Place of delivery:** The materials shall have to be delivered at Store of Massanjore Hydro Power Station (M.H.P.S.), WBSEDCL, Massanjore, District-Dumka, State: Jharkhand, PIN – 814144.
3. **Price:** Price should be firm inclusive of all incidental charges FOR M.H.P.S. GST should be mentioned separately as applicable which will be paid as extra.
4. **Payment:** 90% Payment will be made within 45 days after successful delivery of materials M.H.P.S. Site Store, drawal of Store Receipt Voucher from M.H.P.S. Store and on submission of original bill/ Tax Invoice in triplicate with advanced pre-receipt (Duly signed on Revenue Stamp), Road Challan, Guarantee/warranty Certificate, RTGS/ NEFT Details, Cancelled Cheque which are to be submitted at M.H.P.S. Site, Massanjore at the time of delivery of materials. Payment will be made by RTGS/NEFT whose charge shall be borne by the agency.

Balance 10% shall be kept as Security Deposit. This amount will be refunded to the agency after completion of Warranty Period and on receiving application for Security Refund from the agency.

No claim shall be made against WBSEDCL in respect of interest on Security Deposit.

Part payment against part supply of materials will not be applicable.

9. **FOR:** Massanjore Hydro Power Station (M.H.P.S.), WBSEDCL, Massanjore, District-Dumka, State: Jharkhand, PIN – 814144.
10. **Packing & Forwarding:** The materials should be duly packed taking all reasonable precautions to protect the materials against damage and loss during transit. The bidder will bear total responsibility against any losses & damages during transit.
11. **Penalty:** Penalty for delay in delivery beyond schedule delivery period will be @1/2 % (half percent) of the order value for each week of delay or part thereof up to ten (10) weeks and @1% of the order value per week of delay or part thereof beyond ten (10) weeks subject to maximum limit of 10% (Ten percent) of the order value will be deducted from the agency.
12. **Guarantee:** Original manufacturer/ Supplier's Guarantee/warranty is to be provided for a minimum period of 18 months from the date of successful delivery of the materials at M.H.P.S. Site or 12 months from the date of installation whichever is earlier. In case the supplied materials are beyond our specification or found defective/damage /broken within the guaranty/ warranty period, the same should be replaced by the agency at their own risk, cost and responsibility within 15 days of intimation.
13. **Freight:** It will be arranged and borne by the agency.
14. **Vendor Code Creation:** Successful Bidder will have to generate a 6 (Six) digit Vendor Code by registering himself in the WBSEDCL Official Website (www.wbsecl.in) as a vendor of WBSEDCL. The same has to be intimated to this office by email.
15. **Validity:** The offer must remain valid for 90 days from the date of opening of the tender.
16. **Rejection:** WBSEDCL reserves the right to reject any or all offer at its own discretion without assigning any reasons whatsoever and do not bind itself to accept the lowest tender.
17. **Cancellation of NIT:** WBSEDCL reserves the right to cancel the NIT during any stage of Tendering process at its own discretion without assigning any reasons whatsoever.
18. **Risk Purchase Clause:** Risk Purchase Clause will be applicable as per norms of WBSEDCL.
19. **Site Visit:** Authorized representatives of interested agencies can visit at Massanjore Hydro Power Station (M.H.P.S.), WBSEDCL, Massanjore, District-Dumka, State: Jharkhand, PIN – 814144 for any clarification, if required. Necessary transportation, accommodation etc. for site visit has to be arranged by the agency at their own cost, risk and responsibility.
20. **Non Compliance:** In case of non-compliance of the order by the L1 bidder, necessary action will be taken as per norms of WBSEDCL. It may also lead to Holiday Listing of L1 bidder.
21. **Evaluation:** Evaluation will be done on overall basis including GST.
22. **Additional Performance Security:** All bidders who will quote in the range of -20% to -80% of the Tender Estimate shall have to submit a Performance Bank Guarantee from any scheduled bank as Additional Performance Security, apart from the Performance Security mentioned in the Payment Terms (Clause No. 4), in the prescribed format of




WBSEDCL which shall be equal to 10% of their tendered amount. This Bank Guarantee will be released after completion of Warranty Period and on receiving application from the agency.

23. **Legal Jurisdiction:** If any dispute or difference arises with respect to quality / quantity of the equipment / material pertaining to this order or any other terms and conditions of the order including its execution, such dispute / difference shall be subject to settlement under the jurisdiction of court at Kolkata. The law governing the substantive issues between the parties shall be the law of the land of India, the language of proceedings shall be in English.
24. **Force Majeure:** The successful bidder shall be under no liability if he is prevented from carrying out any of his obligations by reasons of war, invasion, act of foreign country, hostilities (whether declared or not), riots, civil commotion, mutiny, insurrection, rebellion, revolution, accident, earthquake, fires, floods, Govt. order and or restrictions (except power supply restriction) or other statutory restriction and other cause beyond reasonable control within the stipulated time. However, such force majeure circumstances are to be intimated immediately and to be established subsequently with proper document / proofs by the successful bidder to the entire satisfaction of the PPSP-WBSEDCL.
25. **Additional Liabilities:** The WBSEDCL shall not take any additional liability towards enhanced taxes, duties beyond the scheduled delivery period as incorporated in the purchase order, if the delay is due to any failure on the part of you.
26. **Cancellation/ Termination of Order:** The delivery time as mention in this NIT shall have to be treated as the essence of the contract. The WBSEDCL reserves the right to repudiate the Purchase Order placed on the successful bidder if the above period is not strictly adhered to. In the event of failure in effecting the desired work within above stipulated due date as incorporated in the completion time, the Purchase Order may be cancelled on submission of necessary notice in this regard and fresh order may be placed on the any other bidder, as a result of which the extra cost thus liable to be incurred shall be realized from the pending bills of the successful bidder which may be lying with the WBSEDCL.
27. **e-Way Bill:** Successful Bidder will generate e-way bill from the portal, if required. System generated e-way bill is to be submitted with the GST Tax Invoice. E-way bill should comprise of all required information.
28. **Product Catalogue & Technical Specification:** The participating bidders have to submit the Product Catalogue and Complete Technical Specifications of their quoted model duly signed and sealed by them along with their offer.
