- 1) West Bengal State Electricity Distribution Company Ltd. (WBSEDCL) invites sealed quotation from competent, resourceful and registered agency for **Supply and Delivery of Fire Extinguishing Materials and Refilling of Fire Extinguishing Cylinders** as per the specifications mentioned in Annexure-I for Purulia Pumped Storage Project Site. The sealed cover shall be super scribed with "NIT No" Name & Date of the Tender and "Date & Time of opening of the Tender".
- 2) Scope of Work: **Supply and Delivery of Fire Extinguishing Materials and Refilling of Fire Extinguishing Cylinders** as per the specifications mentioned in Annexure-I at Purulia Pumped Storage Project Site, Bagmundi, Purulia within the stipulated time period.
- 3) Quantity required: **As mentioned in Annexure – I.**
- 4) The Bidder shall submit offer duly signed and filled in their Letter head super scribing the NIT no. Terms and Conditions:

1. **Delivery & Re-filling Period:** Within 60 Days from placement of order.
2. **Place of delivery:** The materials will be delivered at PPSP Site Store, WBSEDCL, Bagmundi, Purulia – 723152.
3. **Price:** Price should be firm inclusive of all incidental charges. GST should be mentioned separately as applicable.
4. **Payment:** 97% Payment will be made after successful supply & delivery of fire extinguishing materials and refilling of fire extinguishing cylinders, drawal of Store Receipt Voucher from this end, submission of work completion report, original bill/ Tax Invoice in triplicate with advanced pre-receipt (Duly signed on Revenue Stamp), Guarantee/Warranty/Validity Certificate & Challan. Payment will be made by RTGS/NEFT whose charge shall be borne by the agency. 3 % shall be kept as Security Deposit. Security Deposit Shall be refunded on application of Agency after Warranty period.
5. **Transit Insurance:** In the scope of supplier.
6. **FOR:** Purulia Pumped Storage Project Site, Baghmundi, District: Purulia, PIN: 723152.
7. **Packing & Forwarding:** If Fire Extinguishing Cylinders (Co2 Fire Extinguishers and stored pressure N2, Co2 type Fire Extinguishers etc.) are required to be sent at factory for refilling, the vendor should take all reasonable precautions to protect the materials against damage and loss during transit. The bidder shall bear total responsibility against any losses & damages during transit. The transportation charges will be borne by the agency without any additional financial involvement on WBSEDCL
8. **Penalty:** Penalty for delay in delivery/refilling @1/2 % (half percent) of value of materials/refilling for each week delay or part thereof up to ten (10) weeks and @1% of the order value per week or part thereof beyond ten (10) weeks subject to maximum limit of 10% (Ten percent) will be deducted from the agency.
9. **Guarantee/ Validity:** Guarantee/Warranty/Validity certificates are to be provided for a minimum period of 02 (Two) years for CO₂ type fire extinguishers and 01 (One) year for all other type of fire extinguishers. In case the supply materials are beyond our specification or found defective/damage /broken within the guaranty/ warranty period, the same should be replaced by the agency at their own risk, cost and responsibility within 15 days of intimation.
10. **Freight:** It will be borne by the agency.
11. **Vendor Details:** PAN No., GSTIN No., Trade License, Up to date Professional Tax, Bank NEFT/RTGS details are to be provided for vendor approval along with a cancelled cheque. Credentials – if any, are to be submitted along with the offer.
12. **Validity of Offer:** The offer must remain valid for 60 days from the date of opening of the tender.

13. **Rejection:** WBSEDCL reserves the right to reject any or all offer at its own discretion without assigning any reasons whatsoever and do not bind itself to accept the lowest tender.
14. **Risk Purchase Clause:** Risk Purchase Clause will be applicable as per norms of WBSEDCL.
15. **Demonstration:** Random demonstration of workability of refilling fire extinguishers of one of each type has to be made at PPSP Site at the time of installation, free of cost.
16. **Credentials:** Bidders should have previous experience (at least one) of successfully executing similar type of job. Supporting relevant documents are to be submitted at the time of submission of quotation.
