Tender in sealed envelopes through the prescribed proforma (**Annexure –I**) are invited from bonafide, resourceful, experienced suppliers by the undersigned for supply of:-

Safety Shoe of Karam or Acme Brand on the basis of the following WBSEDCL's terms and conditions.

Tenders will be received at this office till 11.00 hrs. on **19/02/2024** and will be opened on the same date at 12:00 hrs. No quotations via e-mail shall be accepted. The quotations shall be opened in presence of tender providers or their authorised representatives on the above mentioned date & time. Envelopes containing the tender should be properly super-scribed with "**Tender for Safety Shoe**, NIT No: - PSIC/PPSP/Estb/Tender/1367 dated 05/02/24" in block letters.

Tender incorporating any extraneous condition shall not be accepted. Tender received late, unsealed, without authorized signature & date on each page; having overwriting without any attestation will not be accepted.

Tender shall have to remain valid for a minimum period of 90 days from the date of opening of the above tender. **Total quantity required is 90Pcs. (Breakup of sizes are given in Annexure-I)**, which may be changed during placement of order. The estimated cost for such purchase is Rs. 98,100/- (incl. 18% GST & delivery at PPSP Site)

W.B.S.E.D.C.L. does not bind itself to accept the lowest tender and reserve the right to accept or reject any quotation (tender) or all quotation (tenders), as well as the right to split up the order amongst the vendor, if necessary so, without assigning any reason whatsoever. Since there are multiple sizes and each bidder may quote lower price of some sizes, the overall lowest bidder (Bidder who shall quote lowest in totality considering all the items as mentioned in Annexure I) shall be declared as winning bidder.

Terms and conditions are as follows :

1. Rate: - The final rate should be firm, fixed and final inclusive of all Taxes and delivery charges to PPSP Site, however specifically item description, rate; % of G.S.T and **unit price** should be mentioned clearly in the quotation.

2. Payment: - 100% payment will be made in due course by the Drawing & Disbursing Officer, PPSP Site, Bagmundi, WBSEDCL against the bill in triplicate and signed challan in original along with a copy of the order which should be submitted to this end, after delivery of the ordered articles. Payment shall be made through RTGS/NEFT Only (RTGS/NEFT Charges to be borne by you).

3. Delivery: - Supply and delivery of the ordered articles should be made at PPSP Site, WBSEDCL, Bagmundi, Purulia within 30 days from the date of receipt of this order. However, in case of delayed delivery, a penalty @ 0.5% subject to a maximum of 10% shall be imposed @0.5%/week and the same will be deducted from your respective bill.

4. Quality of material:-The material to be supplied should be strictly well as per specifications. In case of any manufacturing / supply defect, the same shall be replaced by you free of cost.

5. Warranty: - Original manufacturing warranty/guarantee should be provided.

6. Risk Purchase Clause: On cancellation of the contract in full or in part, the WBSEDCL shall determine what amount, if any, is recoverable from the contractor for completion of the work or part of the work or in case the work or part of the work is not to be completed, the loss or damaged suffered by WBSEDCL. In determining the amount, credit shall be given to the contractor for the value of the work executed by him up to the time of cancellation, the value of contractor's materials taken over and incorporated in the work and use of plant and machinery belonging to the contractor.

Any excess expenditure incurred or to be incurred by WBSEDCL in completing the work or part of the work or the excess loss or damages suffered or may be suffered by WBSEDCL as aforesaid after allowing such credit shall without prejudice to any other right or remedy available to WBSEDCL in law be recovered from any moneys due to you on any account, and if such money is not sufficient, you shall be called upon in writing and shall be liable to pay the same within 30 days.

7. Consignee: - The P.S.I.C, PPSP Site.

8. Controlling Officer: - The P.S.I.C, P.P.S.P Site or his authorised representative.

9. Supervising officer: - The Manager (HR&A), P.P.S.P Site or his authorised representative.

10. Paying authority: - The Assistant Manager (F&A), PPSP Site, WBSEDCL, Bagmundi, Purulia.
