The bids must be submitted in Two (2) separate sealed covers, one containing and mentioning the Earnest Money Draft/Pay order and the other containing and mentioning the bid documents with super scribing the Tender Notice No, due date of opening and name and address of the bidder on both the envelopes.
09. The bid shall remain valid for **120 (One hundred Twenty) days** from the date of opening of price bid or revised price bid, if any.
10. The intending bidder may please note that prevailing Labour Acts i.e. a) Contract labour (Regulation & Abolition) Act 1970, b) EPF & MP Act 1952, c) Workmen's Compensation Act 1923, d) Building and other Construction Worker's welfare cess Act, 1996, e) Building and other Construction Worker's (Regulation of employment and condition of service) Act 1996, f) Payment of bonus Act 1965 etc. g) Payment of wages Act.1936, h) Minimum Wages Act. 1948 and the rules thereof must be complied by them, as applicable.
11. EMD shall be converted to initial SD. The intending bidder may please note that an amount equal to 8% (approx.) of contract value will be deducted from the R/A bills/ Final bill on account of "The building and other construction workers' welfare Cess Act, 1996", apart from other statutory deductions so that total SD shall not exceed 10% of contract value.
12. The tax imposed under **GST** will be charged and recovered separately as per applicable laws. STDS under GST, TDS, Cess and other deductions will be applicable as per rule.
13. The successful bidder shall have to execute Contract Agreement and Indemnity Bond in the prescribed format of WBSEDCL.
