1. West Bengal State Electricity Distribution Company Ltd. (WBSEDCL) invites sealed quotations for supply, delivery and Installation of 02 Nos. Split Air Conditioner (AC) of different cooling capacity at Massanjore Hydel Power Station, District-Dumka, Jharkhand-814144. The cover shall be superscribed with "Tender Notice No.", " Name of the Tender" and the "Date & Time of opening of the Tender".
2. **Scope of Work:** Supply, delivery and Installation of the complete set of 02 nos. Split ACs, of different cooling capacity, preferably non-inverter type Air Conditioners as per the specifications mentioned herein along with supplying of good quality accessories & consumables like remote for each AC machine, Copper pipes, PVC condensate drainage pipes, Power Cables, three-pin plugs, Angles & fittings, wall brackets, wrapping tape, pipe insulation, etc. required for installation 02 Nos. AC machines at Massanjore Hydel Power Station, District-Dumka, Jharkhand, PIN- 814144.
3. **Specification:** As per Annexure -A or better.
4. **Quantity required:** As per Annexure-A. Any other materials required to complete this work in all respects need to be supplied by the contractor without any extra cost.
5. **Estimated Cost:** Rs 74,800/- (Rupees Seventy Four Thousand & Eight Hundred only) excluding GST but including all incidental charges.
6. **Tender Fee:** Tender fee is NIL
7. **EMD:** Tenderers are not required to submit any EMD amount.

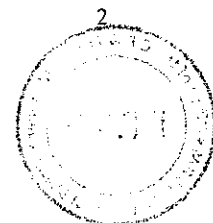

The bidder shall submit a duly filled offer **only in prescribed format as mentioned in Annexure-A** in their letterhead along with a duly signed copy of this 'Tender Notice', and 'Terms & Conditions', and other necessary documents. The bidder may submit their offer by post or by dropping their offer in the tender box at the office of the Chief Engineer & Project Manager, Purulia Pumped Storage Project, West Bengal State Electricity Distribution Company Limited, Vidyut Bhavan, 5th floor, Bidhan Nagar, Sector-II, DJ Block, Kolkata -700 091
11. Any type of conditional and incomplete offer in any respect will not be acceptable and is liable for rejection.
12. Overall Lowest valid rate should normally be accepted. However, the tender accepting Authority does not bind itself to do so and reserves the right to reject any or all the tenders without assigning any reasons whatsoever to the bidder. WBSEDCL reserves its right to curtail any parts of the scope of delivery for its financial interest.

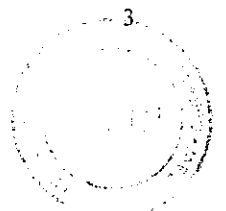
Note:

- Any offer submitted after the expiry of the time prescribed for submission shall be rejected. Late receipt of offer in case of postal delivery will not be considered. Offer by fax /e-mail will not be accepted.
- Holiday listing clause will be applicable as per the terms of the company.
- Before submission of bid, Bidder may visit MHPS Site at their own cost & arrangement to understand the scope of work clearly, or may contact the controlling officer/supervising officer.
- In case of any holiday suddenly fall on due date, the next working day will be considered as due date.

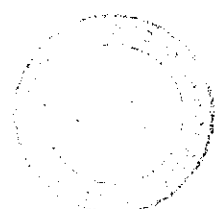


Terms and Conditions:

- 1) **Price:** FOR Massanjore Hydel Power Station basis, Price should be firm, including all charges like supply, delivery & installation charges, cess, Taxes & duties etc. GST will be paid extra as applicable.
- 2) **Delivery & work completion Period:** Within **20 (twenty) days** from the date of placement of order.
- 3) **Place of delivery & Service:** The material will be delivered & installed at Massanjore Hydel Power Station (MHPS), District- Dumka, Jharkhand, at the location shown by the controlling officer.
- 4) **Freight & Insurance:** In the scope of the supplier.
- 5) **Packaging & forwarding:** The agency will take the necessary precautions to protect the material against damage & loss during transit. The agency shall bear total responsibility against any losses & damages during transit.
- 6) **Engineer-in Charge:** The Chief Engineer & Project Manager of PPSP, WBSEDCL, Vidyut Bhavan, Kol-700091 will be the Engineer-in-Charge of the work.
- 7) **Paying Authority:** The DDO of PPSP HQ, WBSEDCL, Vidyut Bhavan, Kol-700091, will be the paying authority.
- 8) **Controlling Officer:** The In-Charge of MHPS, Massanjore, Dist.-Dumka, Jharkhand-814144 will be the Controlling Officer of the work.
- 9) **Consignee Officer:** The In-Charge of MHPS, Massanjore, Dist.-Dumka, Jharkhand, or his authorized representative will be the Consignee Officer of the work.
- 10) **Payment:** 100% payment along with tax will preferably be made within forty-five (45) days after successful supply, delivery & installation of the material at Massanjore Hydel Power Station and on submission of GST Tax Invoice & Delivery challan in triplicate and warranty certificate in a complete manner. Necessary deductions, if applicable, will be done from the bill. HSN/SAC code shall be mentioned in GST tax invoice by the supplier. WBSEDCL will not pay any interest, charges if any. No part payment & part supply is allowed.
- 11) **Accessories & Consumables:** All the required accessories, like remotes with batteries, Copper pipe, PVC condensate drainage pipe, Power cable, three-pin plugs, angles & fittings, wall bracket etc. and consumables like wrapping tape, insulation for copper pipe etc. required for the installation of 02 nos. ACs, shall be supplied by the agency without any extra cost to WBSEDCL.
- 12) **Additional Performance security:** Additional Performance Security @10% of the tendered amount in the NIT shall have to be submitted separately by the successful bidder in the form of Bank Guarantee when the bid rate is (-)20% to (-)80% from the estimate put to tender. Additional Performance Bank Guarantee is to be submitted separately in the format that will be supplied later. Additional Performance Security without any interest will be released after the expiry of the defect liability period.
- 13) **HSN /SAC Code:** During submission of offer, HSN/SAC code of the offered material is to be mentioned.
- 14) **PAN & GST Registration no.:** Copy of valid PAN & GST Registration Certificates are to be provided along with the quotation.
- 15) **e-waybill:** The successful bidder will generate e-waybill from the portal, if required.



- 16) **Offer Validity:** The offer must remain valid for 90 (Ninety) days from the date of opening of the offer.
- 17) **Warranty Period:** OEM warranty is to be provided. However, supplier shall have to provide comprehensive warranty of the AC machine at least for a period of 12 (Twelve) months from the date of successful installation of the job. Warranty certificates shall have to submit by the supplier at the time of delivery of materials. Materials/Service as offered, should be replaced/repared free of cost within 72 hrs if any defects are found within the aforesaid warranty period. If failed, WBSEDCL reserves the right to recover the actual repairing cost from the contractor.
- 18) **Liquidated Damages:** Liquidated damages for delay in delivery beyond the schedule delivery period/contract period will be @ 0.5 % of the order value for each week of delay or part thereof up to 10 (ten) weeks and @ 1% of the order value per week beyond 10 (ten) weeks subject to maximum of 10% of the contract price will be deducted from the bill of supplier.
- 19) **Safety Measures:** All the Safety rules and codes as applicable to the work shall be followed strictly by the contractor without any exception from WBSEDCL.
- 20) **Legal Jurisdiction:** If any dispute or difference arises with respect to quality / quantity of the equipment / material pertaining to this contract or any other terms and conditions of the contract, including its execution, such dispute / difference shall be subject to settlement under the jurisdiction of Calcutta High Court.
- 21) **Rejection of Bid & Bidding Process:**
The Tender Inviting Authority reserves the right to accept or reject any Bid and to cancel the Bidding process and reject all Bids at any time prior to the award of Contract without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the ground for WBSEDCL's action.
- 22) **Vendor Code Creation:** The successful bidder who will get the contract first time from WBSEDCL, shall have to create vendor Code from WBSEDCL web portal.
- 23) **Product Catalogue & Technical Specifications:** The bidders shall have to submit product catalogue & technical specifications booklet with bid.
- 24) **Additional Liabilities:** WBSEDCL will not take any additional liability towards enhanced taxes, duties etc. for delay beyond the scheduled delivery/work completion period as incorporated in the contract, due to any failure on the part of the supplier.
- 25) **Risk Purchase clause:** On cancellation of the contract in full or in part, the WBSEDCL shall determine what amount, if any, is recoverable from the contractor for completion of the work or part of the work or in case the work or part of the work is not to be completed, the loss or damage suffered by WBSEDCL. In determining the amount, credit shall be given to the contractor for the value of the work executed by him up to the time of cancellation, the value of the contractor's materials taken over and incorporated in the work and the use of plant and machinery belonging to the contractor. Any excess expenditure incurred or to be incurred by WBSEDCL in completing the work or part of the work or the excess loss or damages suffered or may be suffered by WBSEDCL as aforesaid after allowing such credit shall without prejudice to any other right or remedy available to WBSEDCL in law be recovered from any moneys due to the contractor on any account, and if such moneys are not sufficient, the contractor shall be called upon in writing and shall be liable to pay the same within 30 days.
- 26) **Purchase Order/Work order:** WBSEDCL will communicate acceptance of tender to the successful bidder by a Purchase /work Order. The successful tenderer shall communicate the



acceptance of the purchase/work order within a specific period to be mentioned on the order.

- 27) **Cancellation / Termination of Order:** The time period for effecting complete supply/ work of the above materials/equipment as indicated through the delivery / work schedule under term (2) shall have to be treated as the essence of the contract. The Company reserves the right to repudiate the contract if the above period is not strictly adhered to. In the event of failure in effecting the desired supply and delivery of the above equipment/materials within above stipulated due date as incorporated through the term (2), the order may be cancelled on submission of necessary notice in this regard and fresh order may be placed on the next higher bidder or on any other bidder, as a result of which the extra cost thus liable to be incurred shall be realized from the original supplier's / service provider pending bills which may be lying with the WBSEDCL.


28) **Force Majeure:**

The contractor shall be under no liability if he is prevented from carrying out any of his obligations because of war, invasion, act of foreign country, act of the public enemy, acts of Governments, hostilities (whether war declared or not), riots, civil commotion, mutiny, insurrection, rebellion, revolution, accident, earthquake, fires, floods Govt. order and/or restrictions (except power supply restriction) delay or inability to obtain materials due to import or other statutory restriction and other cause beyond the reasonable control of the contractor. However, such force majeure circumstances are to be intimated immediately and to be established subsequently with proper documents/proofs to the entire satisfaction of the Company / WBSEDCL.

The Company / WBSEDCL shall not be responsible or liable to pay any compensation for any interruption in work at the site due to strike, lockout, riot, earthquake, flood, cyclone or civil commotion or any other force of accident due to any reason beyond control of Company / WBSEDCL. The Company / WBSEDCL shall not be held responsible to or liable to pay for any interruption in contractor work at the site arising out of resistance from the local public due to any resistance towards work.
