The Addl. Chief Engineer & Project Manager, Jaldhaka Hydel Project, WBSEDCL invites e-tender (Submission of Bid online) on percentage rate basis for the works detailed below from bonafide, resourceful and experienced contractors of State / Central Govt., State / Central Govt. PSU, Statutory Bodies constituted under the statute of Central / State Govt. as per following terms & conditions:

A) Name of the work: "Round-the-Clock maintenance for routine, breakdown and preventive Maintenance of (4 X 9.0+2X4) MW TG Sets with all auxiliaries, 66 kV Switchyard and Bindu Barrage under Jaldhaka Hydel Project, WBSEDCL. Dist- Kalimpong (WB) PIN-734503"

B) PERIOD OF CONTRACT:- 02 (two) years with provision of extending another year.

C) ESTIMATED AMOUNT: RS.4, 45, 33,462/- (Rupees Four Crore forty five Lakh thirty three Thousand four hundred sixty two) only for 2(two) years. GST will be paid extra as per statute.

D) ANNUAL ESTIMATED VALUE:

a. **1st year:** Rs 2, 15, 86,456/- (Rupees two Crore fifteen Lakh eighty six Thousand four Hundred fifty six) Only

b. **2nd year:** Rs 2,29,47,006/- (Rupees two Crore twenty nine Lakh forty seven Thousand six Only).

E) EARNEST MONEY DEPOSIT: Rs. 5, 73,675/- (Rupees five Lakh seventy three Thousand six Hundred seventy five) only shall have to be deposited online/offline mode as per detailed NIT. Tender without Earnest Money Deposit shall be rejected altogether.

G) TECHNICAL ELIGIBILITY CRITERIA: Intending bidder must possess following:

- valid Electrical Contractor's License with Supervisory Competency Certificate suitable for 66 KV level;
- Annual turnover not less than 1 (one) Crore in any particular year during last three years. Audited financial statement for last three financial years shall have to be furnished.
- Current Professional Tax payment certificate,
- PAN CARD
- GST Registration Certificate,,
- GST return for last two financial years.
- Income Tax Return for last three financial years.
- Trade License in respect of the prospective Bidder. Proprietorship Firm: (Trade License). Partnership Firm: (Partnership Deed, Trade License). Limited Company : (Incorporation certificate, Trade License). Co-operative Society: (Society Registration certificate, Trade License)

H) FINANCIAL ELIGIBILITY CRITERIA: The intending bidders must have satisfactorily completed within last 7 years i.e. from 01-04-2016:

At least 3 (Three) completed works of similar nature, each costing not less than the amount equal to 40% of the 1st year's estimated value.

OR

At least 2(Two) completed works of similar nature, each costing not less than the amount equal to 50% of the 1st year's estimated value.

OR

At least 1(one) completed work of similar nature, costing not less than the amount equal to 80% of the 1st year's estimated value.

Similar works means works related to "AMC of Electro-mechanical maintenance or construction of Hydel Power Station having capacity 5 MW or above. The separate orders for Mechanical and Electrical works within the same financial year having minimum lapping of one month will be considered as single order for electromechanical work combining the annual value of both the contracts.

OTHER TERMS OF TENDER:

1. Intending bidder should download the tender documents from the website <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate. All documents are to be submitted concurrently duly digitally signed by the Bidder through the website <https://wbtenders.gov.in>.
2. The financial offer of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
3. All statutory labour laws have to be complied as per Govt. norms during the period of execution.
4. No mobilization advance or secured advance will be allowed.
5. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a

single job, all his offers will be rejected for that job.

6. Bid shall remain valid for a period not less than 180 (one hundred eighty) days from the date of technical bid opening. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD). However, WBSEDCL may, on the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
7. The instant e-NIT will be processed in line with prevailing Revised Purchase Policy of WBSEDCL as available in <http://www.wbsedcl.in> website.
8. The Bidder at the Bidder's own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. The cost of visiting the site shall be at the Bidder's own expense.
9. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
10. Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.
11. Exemption from deposition of Earnest Money (EMD) shall not be allowed under any circumstances.
12. Conditional / Incomplete tender will not be accepted under any circumstances.
13. The intending Bidders are required to quote the rate online at wbtenders.gov.in.
14. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice and legal action will be taken against him.
15. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.

16. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) without assigning any reason whatsoever.
17. Revised Purchase Policy will be followed wherever applicable in respect of the contract work. Revised Purchase Policy is available on company's website.
18. The WBSEDCL reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
