- 2. The bidder shall submit **along with the offer** necessary documents in support of their previous supply. Of the items of the tender to WBSEDCL in earlier. Occasions and financial capabilities to the extent of the estimated financial amount of their offer.
- 3. No agent is allowed to participate in the Tender.
- 4. WBSEDCL reserves its right to take decision keeping its financial interest. The Purchase Policy of WBSEDCL along with the provisions of Vendor Rating & Holiday Listing, as effective from 01.09.2012 and the subsequent amendment effective from 18.03.2013 will be applicable.

- 95% payment of bill will be made as per availability of fund in respect of submission of bill against: Original receipted Challan/Invoice signed by Store In-Charge attached to the respective stores, if applicable and
- b) Balance 5% payment will be made after expiry of warranty period, if applicable.
- 17. GUARANTEE/WARRANTY PERIOD: Guarantee/Warranty Period of supplied material will be one year from the date of delivery of the said materials. In case of any adverse report from store or defect found in site, materials have to be replaced or it would affect the vendor rating.
- 18. PAYING AUTHORITY: The Assistant Manager (F&A)/DDO, Khatra Division, WBSEDCL, will be the Paying Authority.
