NOTICE INVITING E-TENDER

Tender Notice No.: PM/RMM/e-Tender/ELECT/22-23/07, Date: 22.07.2022

Online tenders are invited in two parts (Techno-commercial Part & Price Part) by the Addl. Chief Engineer & Project Manager, Rammam H.P., St-II, WBSEDCL, Adm. Building, Dovan, P.O.: Lodhamahat, Dist. Darjeeling (WB) from bonafide, eligible, resourceful and experienced contractors of WBSEDCL/WBSETCL or any other Government Organizations, for Maintenance Contract for "Round the clock maintenance of HT/LT lines, Communication System and other electrical installations in buildings, quarters & establishments outside power house under the project area of Rammam Hydel Project Stage-II".

1. Estimated Cost:

Rs. 13,95,974.65/- or **Rs. 13,95,975/-(rounded up)** from Oct 2022 to Mar 2023 (six months), excluding GST.

(Rupees thirteen lakhs ninety-five thousand nine hundred and seventy five only) excluding GST.

- 2. Period of the Contract: 6 (Six months).
- Downloading of the Tender Document: Intending bidders should download the tender documents from the website http://www.wbtenders.gov.in directly with the help of Digital Signature Certificate, without any cost.
- 4. Earnest Money: Rs. 34,899/- (Rupees thirty-four thousand and eight hundred and ninety-nine only) is to deposited by the intending bidder electronically:
 - a. online through net-banking enabled bank account maintained at any bank, or,
 - b. offline through any bank by generating NEFT/RTGS challan from the e-tendering portal.

Intending bidder will get the Beneficiary Details from the e-tendering portal with the help of Digital Signature Certificate and may transfer the EMD from their respective Bank as per the Beneficiary Name & Account, Beneficiary Bank Name (ICICI Bank) and IFSC Code and e-procurement Reference Number. Intending bidder who wants to transfer EMD through NEFT/RTGS must read the instruction of the Challan generated from e-Procurement site. Bidders are also advised to submit EMD of their bid, at least 3 working days before the bid submission closing date as it requires time for processing of payment of EMD.

5. Eligibility Criteria:

- The tenderer should possess at least two years' experience in similar nature of work of value not less than Rupees 11 (Eleven) lakh in any financial year during last Three years.
- ii) Annual turnover should be at least Rupees 10 (ten) lakh in any financial year during the last three years.
- iii) The tenderer should submit MSME certificate if they fall under the said category.
- iv) The tenderer must possess & submit the following documents along with the bid:
- a) Proof of experience as in 5. i) above.
- b) Valid Electrical Contractor's License along with valid Supervisory Competency Certificate for voltage level not less than 11 kV including that for 11 KV UG cable.
- c) Employees' Provident Fund (Registration).
- d) GSTN.
- e) Trade License
- f) Up to date P. Tax challan.
- g) PAN No. & IT Return for last three years.
- h) Balance sheets for last three financial years.
- i) MSME Certificate, if applicable.
- 6. Sale of tender paper: The tender documents will be available at http://wbtenders.gov.in/nicget, from 10:00 AM on 01.08.2022 till the closing time of the tender at 04:30 PM on 18.08.2022. There shall be no cost of tender document and the procedure for downloading of the same is mentioned in SI No. 03 above.
- 7. Submission of the Tender: Filled in tender shall have to be uploaded at http://wbtenders.gov.in/nicget up to 04:30 PM on 18.08.2022. Tender shall include:
 - j) Techno Commercial Part Necessary documents as stated in Sl. No. 5 (iv) above.
 - ii) Price Part Filled in BOQ (Bill of Quantities) to be uploaded in a separate folder titled "BOQ".
- 8. Opening of Techno-commercial Bid (Part-I): Techno commercial part shall be opened on 11:00 AM on 23.08.2022. Bids, of tenderers not depositing EMD before Closing Time of the tender, shall not be opened.
- 9. Verification of Documents: Documents submitted in support of eligibility criteria shall be verified with the originals on 10:30 AM on 25.08.2022 at the Office of the ACE & PM, RHP St-II at Adm. Building, Dovan, P.O.: Lodhamahat, Dist. Darjeeling (WB). The bidders or their authorized representatives shall have to remain present with the original documents at the time & venue mentioned herein.
- 10.Opening of the Price Bid (Part-II): Price Part (Uploaded separately as BOQ) in case of bidders qualifying at Techno-commercial Part shall be opened online on date and time to be intimated to the bidders later.

- 11.Validity of Bid: 90 (ninety) days from the date of opening of Price Bid (Part-II).
