Item rate sealed tenders (2nd Call) are invited by The Chief Engineer & Project Manager, Purulia Pumped Storage Project, WBSEDCL, Vidyut Bhavan, 5th Floor (A Block), Salt Lake, Bidhannagar, Kolkata 700091 from bonafide eligible, resourceful and experienced contractors having requisite credentials of works in WBSEDCL / other Power Utilities / other Govt. Departments in the past for the following works at Massanjore Hydel Power Station at Massanjore, Dist. Dumka, Jharkhand, P.C.- 814144, INDIA. (Submission of Bid through online only)

- Intending bidder should download the tender documents from the website <https://wbttenders.gov.in> directly with the help of his Digital signature Certificate. Necessary Earnest Money Deposit (EMD) should be paid in full through online mode only as mention at Instructions to Bidders. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Eligibility Criteria' before tendering the bids.
- Both Technical Bid and Financial Bid are to be submitted concurrently duly digitally signed by the Bidder through the website <https://wbttenders.gov.in>. (Details of which has been narrated in 'Instruction to Bidders').
- Eligibility criteria for participation in tender:**

A) The bidders shall have credential for successfully executed work of "Construction or Operation and Maintenance of minimum 1 MW Hydel Power Plant and their auxiliaries, hydro-mechanical and electro-mechanical equipment including switchyard" or "operation and/or maintenance 33/11 KV Sub-station" or



"erection/ installation, testing & commissioning of 33/11 KV Sub-station" in WBSEDCL / other Power Utilities / other Govt. Departments in earlier occasions within last seven years (to be reckoned from the Bid Submission Start Date) having completed work value as followed :-

i) Three similar completed works costing not less than the amount equal to 30% of the estimated cost each.

Or

ii) Two similar completed works costing not less than the amount equal to 40% of the estimated cost each.

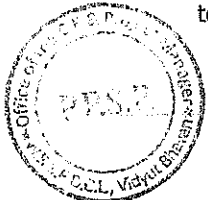
Or

iii) One similar completed work costing not less than the amount equal to 60% of the estimated cost.

The value of work excluding tax will be considered for evaluation.

Value of Extension order, if any, having continuity of work of the same job will be considered for fulfillment of above criteria.

- B) The bidders shall have valid Electrical Contractor's License issued by Appropriate Govt. Authority, authorizing him to execute electrical work upto category of 33 KV systems. The bidders shall also have valid Provident Fund Registration.
- C) The bidders shall have achieved minimum average annual turnover amounting to 25% (Twenty Five Percent) of estimated value during last three financial years (i.e. FY 2024-25, FY 2023-24 & FY 2022-23).
- D) The bidders shall have working capital in the year, proceeding the year of bid submission shall not be less than amounting to 25% (Twenty Five percent) of Estimated value.
- E) In case documents certifying credit facility from a scheduled Bank is submitted, the requirement given in 3(D) above shall be judged by adding available credit facility and working capital taken together. Banker's certificate regarding financial capability of bidder, should not be more than three (03) months old as on the last date for submission of bids. The Bidders' shall have to submit certificate as per prescribed format given in "Form - V" of the tender document, duly certified by transacting banks.
- F) Annual Audited Financial report for last 3 (three) financial years (i.e. FY 2024-25, FY 2023-24 & FY 2022-23) to be submitted for verification in respect of bidders for whom audit of accounts is mandatory. For those whose audit of accounts is not mandatory, they shall submit copy of IT returns along with related enclosures (Form 3CA and Form 3CB) for last five years.
- G) All categories of prospective Bidders shall have to submit valid copies of current Professional Tax payment certificate, E.P.F. Registration certificate, Final GST Registration certificate, E.S.I. registration certificate, PAN Card and Income Tax Return for last three financial years, Trade License in respect of the prospective Bidder, viz Proprietorship Firm - Trade License / Partnership Firm - Partnership Deed, Trade License/ Company - Incorporation certificate, Trade License / Co-operative Society - Society Registration copy, Trade License.
- H) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. Any bidder against whom FIR/Complaint is lodged with Police by WBSEDCL shall not be eligible to participate in the bidding process. (A declaration to this effect shall have to be furnished by the prospective bidders).



- I) The prospective bidders must not have been banned, de-listed, blacklisted, or debarred from participating in any business dealings by any WBSEDCL/ WBSETCL/ Statutory/ Regulatory/ Government Authorities / State Electricity Utility/ Public Sector Undertaking (PSU) or any other authorized institution in India. A declaration to this effect shall have to be furnished by the prospective bidders.
- J) A prospective bidder shall not have a conflict of interest. Any bidder found to be in a situation of conflict of interest shall be disqualified from the bidding process.

A bidder shall be considered to have a conflict of interest if any of the following conditions are met:

- i) They have a controlling partner in common with another bidder; or
 - ii) They receive or have received any direct or indirect subsidy from any other bidder; or
 - iii) They have the same legal representative for the purposes of this bid as another bidder; or
 - iv) They have a relationship with each other, directly or through common third parties, which allows them to have access to or influence the bid of another bidder, or influence the decisions of the Employer regarding this bidding process; or
 - v) A bidder submits more than one bid in the bidding process, either individually or in any form of joint venture/association/consortium. All such bids shall be disqualified; or
 - vi) The bidder or any of its affiliates has participated as a consultant in the preparation of the design or technical specifications of the materials, services, or works that are the subject of the bid; or
 - vii) The bidder, directly or indirectly, is a dependent agency of WBSEDCL.
4. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website, mention above.
 5. Bid shall remain valid for a period not less than 180 (one hundred eighty) days from the date of opening of Price Bid. However, WBSEDCL may, on the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of Earnest Money Deposit (EMD).

7. The Bidder at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. The cost of visiting the site shall be at the



Bidder's own expense. Before submission of the bid, Bidders are requested to make themselves fully conversant with the site conditions, labour related issues / conditions, specifications, schedules, drawings and other information so that no ambiguity may arise in these respects subsequent to the submission of the tender. Representative of the Bidders should visit the sites to assess the site conditions prior to submission of bid. The contractor will also be considered as having acknowledged that any failure to acquaint itself with all such data and information shall not relieve its responsibility for properly estimating the difficulty or cost of successfully performing the work.

8. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any Bid and to cancel the Bidding processes and reject all Bids at any time prior to the Award of Contract without assigning any reason whatsoever and without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders. WBSEDCL is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
9. Exemption from deposition of earnest money deposit (EMD) shall not be allowed under any circumstances.
10. Conditional / Incomplete tender will not be accepted under any circumstances.
11. Mobilization advance and secured advance will not be allowed.
12. The intending Bidders are required to quote the rate online only.
13. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a single job, all his offers will be rejected for that job.
14. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
15. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
16. Mere downloading of the bid document by a prospective bidder shall not be construed as an automatic qualification of the bidder with respect to the prescribed eligibility criteria. The compliance of a bidder with the specified eligibility requirements shall be examined and verified only after the opening of the bids, based on the documentary evidence submitted along with their bid. If any document submitted by a Bidder is either incorrect / manufactured / fabricated or false at any stage, his Tender will be outrightly rejected and legal action will be taken against him.
17. Price preference will not be allowed to any contractor based on the size of the company or its geographic location. Co-operative Society / MSME will not be considered with separate status.
18. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever. WBSEDCL reserves its right to take decision keeping its financial interest.
19. The WBSEDCL reserves the right to cancel the NIT due to unavoidable circumstances and no claim in this respect will be entertained. In such case EMD will be refunded without any interest.
20. The Employer reserves the right to:
 - i) Amend the scope of work to be tendered;
 - ii) Accept or reject any bid, including for reasons related to national defense and security considerations; and



iii) Cancel the bidding process and reject all bids, without assigning any reason thereof.

The Employer shall not be held liable for any consequences arising from such actions. However, bidders who wish to seek reasons for such cancellation or rejection shall be informed by the Employer, unless the disclosure of such information is reasonably expected to affect the sovereignty and integrity of India or endanger the security, strategic, scientific, or economic interests of the State or harm relations with foreign states or lead to incitement of an offence.

21. Once the tenders have been submitted, the tenderers will not have the option to withdraw offer within the validity period. If any tenderer withdraws his tender before expiry of validity period or makes any modification in the terms and condition of tender which are not acceptable to the company then the company shall without prejudice to any other right or remedy, be at liberty to forfeit the earnest money and also suitable actions could be contemplated against each erring bidder by the Company (WBSEDCL).
22. Other information as well as terms and conditions, which are not covered above, will be available in Instructions to Bidders, General Conditions of Contract and scope of work of this tender.
