Darjeeling (WB) from bonafide, eligible, resourceful and experienced contractors of WBSEDCL/WBSETCL any State or Central Govt. concern for Providing Furniture to of Rammam Hydel Project, St-II.

- 1. Name of work: SUPPLY, DELIVERY AND INSTALLATION OF FURNITURE FOR USE OF DIFFERENT SECTIONS AND INSPECTION BUNGALOW OF RAMMAM HYDEL PROJECT, ST-II.

The amount of Earnest Money Deposit (EMD) as mentioned above shall be deposited by the bidder electronically: online-through his net banking enabled bank account maintained at any bank or offline: through any bank generation NEFT/RTGS challan from the e-tendering portal. Intending Bidder will get the Beneficiary details from e-tender portal. In case of actual EMD amount as per NIT is more than the one shown in e-tender portal, bidders will have to opt for NEFT/RTGS mode (challan mode). In that case the total actual EMD amount is to be paid only through NEFT/RTGS mode (challan mode).

- i. The tenderer should possess at least two years' experience in similar nature of work i.e. Furniture supply in any State/Central Govt. concern.
- ii. The tenderer must possess & submit the following documents along with the bid:

 - b) Employees' Provident Fund and GSTN.
 - c) Trade License.
 - d) Up to date P. Tax challan.
 - e) PAN No. & IT Return for last three years.
 - f) Balance Sheets for last three financial years.
 - g) GST Return for last 06 (six) months.

- iv. Verification of Documents: Documents submitted in support of eligibility criteria shall be verified with the originals on 01.07.2025 at 11 AM at the O/o the PM, RHP, St-II at Adm. Building, Dovan, P.O: Lodhomahat, Dist.-Darjeeling (WB). The bidders or their authorized representatives shall have to remain present with the original documents at the time & Venue mentioned herein.
- v. Opening of the Price Bid (Part-II): Price Part (Uploaded separately as BOQ) in respect of bidders qualifying at Techno-commercial Part shall be opened online and will be intimated later.
- vi. Validity of Bid: 180 (One hundred eighty) days from the date of opening of Part-I.

10. General guidance for e-Tendering:

- a. The bidder will have to be enrolled & registered with the Government e-Procurement system of West Bengal through logging onto https://www.wbtenders.gov.in (web portal) and the bidder is to click on the link for e-Tendering site as given on the web portal.
- b. Each bidder is required to obtain a class-II or class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National informatics Centre (NIC) on payment of requisite amount. Details are available at http://www.wbtenders.gov.in. DSC is given as a USB e-Token.
- c. The bidder can search & download N.I.T. & Tender Documents (s) electronically from computer once he logs on to http://wbtenders.gov.in using the DSC. This is the only mode of collection of the Tender Documents.
- d. Tenders are to be submitted online to http://wbtenders.gov.in in two folders at a time, one in Technical Proposal and the other is Financial Proposal before the prescribed date & time in the form of virus scanned copy duly Digitally signed. The uploaded Documents will get encrypted (transformed into non-readable formats).
 - **A. Technical Proposal:** This shall consist of scanned copies of the N.I.T, technical documents mentioned in SI. No.4 (ii) above and scanned copies of Earnest money deposit and cost of tender document both in the form of Demand draft or Banker's cheque.
