3. Eligibility criteria for participation in tender:

The pre-qualification will be subject to bidder's fulfillment of the qualification criteria set forth and stipulated hereunder & substantiated by authentic and relevant information and details. The bidders shall also have experience and proven track record in taking up and completion of the work of magnitude and nature similar to the items as mentioned hereunder.

3.1 TECHNICAL CRITERIA:

- a) A bidder shall be considered technically eligible, with experience of having successfully completed similar works during last 7 years (after 30th lune 2015) subject to fulfillment of the following criteria:

- b) Similar nature of works for work under sl. no. 3.1(a) shall mean similar type of work like renovation of bituminous road, repair of protection bituminous road, repair & maintenance of quarters/buildings/roads, Construction/Restoration of wall/sausage wall Papeir & Maintenance of protection wall/sausage wall. Repair & Maintenance/ Construction/ Renovation of any type of drain/ culvert etc. Execution of any type of road work that are in any type of road work, that contributes towards major financial involvement of the bid.

Registration Certificate, GST registration certificate, PAN Card and Income Tax Return Acknowledgement for Assessment Year, 2021-22, 2020-21, 2019-20. Trade License in respect of the prospective bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Ltd Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License, MSME registration certificate of the bidders, if available, ESI registration Certificate.
- e) Neither prospective Bidder nor any of the constituent partners had been debarred to participate in any Tender by any Government Department/Semi-Govt./ Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
- f) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
- 4. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the bidder is found qualified by WBSEDCL. The decision of WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
- 5. No mobilization advance and secured advance will be allowed.
- 6. A prospective bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If he is found, to have applied severally, in a single job, all his offers will be rejected for that job.
- 7. Bid shall remain valid for a period of 120 (one hundred twenty) days from the date of opening of Price Bid or revised Price Bid, if any. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).
