## **INVITATION TO BID**

### **1.0 SCOPE OF WORK :**

Laying of 33 KV HT UG XLPE 3Cx400 Sqmm by micro tunneling of R/L-110 Meter and extension of 33 KV Bay for LILO arrangement at ongoing Kuthighat-Narajole 33 KV Feeder and Switch yard of Kuthighat 33/11 KV substation respectively under Ghatal Division.

### **3.0 SUBMISSION OF TENDER:**

The tender will be submitted in two bid systems i.e. Techno-Commercial bid & Financial bid, online only through the Website [www.wbtenders.gov.in](http://www.wbtenders.gov.in)

### **4.0 ELIGIBILITY CRITERIA OF THE BIDDER:**

#### **4.1 Technical :**

The bidder must have successfully completed construction of similar nature of work having contract value in a single contract during last five years, not below Rs 50 % of total quoted value. All the required License and enlistment must be produced for such kind of Works.

#### **4.2 Commercial & Financial :**

4.2.1 The average annual turnover of the bidder for best two years out of the financial years 2022-23 , 2023-24 , 2024-25 shall be minimum 10( Ten) lakhs for sl.no.1, **(Annexure-I)**.

4.2.2 The working capital and credit facility taken together either for 2021-22 , 2022-23,2023-24,2024-25 shall be minimum 20 Lakhs **(Financial Capability proof certificate from bankers, one year from date of Publication of NIT).**

**(Financial Capability proof certificate from bankers, prior one year from date of Publication of NIT).**

#### **4.3 The Bidder must include following documents to substantiate the qualifying requirement such as:**

- 4.3.1. Monetary value of similar work performed by the bidder in last five years (copy of order and completion certificate to be enclosed).**(Annexure-II)**
- 4.3.2. Major items of construction equipment proposed to carry out the contract.**(Annexure-III)**
- 4.3.3. Qualification, experience and License of key site management and technical personnel proposed for the contract.**(Annexure-IV)**
- 4.3.4. Reports on financial standing of the bidder, such as profit and loss accounts & balance sheets and Auditor's report etc. for the last financial year i.e.2023-24 and I.T return for financial year,2021-22,2022-23,2023-24, 2024-25 should be uploaded.
- 4.3.5. Information regarding any litigation, current or during last five years in which the bidder is involved, the parties concerned and the disputed amount.
- 4.3.6. Photocopy of following documents:

- i) ESI with valid certificate.
- ii) PAN Card.
- iii) GSTIN Registration No. with valid certificate.
- iv) P.F Registration No. along with challan.
- v) SAC CODE & HCM CODE where applicable

4.4 Photocopies of all documents should be self-authenticated.

4.5 Notwithstanding anything stated above, the owner (WBSEDCL) reserves the right to assess the capacity and capability of the bidder to execute the work, should the circumstances warrant such assessment in the overall interest of the owner.

4.6 Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have,

4.6.1. Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualifying requirements and/or

4.6.2. Record of poor performance such as abandoning the work, not properly completing the contract, inordinate delays in completions, litigation history or financial failure.

4.7 One Self declaration will have to be uploaded online mentioning the correctness of the documents uploaded along with this tender.

#### **6.0 DETAILS OF WORK: If work involves cable laying-**

- a) The scope of work involves laying, Erection, Installation, testing and commissioning of 33KV 3X400 sq.mm XLPE UG cable and 11 kV, 3X300 sq mm XLPE cable.
- b) Micro tunneling with 200 mm/160 mm HDPE, PE-80, PN-6 pipe for laying of UG cable.
- c) Excavation of soil for formation of cable trench and re-instatement of the same for restoration.
- d) Making of straight through joint of 33KV 3X400 Sq.mm XLPE UG cable.
- e) Making of end termination I/D & O/D type joint of 11KV 3X400 Sq.mm XLPE cable.
- f) Supply and Fixing of G.I Pipe (Medium) as per I.S 200 mm dia for cable riser arrangement (pipe shall be TATA/JINDAL/EQUIVALENT).

6.1. The contractor will have to supply the specified materials as per specifications and to be procured by the contractor himself. The specifications for the major equipment to be procured are as follows:

- a) Cable jointing termination and straight through kits as per specifications enclosed from reputed manufacturers.
- b) All the other materials like LA base plate 430 mmx43 mmx8 mm, G.I. pipe (medium) 150 mm dia. (Tata/Jindal/equivalent), kiln burnt 1<sup>st</sup> class brick, coarse and fine aggregate sand, cast iron markers, sealing, route markers, cable support clamps, terminals and inline connectors, sealing compounds etc., whether specifically mentioned or not in these specifications are deemed to have been included in the scope of supply and installation. Similarly, the contractor has to arrange for all the tools and plants required for the works at his own cost.

#### **7.0 If work involves extension of Bay 33/11 kV Sub-Station-**

- a) Supply and installation of CT, PT and cable support structures as per instruction of concerned site engineers.
- b) Installation of 33 kV OD CT and PT as per specification.
- c) Installation of 33 kV VCB shunt trip switchgear with connection as applicable as per instruction of site engineer.
- d) Laying and dressing of 1.1 kV, 4C,8C, 12C Cu-Control cable with lugging and ferruling as per instruction of site engineer as applicable
- e) Supply and Fixing of G.I Pipe (Medium) as per I.S 200 mm dia for cable riser arrangement (pipe shall be TATA/JINDAL/EQUIVALENT if applicable)

## **8.0 Pre-Bid Meeting :**

- 8.1** Pre bid meeting will be held on **01.08.2025 at 16.00** hours at the Conference Room of Administrative Building, WBSEDCL, Ghatal Division, Nischindipur, Ghatal, Ward No. 11 Dist: Paschim Medinipur.
- 8.2** Any change in date shall be available in website of [www.wbtenders.gov.in](http://www.wbtenders.gov.in).
- 8.3** Non attendance at the Pre-bid meeting will not be a cause for disqualification of bidders.
- 8.4** If there be any discrepancy or obscurity in the meaning of any clauses of the bid document or if there be any query of the intending bidder, the bidder may submit their queries to the tendering authority on or before 10.07.2024. The clarification given in the pre-bid discussion shall be final and binding on the bidder, being a part of the original Bid Documents.

### **Note:**

1. WBSEDCL reserves the right to reject or accept any Bid or part thereof or all Bids received at its sole discretion without assigning any reason(s) whatsoever.
2. WBSEDCL reserves the right to go to divisible contract, if necessary.
3. WBSEDCL is not necessarily bound to accept the lowest offer.
4. No interest shall be payable for Bid Guarantee/EMD.
5. Any extraneous conditions will be treated as non-responsive.
6. The Bids must be submitted in prescribed proforma only, where indicated i.e. Annexures, BOQ and Rate.



9. Bidders shall ensure that all pre-requisites are duly fulfilled by them and if there be any dispute regarding non-submission of any document, WBSEDCL reserves the right to cancel the Bid unilaterally without assigning any reasons.
10. The bidder is expected to examine carefully all instructions, conditions, forms, schedules, terms, annexure, specifications and drawings of the bidding document. Bids, which are determined to be not substantially responsive to the requirement of the bidding document, may lead to rejection.

**12. Return of Earnest Money of the unsuccessful tenderer(s):**

The Earnest Money will be returned by this office immediately after opening of Financial Bid except lowest bidder.

**All bids in the range of -20% to -80% of the estimated cost shall furnish an Additional Performance Security in the form of Bank Guarantee (Annexure-VII) from any scheduled Bank, which shall be equal to 10% of the Tendered amount.**

11. **Earnest Money (EMD) :** Earnest Money Deposit shall be submitted through online mode through the e-Tendering portal (<https://wbtenders.gov.in>). All offline instruments like Bank Draft, Pay Order etc. will be stopped for e-tender procurement. In case of unsuccessful/ rejected bids, the EMD shall be refunded directly from the e-Tendering portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms.

A) The bidder shall deposit the requisite earnest money through **online mode only** (*Bank Name-ICICI Bank Ltd., A/C No.-193405000657, Account Title- West Bengal State Electricity Distribution Company Ltd., Account Type –Current, IFSC Code-ICIC0001934, MICR Code-700229096, ICICI BANK LTD., BLOCK-A, ECOSPACE BUSINESS PARK, RAJARHAT, KOLKATA-700156.*) Following payment options are available for online payment of EMD, for the intending bidders,

- i. Net-banking through Payment Gateway.
- ii. **RTGS/NEFT Payment:** On selection of RTGS/NEFT as the payment mode, the e-procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.
- iii. **Submission of EMD through BG:** For submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in e-tender portal and upload scanned copy of BG in the EMD exemption document upload section. Physical copy of BG shall be submitted at the office of tender inviting authority as per respective clauses of NIT.

EMD amount can be paid either in online mode or submitted through Bank Guarantee (BG) in full. **Partial payment through online mode and remaining submission through BG is not allowed.**

**B) GENERAL INSTRUCTIONS FOR ONLINE PAYMENT OF EMD:**

- i. The bidder will have to mandatorily pay through Net-banking facility once Net-banking mode is opted for payment.
- ii. Status of NEFT/RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.). As such bidders opting to pay through NEFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicity.
- iii. In case actual EMD as per NIT is more than the one shown in E-tender Portal, bidders will have to opt for NEFT/RTGS mode (challan mode). In that case the **total actual EMD amount** is to be paid only through NEFT/RTGS mode (challan mode).
- iv. The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.

**C) REFUND OF EMD AMOUNT:**

- i. For unsuccessful bidders, EMD amount submitted against the tender shall be refunded automatically, through an automated process, by NIC portal on receipt of updated status of any bid.
- ii. For successful bid(s), EMD will be refunded from WBSEDCL authority after completion of tendering process and following due procedures.

iii. The bank account used for payment of EMD by bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.
