The bidders shall also have experience and proven track record in taking up and completion of the work of magnitude and nature similar to the items as mentioned hereunder.

Technical Requirement:

All categories of intending Bidders who have satisfactorily completed:-

- The bidder must have successfully completed similar works (civil & electrical) after 01.09.2014 under the authority of State/Central Government, State/Central Government Undertakings, statutory Bodies constituted under the statute of Central/State Government, subject to fulfillment of the following criteria:

Satisfactory Completion Certificate indicating Estimated Amount, Value of work-done and Date of Completion of the work and detail communication address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. The bidder must have full-fledged set up for executing similar nature of work. Details of execution set up to be deployed by the bidder shall be furnished in their offer.

Statutory/Non-Statutory requirements:

All categories of prospective Bidders (Firm/Entity) shall have to submit valid copies of the following documents (All the documents must be in the name of the Firm/Entity applying

as prospective bidders) :-

m) Net worth for the each of the last 03 (three) Financial Years (2017-18, 2018-19 and 2019-20) should be positive. Net worth means the sum total of the paid up capital and free reserves (excluding reserves created out of revaluation) reduced by aggregate value of accumulated losses (including debit balance in profit and loss account for current year) and intangible assets.

n) The bidder's Minimum Average Annual Turnover (MAAT) for last 03 (three) Financial Years (2017-18, 2018-19 and 2019-20) shall not be less than 30% of the estimated cost/year.

o) The working capital of the bidder in the preceding year of bid submission shall not be less

than 30% of the estimated cost.

- p) Annual Audited Financial Report for last 3 (three) years to be submitted for verification in respect of bidders for whom audit of accounts is mandatory. For those whose audit of accounts is not mandatory, they shall submit copy of IT returns along with related enclosures (3CA/3CB and particulars are reported in the Form 3CD u/s 44AB of Income Tax Act'1961) for last five years.
- The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such
