1. In the event of e-filling intending bidder may download the tender document from the website <https://wbtennders.gov.in> directly with the help of Digital Signature Certificate.
2. Both Technical Bid and Financial Bid should be submitted in technical and financial folder concurrently duly digitally signed by the Tenderer through the website <https://wbtennders.gov.in>.
3. Technical Document and Financial Bid should be submitted online on or before as per the "Date & Time Schedule" stated in SI No.-07.
4. The FINANCIAL OFFER of the prospective tenderer will be considered only if the TECHNICAL DOCUMENT of the tenderer found qualified by the Tender Inviting Authority. The decision of the Tender Inviting Authority will be final and absolute in this respect. The list of Responsive and Non-Responsive Bidders will be displayed in the website.
5. **Eligibility criteria for participation in the tender:**
 - a. **Participation in the Tender:**
 - Original manufacturer of Instruments in India will be eligible in the tender.
 - For any non-indigenous Manufacturer having either manufacturing or assembling unit in India in collaboration with any registered Indian Company, are also eligible to quote.
 - Authorized Distributor or Dealer or Channel Partner will be eligible for submission of quotation.
 - Bidder will be OEM/OES in nature.
 - Bidder must submit the performance certificate of at least One/Two/Three customers of similar or higher rating who has been using the equipment for at least 01 year. The performance certificate must contain WO/PO No. & Date, Name of issuing Authority, Date of completion, Amount after completion.
 - Instruments should be calibrated from any NABL accredited Laboratory. Calibration certificate should bear NABL logo in each page. Calibration results shall comply with the specifications
 - Warranty period should be at least 12 months for UPS and in case of Battery warranty period should be at least 24 months from the date of commissioning.

- Bids will be accepted only after meeting the technical requirement as per specification.

- Experience:** The bidder shall be an established UPS Manufacturing Company registered under the Companies Act, 1956 having operation in India for the last three years (Certificate of Incorporation).
- The bidders should have successfully supplied the tendered items/similar nature of items to WBSEDCL / other Power Utilities / other Public / Government Departments on earlier occasions having value not less than 80% (Eighty percent) of the estimated cost in a single contract or 2 no. similar nature of work having value not less than 50% (Fifty percent) of the estimated cost in 2 contract or 3 no. similar nature of work having value not less than 40% (Forty percent) of the estimated cost in 3 contract during last 7 (Seven) years.
- Average annual turnover** during last three years shall not be less than 30% of the estimated cost. Working capital in preceding year of bid submission shall not be less than 30% of the estimated cost. In case documents certifying credit facility from a scheduled Bank is submitted, the requirement given in working capital shall be judged by adding available credit facility and working capital taken together.
- All intending Bidders are required to produce valid copies of Professional Tax Registration Certificate/Registration No.(P. Tax Registration Certificate/ Enrollment Certificate as applicable), current professional tax payment certificate along with payment challan along with PAN Card / IT return for last 3 years, Annual Audited Financial Report for last 3 years. For whose Audits of accounts is not mandatory, they shall submit copy of IT returns along with related Enclosures (Form3CA and Form3CB if applicable) for last 3 years. Trade License, GST Registration Certificate/No. with GSTR-3B for the month of June, 2026 if monthly paid/for April 2026-June 2026 if quarterly paid & Certificate of compliance of statutory obligations (to be documented through e-filing).

- Bids shall remain valid for a period not less than **120(one hundred twenty)** days after date of Bid opening of tender. Bid valid for a shorter period shall be rejected by the Tender Inviting Authority as non-responsive. If the tenderer withdraws the bid before the period of bid validity without giving any satisfactory explanation for such withdrawals, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
- Specification of materials:** 20 KVA UPS along with one set (32 nos.) 100AH, 12 Volts (each) Battery should be as per Technical Particulars which is enclosed herewith as Annexure-VI.
- Earnest Money/Bid Guarantee:**

A bidder desirous of taking part in a tender invited by offices of WBSEDCL shall login to the e-Procurement portal of Government of west Bengal <https://wbttenders.gov.in> using his login Id and password. The bidder shall select the tender to bid and initiate payment of EMD amount. Exemption from deposition of EMD shall not be allowed under any circumstances. No Interest shall be payable by WBSEDCL on the above bid guarantee.

Following payment options are available for paying EMD amount through online mode:

- Net-banking through Payment Gateway
- RTGS/NEFT Payment: On selection of RTGS/ NEFT as the payment mode, the e-Procurement portal will

show a pre-filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the prefilled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed. EMD amount need to be paid in online mode. Any other mode of payment will not be accepted.

11. General Instructions for Online Payment:

- The bidder will have to mandatorily pay through Net-banking facility once Net banking mode is opted for payment.
- Status of NEFT/RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.). As such bidders opting to pay through NEFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicity.
- In case actual EMD amount as per NIT is more than the one shown in E-tender Portal, bidders will have to opt for NEFT/RTGS mode (challan mode). In that case the total actual EMD amount is to be paid only through NEFT/RTGS mode (challan mode).
- The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.

12. Refund/Settlement of EMD Amount:

- For unsuccessful bidders, EMD amount submitted against the tender shall be refunded automatically, through an automated process, by NIC portal on receipt of updated status of any bid.
 - For successful bid(s), EMD will be refunded from WBSEDCL authority after completion of tendering process and following due procedures.
 - The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.
 - For any queries related to payments and refunds, bidders will have to communicate with ICICI Customer Support, viz, 033- 40267512/ 13, since payment gateway facility used by E-tender portal is maintained by ICICI.
13. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of the Bid, the Tender Inviting Authority reserves the right to accept or reject any / all offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by the Bidder at the stage of Bidding.
14. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in "Instruction to bidders" stated in Section – "A" before tendering the bids.
15. Work Order & Payment of work will be depended on availability of fund. Intending bidders may consider this criteria while submission of tender and quoting their rate through online.
16. No Conditional Bid / Incomplete Tender will be accepted under any circumstances.
17. At any stage during scrutiny, if it is found that the credential or any other papers which the Bidder uploaded during Bidding process, found incorrect / manufactured / fabricated, that bid will be considered a nonresponsive and outright rejected with forfeiture of Earnest Money and action will be taken as per stipulation of IT Rules in force.
18. Before issuance of Letter of Acceptance / Work order/ Purchase Order, the tender accepting authority may verify the credential & other documents of the lowest bidder so uploaded online if found necessary. If it is found such document incorrect / manufactured / fabricated, Letter of Acceptance / Work order will not be issued in favor of the bidder under any circumstances and action will be taken accordingly.
19. The Tender Inviting Authority reserves the right to cancel the NIT due to unavoidable circumstances and no claim in this respect will be entertained.
20. The company shall no way be held responsible or liable for any accident, miss hap of any worker during the execution of the work, any loss or damage cause to any equipment of WBSEDCL during execution shall have to be compensated in full as per direction of the Tender Inviting Authority.
21. Standard safety norms as prescribed in the rules and regulations of WBSEDCL have to be religiously followed.
22. Liquidated damages @ 0.143% of the value of materials of the particular lot offered and/ or delivered beyond the stipulated delivery period for each day of delay, subject to a maximum of 10 % of the value of the particular lot and accept the goods beyond the stipulated period.
