1. Intending bidder should download the tender documents from the website <http://www.wbtenders.gov.in> directly with the help of Digital Signature Certificate, without any cost. The amount of Earnest Money Deposit (EMD) as mentioned above shall be deposited by the bidder electronically: online - through his net banking enabled bank account maintained at any bank or offline: through any bank by generating NEFT/ RTGS challan from the e-tendering portal. Intending Bidder will get the Beneficiary details from e-tender portal with the help of Digital Signature Certificate and may transfer the EMD from their respective Bank as per the Beneficiary Name & Account, Beneficiary Bank Name (ICICI BANK) & IFSC Code and e-procurement Reference No. Intending bidder who wants to transfer EMD through NEFT/RTGS must read the instruction of the Challan generated from e-Procurement site. Bidders are also advised to submit EMD of their bid, at least 3 working days before the bid submission closing date as it requires time for processing of Payment of EMD.
2. Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed by the bidder through the website <http://www.wbtenders.gov.in>. (Details of which has been narrated in Section-II i.e. "Instruction to Bidders") as per Schedule stated in Sl. No. 8.
3. **Eligibility criteria for participation in tender:**
The pre-qualification will be subject to bidder's fulfillment of the qualification criteria set forth and stipulated hereunder & substantiated by authentic and relevant information and details. The bidders shall also have experience and proven track record in taking up and completion of the work of magnitude and nature similar to the items as mentioned hereunder.

The bidder shall satisfactorily meet the following qualifying criteria:

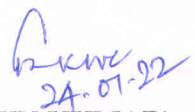
3.1 TECHNICAL CRITERIA:

- a) All categories of intending Bidders who have satisfactorily completed at least one work of similar nature of executed value not less than Rs. 3.18 lakh in a single contract after 31st December, 2018.
 - b) Similar nature of works for work under sl. no. 3.1(a) shall mean similar type of work like repair & maintenance of quarters/buildings/roads, Construction/Restoration of protection wall/sausage wall, Repair & Maintenance/Construction/Renovation of any type of drain/culvert, Repair & Maintenance of water supply, Operation & maintenance of water treatment plants etc. Execution of any type of road work that contributes towards major financial involvement of the bid.
 - c) The bidders must have satisfactorily completed works of similar nature as per above eligibility criteria under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government. Copy of order/s along with completion Certificate/s from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. Value of work-done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by The bidder along with the credential.
 - d) The bidders shall have to submit valid copies of up to date Professional Tax Payment Certificate, Professional Tax deposit challans for last six months, E.P.F. Registration Certificate, GST registration certificate, PAN Card and Income Tax Return Acknowledgement for Assessment Year, 2021-22, 2020-21, 2019-20. Trade License in respect of the prospective bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Ltd Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License), ESI registration certificate, MSME registration certificate of the bidders, if available.
 - e) Neither prospective Bidder nor any of the constituent partners had been debarred to participate in any Tender by any Government Department/Semi-Govt./ Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
 - f) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
4. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the bidder is found qualified by WBSEDCL. The decision of WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
5. **No mobilization advance and secured advance will be allowed.**
6. A prospective bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If he is found, to have applied severally, in a single job, all his offers will be rejected for that job.
 7. Bid shall remain valid for a period of 120 (one hundred twenty) days from the date of opening of Price Bid or revised Price Bid, if any. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).

10. The intending bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by WBSEDCL. WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any bidder at any stage of Bidding.
11. Prospective bidders are advised to note carefully the minimum qualification criteria as mentioned in 'Sl. no. 3' of this section and as stated in Section – II before tendering the bids.
12. Exemption from submission of Earnest Money Deposit (EMD) shall not be allowed under any circumstances.
13. Conditional / Incomplete tender will not be accepted under any circumstances.
14. The intending bidders are required to quote the rate online (Details of which has been narrated in Section-II).
15. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
16. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
- 17. The eligibility of a bidder will be ascertained on the basis of the documents submitted by a bidder in support of eligibility criteria. If any document submitted by a bidder is incorrect or false at any stage, his bid will be out rightly rejected and legal action will be taken against him.**
18. The participating bidder may please note that the successful bidder shall have to submit an Indemnity Bond in the prescribed format before commencement of work.
19. WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever.
20. WBSEDCL reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
