- 1) Name of the Work:** Creation of Training Hall & Faculty Room for EETI, Siliguri, WBSEDCL.
- 2) Eligibility Criteria:** The Bidder must possess valid Trade Licence, PAN, GSTIN, copy of executed ONE similar civil works (during last seven years from date of issue of this NIT) (along with completion certificate) and copy of the same shall be submitted along with the Tender Application.
- 3) Key Dates:** The bid documents (Bid documents consisting of NIT copy and Annexure (Price Bid) will be issued to the eligible intending bidders by The Zonal Manager, Siliguri Zonal Office, Darjeeling, WBSEDCL, upon submission of requisite fee for tender document of **Rs.295/-** (Non-refundable) [in form of CASH/DD of any Nationalised Bank of India of **Rs.295.00/-** in Favour of **WBSEDCL, payable at Siliguri** as Cost of Tender Documents] along with application for issue of Tender Documents with self-attested copy of valid Trade Licence, PAN, GSTIN, copy of at least one executed similar civil works (during last seven years from date of issue of this NIT along with completion certificate). The last date of receiving of such application shall be up to **17:00 Hrs of 18 August, 2023**. The last date of issue of tender paper against application (subject to fulfilment of eligibility criteria) is **17:00 Hrs of 25 August, 2023**. - 5) **Validity of Bid:** The bid shall be valid for a period of 180 (One Hundred Eighty Days) from the date of opening of tender.
- 6) **Opening of Tender & Award of Contract:** Submitted bids shall be opened as per date and time schedule of this NIT. Submitted documents along with the bid as asked in Cl. No. 4 of this NIT are valid, then lowest price in totality shall be the guiding factor to decide the successful bidder. The bidder whose bid will be accepted will be notified by the authorised official through letter of award. The notification of award will constitute the formation of contract.
- 7) **Defective Material:** If in the opinion of the Engineer-in-Charge/ Controlling Officer, any of the materials brought to the site for use are not of the quality or kind specified in the contract and/ or are unfit for work, he shall be at liberty to order the removal of the said materials and the contractor shall remove the same within 24 (twenty four) hours after notice has been given to him, and if he fails to remove them within the time the Engineer may cause them to be removed anywhere at the risk of the contractor and any cost incurred in so doing shall be deducted from the dues to the contractor under the contract.
- 8) **Payment:** 100% payment of ordered value along with applicable GST shall be paid to you (after deduction of Security Deposit as per company rule) after successful completion of work and submission of tax invoice in triplicate with due certification from the controlling officer of the work.
- 9) **Completion:** The work shall be completed 30 days from the date of site handover.
- 10) **Earnest Money Deposit:** intending bidder(s) shall submit DD of any Nationalised Bank of India of **Rs.1,887/-** in Favour of WBSEDCL, payable at Siliguri as Earnest Money Deposit (EMD). Tender submitted without EMD fee shall be rejected. At no circumstances, waiver of EMD shall be allowed. After successful completion of tender formalities, the EMD of the unsuccessful bidders shall be refunded upon prayer for the same to the tendering authority. The prayer shall consist detailed description of the tender along with the Bank Account details, in which the amount to be refunded. In any case the tender if gets cancelled due to any unavoidable circumstances, the EMD of all the participants shall be refunded as per norms of WBSEDCL. However, the EMD money of the successful L1 bidder shall be converted in tune to the Security Deposit for the work, which shall be refunded as per clause no 11.
- 11) **Security Deposit:** Security Deposit @8.00% shall be deducted from the bill value along with which the EMD of 02% of contract price shall be converted in tune of total of 10% of contract price as Security deposit, which shall be refunded after satisfactory completion of defect/liability period of 06 (six) months or one full monsoon period (June-September), whichever is later, which shall be reckoned from date of completion of work. In case L1 bidder submit quotes higher than the estimated amount, additional Money to complete the tune of 2% EMD value shall be deposited within 07 days after finalisation of the tender.
- 12) **Deduction of Taxes and Cess for BOCWWC Act, 1996:** If it is obligatory under the provision of Income tax Act 1961 to deduct tax at source then the same will be deducted from the bills as applicable. The contractor is

For this deductions certificate will be issued as per rules.
- 13) The bidder at the his/her own responsibility and risk is encouraged to visit and examine the site of works and its surrounding and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. The cost of visiting the site shall be at the Bidder's own expense.
- 14) The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
- 15) Conditional/Incomplete tender will not be accepted under any circumstances.
- 16) Tenders received after due date and time will not be considered under any circumstances
- 17) The price will be firm and no escalation in price will be considered under any circumstances.
- 18) The applicable goods & service tax will be paid as per GST statute.
- 19) If the Office happens to be closed on the last date of receipt of documents /opening of tender, the next working day at the same time & venue shall be applicable for the said purpose.
- 20) The Chief Engineer & Zonal Manager, Zonal Office, Siliguri, WBSEDCL, Siliguri shall be the Controlling Officer.
- 21) The Sr. Manager (F&A), Zonal Office, Siliguri, WBSEDCL, Siliguri shall be the Paying Officer.

delay subjected to Force Majeure. The total recovery against liquidated damage shall not exceed ten percent (10%) of the contract value of the work.

28) **Extension of Time:** An extension of time without imposition of liquidated damage, may be granted for delay in execution of work provided there is no fault whatsoever on the part of the contractor.
