- 1. Intending bidder should download the tender documents from the website http://www.wbtenders.gov.in directly with the help of Digital signature Certificate. Necessary Earnest Money Deposit (EMD) should be remitted separately through either online mode or in the form of Bank Guarantee in full on any schedule commercial bank in the annexed format and the same should be documented and scan copy of the aforesaid documents is to be uploaded through said website as per schedule stated in SI. No. 6. (Details of which has been narrated in the Instruction to the bidders). The last date for submission of physical copy of EMD via Bank Guarantee (if EMD in form of in form of bank guarantee is opted) will be up to 24.01.2022 upto 15.00 hrs. Partial payment through online mode and remaining submission through BG is not allowed. EMD collected via online mode will be settled automatically from e-tendering portal maintained by National informatics Centre (NIC) wherein EMD for rejected or unsuccessful bids shall be refunded in the bank account of participating bidders directly from NIC Portal. However, for successful bidder the Earnest Money will be converted into Security Deposit.
- 2. Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed by the Bidder through the website https://wbtenders.gov.in. (Details of which has been narrated in 'Instruction to Bidders') as per Schedule stated in Sl. No.8.
- 3. Eligibility criteria for participation intender:

The pre-qualification criteria will be subject to bidder's fulfillment of the qualification criteria set forth and stipulated hereunder & substantiated by authentic and relevant information and details. The bidders shall also have experience and proven track record in taking up and completion of the work of magnitude and nature similar to the items as mentioned hereunder.

(A) Technical Requirement:

All categories of intending Bidders who have satisfactorily completed:-

- The bidder must have successfully completed similar works for Civil & electrical (Composite and separate) work during last **07(Seven)** years (i.e up to 30.11.2021) under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government. Value of work done i.r.o civil & Electrical works will be evaluated separately in case of composite works. The criteria for completed similar works will be as follows:
 - a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

b) Two similar completed works each costing not less than the amount equal to **50%** of the estimated cost.

- c) One similar work each costing not less than the amount equal to 80% of the estimated cost.
- 2. Satisfactory Completion Certificate indicating estimated amount and/or Ordered Amount, Value of work-done and Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. The bidder is to upload the LOA/Execution Order/PO in full along with the BOQ showing the full description of items in respect of the work for which completion certificate is being uploaded. Delay in completion of work, if any, must be mentioned in completion certificate along with the reason.

Statutory/Non-Statutory requirements: (B)

All categories of prospective Bidders (Firm/Entity) shall have to submit valid copies of the following documents (All the documents must be in the name of the Firm/Entity applying as prospective bidders) :-

a) Professional Tax Registration Certificate/No. (P. Tax Registration Certificate/ Enrollment Certificate as applicable), current professional fees payment certificate along with payment

b) P.F. Registration Certificate/No. along with up to date return/challan for last three months,

c) GST Registration Certificate/No. with up to date return/challan for last three months, [Monthly/Quarterly as applicable]

d) E.S.I. Registration certificate/no with up to date return/challan.

- e) PAN Card and Income Tax Return for last three Assessment Years i.e. 2019-20, 2018-19, 2017-18
- f) Valid Electrical Contractor's License issued by the Licensing Board, Government of West Bengal/India under Act with valid Electrical Supervisor's Certificate of Competency (SCC) Part No. 1,2,3,4,6A,6B & 11 issued by the Licensing Board, Government of West Bengal/India (current engagement of electrical Supervisor at prospective bidders firm needs to be established).

Valid up-to-date Trade License in respect of the prospective Bidder,

h) Registration Certificates of Firms/Entities:-

a. Proprietorship Firm (Valid Trade License),

b. Partnership Firm (Valid Partnership Deed, Valid Trade License).

c. Ltd Company (Incorporation certificate i.e. MOA and AOA, Valid Trade License).

d. Co-operative Society (Society Registration copy, valid Trade License).

NB: Any MOU/Temporary Agreement/Joint Ventures/Consortium/ Any other arrangement to constitute an Entity having no statutory Registration Certificates (Non-Permanent Establishment) beyond the above entities (mentioned in h- a to d) for the purpose of applying as prospective bidder will not be considered as valid document.

i) Performance as prime contractor applying as prospective bidder for execution of similar nature of work for last seven years will only be considered.

Information regarding any past and current litigation with WBSEDCL/WBSETCL/Govt/PSU in which the bidder is involved, the party's concerned and disputed amount.

- k) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt/Govt Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. (A declaration on Rs.100.00 Non Judicial Stamp duly notarized by Notary Public, in this respect has to be furnished by the prospective bidders).
- 1) The bidder shall submit reports on the financial standing i. r. o. solvency of Bidder (Company/ Firm) as certified by bankers in Bank's Official Letter Head, audited annual reports on accounts with auditors' certificate for company registered under Companies Act and Tax Audit Report for Partnership Firms for Financial Years 2017-18, 2018-19 and 2019-20.
- m) Net worth for the each of the last 03 (three) Financial Years (2017-18, 2018-19 and 2019-20) Should be positive. Net worth means the sum total of the paid up capital and free reserves (excluding reserves created out of revaluation) reduced by aggregate value of accumulated losses (including debit balance in profit and loss account for current year) and intangible assets.

n) The bidder's Minimum Average Annual Turnover (MAAT) for last 03 (three) Financial Years (2017-18, 2018-19 and 2019-20) shall not be less than 30% of the estimated cost per year.

o) The working capital of the bidder in the preceding year of bid submission shall not be less than 30% of the estimated cost per year.

p) In case documents certifying credit facility from a scheduled bank is submitted, the requirement given in clause no (o) shall be judged by adding available credit facility and working capital taken together.

q) Annual Audited Financial Report for last 3 (three) years to be submitted for verification in respect of bidders for whom audit of accounts is mandatory (3CA/3CB and particulars are reported in the Form 3CD u/s 44AB of Income Tax Act'1961 are to be submitted). For those whose audit of accounts is not mandatory, they shall submit copy of IT returns along with related enclosures for last five years.

r) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration on Rs.100.00 Non Judicial Stamp duly notarized by Notary Public, in this respect has to be furnished by the prospective bidders). (Non-statutory Documents.)

s) No conditional / incomplete /inadequate / wrong submission of Tender Documents and facts will be accepted under any circumstances and no further prayer for consideration will

entertained.

- t) Details of Eligibility criteria for participation in tender for Electrical Works are mentioned in Instruction to Bidders (SECTION-A) under the head A-2. (Sl. No. vii, viii & ix) Non statutory cover containing of Eligibility criteria for participation in tender.
- 4. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.

5. No mobilization advance and secured advance will be allowed.

- A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm, Society, Company, Registered Unemployed Engineers Cooperative Society/Registered Labour Co-operative Society. If found applied severally in a single job, all his offers will be rejected for that job.
- 7. Bid shall remain valid for a period not less than 180 (one hundred twenty) days from the date of opening of Financial Bid. If the bidder modifies/withdraws the bid during the interval between the deadline for submission of bids and the expiry of the period of bid validity, the bid will be cancelled with forfeiture of earnest money deposit (EMD).
