Intending bidders desirous of participating in the tender are to log on to the website <https://wbttenders.gov.in> for the tender.

Bidders willing to take part in the process of e-tendering are required to obtain Digital Signature Certificate (DSC) in the name of person who will sign the tender, from any authorized Certifying Authority (CA) under CCA, Govt of India (viz. nCode Solution, Safescrypt, e-Mudhra). DSC is given as a USB e-Token. After obtaining the Class 2 or Class 3 Digital Signature Certificate (DSC) from the approved Certifying Authority they are required to register the fact of possessing the Digital Signature Certificates through the registration system available in the website.

Tenders are to be submitted online and intending bidders are to download the tender documents from the website stated above, directly with the help of the e-Token provided. This is the only mode of collection of tender documents. Details of submission procedure are given in "Instructions to Bidders".

### Terms & conditions of the Tender Notice:

1. Earnest Money amounting Rs. 20,589/- (Rupee Twenty thousand Five Hundred Eighty Nine only) is to be deposited for transportation of all materials / equipment. Earnest Money deposit shall be submitted through following online payment modes.

- **Net Banking** through Payment Gateway.
- **RTGS / NEFT Payment:** On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre - filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e-Procurement portal to continue the bidding process after expiry of reasonable time to enable the RTGS/NEFT process to be completed.

### **2. General Instructions for Online Payment:**

- The bidder will have to mandatorily pay through Net-banking facility once Net-banking mode is opted for payment.
- Status of NEFT/RTGS payment through Challan for a bid may take time for bank settlement to be updated in 24 Hrs. (approx.). As such bidders opting to pay through NEFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicity.
- In case actual EMD amount as per NIT is more than the one shown in E-tender Portal, bidders will have to opt for NEFT/RTGS mode (challan mode). In that case the total actual EMD amount is to be paid only through NEFT/RTGS mode (challan mode).
- The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.

### **3. Refund/Settlement of EMD Amount:**

- For unsuccessful bidders EMD amount submitted against the NIT shall be refunded automatically, after completion of empanelment process against the NIT, through an automated process, by NIC portal on receipt of updated status of any bid.







- The Earnest Money Deposit of the successful bidders will be converted to Permanent Security Deposit. The Permanent Security Deposit will be refunded to empanelled vendors after expiry of "Total Empanelment Period".
  - The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of "Total Empanelment Period". All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.
  - For any queries related to payments and refunds, bidders will have to communicate with ICICI Customer Support, viz, 033-40267512/13 since payment gateway facility used by E-tender portal is maintained by ICICI.
4. All intending bidders are required to produce valid copies of blue books /smart cards of vehicle owned (self-attested), document in support of valid Insurance coverage, Route permit, Trade license, Road Tax & Pollution free Certificate. Copies of Transport Orders, Copies of signed Challans, completion certificate in support of similar nature of work already executed from users at least for two separate jobs during any of the two years of the last seven financial years under WBSEDCL/ WBSETCL/WBPDCL/ other Govt. Department. Statements on Annual turnover for last three financial years, duly certified by a Chartered Accountant. Professional Tax Registration Certificate/Registration No.(P. Tax Registration Certificate/ Enrollment Certificate as applicable), current professional tax payment certificate along with payment challan. Photo Copy of valid/operative PAN CARD (self-attested). Income Tax Return for last three Assessment Years, Annual Audited Financial Report for last 3 years (3CA and 3CB if applicable). GST Registration Certificate/No (GSTR3B) with up to date return/challan for October 2025 if monthly paid/July-September 2025 if quarterly paid. Solvency certificate from any schedule bank of India.
5. No agent is allowed to participate in the Tender. Original **Vehicle Owners** will only be allowed in the tender.

12. A new contract will be initially awarded for a period of 2 (two) years, with the option for a further 1 (one)-year extension based on satisfactory performance and agreed-upon rates.
