5.1 Technical Requirement:- Bonafide, experienced & resourceful contractors of Govt., Semi Govt., Govt. undertaking Organizations, Govt. Commercial Requirement:- a) Average annual turnover during last three years shall not be less than 30% of the estimated cost. b) Working capital in the year preceding the year of bid submission shall not be less than 30% of the estimated cost. c) available credit facility shall also be added to working capital certified by Bank for working capital as noted in (b) above. d) Annual audited Financial Report for last three years to be submitted for verification i.r.o bidders for whom audit of accounts is mandatory. For those whose audit of accounts is not mandatory, they shall submit copy of IT return along with related enclosures (Form 3CA and Form 3CB) for last three years.
