4.0 ELIGIBILITY CRITERIA OF THE BIDDER:

4.1 Technical:

The bidder must have successfully completed construction of similar nature of work having all the required License and enlistment must be produced for such kind of Works. Documents in support of supply of the tendered items to WBSEDCL, in earlier occasions as mentioned below:

Value not less than 80% (eighty percent) of the tendered amount in a single contract in the jurisdiction of West Bengal State.

Or Value not less than 50% (fifty percent) of the tendered amount in two contracts (cumulatively) in the jurisdiction of West Bengal State.

4.2 Commercial & Financial:
