Gate Valve, Gasket Sheet, Hole punch set etc. by the Project Manager, Rammam Hydel Project, St.-II, WBSEDCL, P.O.: Lodhomahat, Dist.: Darjeeling, Pin: 734201 for Supply and Delivery of "gate valves, 7/16" stainless steel stud, gasket for bearing oil heat exchanger and hole punch set for cutting of gasket in proper size", as detailed below in Sl. No. 1 (scope of supply) for Rammam H.P., St-II, Dovan, P.O. Lodhomahat, Dist. Darjeeling, Pin: 734201.

Notice Inviting Tender (NIT) will be made available in the website of WBSEDCL (www.wbsedcl.in) for downloading and displayed at Notice Board of above office from **08-07-2022 at 10:00 hrs.** The bids will be received up to **28-07-2022 till 17:00 hrs.** and will be opened on next working day i.e. on **29-07-2022 at 14:00 hrs.** in the presence of authorized representative of Tenderers. Tender description, Tender notice no. and due date of opening of the tender should be written on the envelope in a legible manner. Rates should be quoted in the prescribed format as furnished in Annexure-I. No NIT will be issued in name of any Agency/ Dealer.

The tenders will be guided by the following general terms and conditions:

GENERAL TERMS AND CONDITIONS:

1. SCOPE OF SUPPLY:

2. DELIVERY PERIOD:

The Materials shall have to be delivered at site i.e. Rammam Hydel Project, Stage II, Lodhomahat, Dist. Darjeeling, Pin: 734201 within 45 (Forty-Five) days from the date of placement of Purchase Order (PO).

3. FREIGHT & INSURANCE:

Charges i.r.o. Transportation and Transit Insurance shall be capped up to 03% (three percent) of the ordered amount and shall be reimbursed after submission of duly signed authenticate supporting documents by the supplier.

4. TAXES & DUTIES:

Taxes & Duties, if any, are to be mentioned clearly and shall be reimbursed as per prevailing norms. (GST shall be extra as per norms and IT @ 2% may be deducted, if required)

5. PAYMENT:

100% (One Hundred percent) payment along with GST and F&I will be paid after satisfactory receipt of materials at site (Rammam Hydel Project stage II, Lodhomahat, Dist. Darjeeling, Pin: 734201) in good order and condition. Payment shall be made through fund transfer against receipt of bill and challan in triplicate. The Agency shall have to submit their bank account details along with the offer. Bank charges, if any, shall be borne by the Agency.

6. VALIDITY:

The Tender / Quoted Rates shall remain valid for One Hundred & Twenty (120) days from the date of opening of the NIT.

7. GUARANTEE:

Materials shall have to be guaranteed for 12 (twelve) months from the date of installation or 18 (eighteen) months from the date of receipt of materials at site, whichever is earlier, against any manufacturing defect. The Agency shall submit a Guarantee Certificate along with the invoice during the time of delivery.

8. LIQUIDATED DAMAGES:

Liquidated damages @ ½ % (half percent) per week up to 10 (ten) weeks and @1% (One percent) beyond that, for delay in supply or part thereof subject to a maximum of 10% (ten percent) will be imposed for non-delivery of materials within the stipulated delivery period as mentioned in Sl. No. 2 above.

9. RISK PURCHASE:

The time of delivery as stipulated in this NIT shall be deemed to be the essence of the order and if you fail to deliver any consignment within the period prescribed for such delivery as mentioned above, WBSEDCL shall be entitled to purchase such consignment or if not available, the best and nearest available substitute elsewhere on your account and at your risk or to cancel the order and you shall be liable to compensate for any loss or damage which WBSEDCL may sustain by reason of such failure on your part.

10. STATUTORY TAX & SETTLEMENT OF DISPUTES:

Income tax and STDS together with GST will be deducted or paid as per laws from the Invoice. All disputes shall be settled amicably and where settlement cannot be reached then disputes shall be subjected to settlement under the jurisdiction of Darjeeling Court/ Kolkata High Court.


