3. Eligibility criteria for participation in tender:

- i. The bidder must have successfully completed similar works during last 7 (Seven) years from the date of this Notice Inviting Tender under the authority of State/Central Government, State/Central Government Undertakings, Statutory Bodies constituted under the statute of Central/State Government, subject to fulfillment of the following criteria:

(a) **Three similar** completed works each having executed cost not less than 40% of the total estimated cost in a single contract,

OR

(b) **Two similar** completed works each having executed cost not less than 50% of the total estimated cost in a single contract,

OR

(c) **One similar** completed work each having executed cost not less than 80% of the total estimated cost in a single contract. [Non-statutory Documents]

Order shall be submitted with the bid in this regard. Completion certificate should clearly indicate name of work, Executed value of work, date of commencement, date of completion, Letter of Award/Award of Contract/Work Order No. The Completion Certificate of concerned statutory body of Central or state government will be treated as valid credential. The completion certification shall be issued by an officer of executive rank or above. Completion certificate not having the above stated information or not fulfilling the above mentioned criteria will not be accepted. Letter of Award/Award of Contract/Work Order without any completion certificate will not be accepted as valid credential.

- ii. Average annual turnover during last three years shall not be less than 30% of the estimated cost. [Non-statutory Documents].
- iii. Working capital in preceding year of bid submission shall not be less than 30% of the estimated cost. [Non-statutory Documents].
- iv. In case documents certifying credit facility from a scheduled Bank is submitted, the requirement given in 3. (iii) shall be judged by adding available credit facility and working capital taken together. [Non-statutory Documents].
- v. **Annual Audited Financial Report** for last 3 (three) years to be submitted for verification in respect of bidders for whom audit of accounts is mandatory (3CA/3CB and particulars are reported in the Form 3CD u/s 44AB of Income Tax Act'1961). For those whose audit of accounts is not mandatory, they shall submit copy of **IT returns, Balance Sheet, P&L Statements** along with related enclosures for last five years. - vi. All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax receipt Challan, Up to date valid Professional Tax receipt Certificate, E.P.F. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders). [Non-statutory Documents]
- x. No conditional / Incomplete Tender will be accepted under any circumstances.
4. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
5. No mobilization advance and secured advance will be allowed.
6. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a single job, all his offers will be rejected for that job.
7. Bid shall remain valid for a period not less than 180 (one hundred eighty) days from the date of opening of Technical Bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).

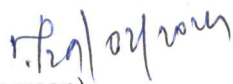
