### INVITATION TO BID

#### **1.0 SCOPE OF WORK :**

The specification/contract is intended to cover execution of civil work proposed for:

1. Renovation of Ghatal Division Administrative Building, boundary wall and other allied civil works under Ghatal Division in Paschim Medinipur Region, WBSEDCL
2. Construction of 1 no 6.3 MVA PTR, 1no VCB, 1no CT & 1 no Station Service Plinth, Control Cable Trench along with looping arrangement for Creation of Bay at Kalua Brindaban 33/11 kV Suh-Station under Kharagpur Division, District -Paschim Medinipur
3. Construction of Fencing and Pathway to Create a Separate Corridor for operating 33 kV Outgoing Isolator to handover it to WBSETCL at Debra 33/11 kV Sub-Station Premises under Kharagpur Division, District:- Paschim Medinipur.

The work is including supply of all materials, labour, equipment's etc. and any other works required for completion of the works in all respect as per technical specification, schedule of works and approved drawings.

#### **2.0 REQUEST FOR TENDER :**

#### **3.0 SUBMISSION OF TENDER:**

The tender will be submitted in two bid systems i.e. Techno-Commercial bid & financial bid, online only through the Website [www.wbtenders.gov.in](http://www.wbtenders.gov.in)

#### **4.0 ELIGIBILITY CRITERIA OF THE BIDDER:**

##### **4.1 Technical :**

**A bidder shall be considered technically eligible, with experience of having successfully completing Construction projects of similar nature of works with a focus on electrical substation work during last 7 years subject to fulfilment of the following criteria**

- a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost.  
Or
- b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost.  
Or
- c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.

The word 'similar' shall mean similar type of work like building, switchyard foundations etc that contributes towards major financial involvement of the bid. In case of jobs with combination of different types, eligibility requirement will be from 'must conditions'. The eligibility criterion may differ for different serial number of tender based on the major financial involvement in that particular job.

The bidder has to submit credential documents over estimated values works as mentioned above. Completion Certificate indicating Estimated Amount, Value of work-done, date of completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. [Non-statutory Documents]

### **4.2 Commercial & Financial:**

4.2.1 The average annual turnover of the bidder during last three years shall not be less than 30% of the estimated cost. (Annexure-I).

4.2.2 Working capital in the year, proceeding the year of bid submission shall not be less than 30% of the estimated cost.

4.2.3 In case documents certifying credit facility from a scheduled bank is submitted, the requirement given in cl 4.2.2 shall be judged by adding available credit facility and working capital taken together.

### **4.3 The Bidder must include following documents to substantiate the qualifying requirement such as:**

4.3.1 Monetary value of civil engineering work performed by the bidder in last seven years (copy of order and completion certificate to be enclosed). (Annexure-II)

4.3.2 Major items of construction equipment proposed to carry out the contract. (Annexure-III)

4.3.3 Qualification and experience of key site management and technical personnel proposed for the contract. (Annexure-IV)

4.3.4 Annual Audited Financial Report for last 3 (three) financial years to be submitted for verification in respect of bidders for whom audit of account is mandatory. For those whose audit of accounts is not mandatory, they shall submit copy of IT returns along with related enclosures (Form 3CA and Form 3CB) for last five years.

4.3.5 Information regarding any past and current litigation with WBSEDCL/WBSETCL/Govt./PSU in which the bidder is involved, the party's concerned and the disputed amount.

### **4.3.6 Photocopy of following documents:**

- i) P. Tax with deposited latest challan.
- ii) PAN Card.
- iii) P.F. Registration No. along with latest challan of last 3 (three) months.
- iv) GST registration certificate.

4.4 Photocopies of all documents should be self-authenticated.

4.5 Notwithstanding anything stated above, the owner (WBSEDCL) reserves the right to assess the capacity and capability of the bidder to execute the work, should the circumstances warrant such assessment in the overall interest of the owner.

4.6 Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have,

4.6.1. Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualifying requirements and/or

4.6.2. Record of poor performance such as abandoning the work, not properly completing the contract, inordinate delays in completions, litigation history or financial failure.

### 5.0 Pre-Bid Meeting :

- 5.1 Pre bid meeting will be held on **21-01-2025 at 11-00 hours** at the Conference Room of Administrative Building, WBSEDCL, Power House Complex, Burdge Town, Midnapore, Dist: Paschim Medinipur.
- 5.2 Any change in date shall be available in website of [www.wbtenders.gov.in](http://www.wbtenders.gov.in).
- 5.3 Non attendance at the Pre-bid meeting will not be a cause for disqualification of bidders.
- 5.4 If there be any discrepancy or obscurity in the meaning of any clauses of the bid document or if there be any query of the intending bidder, the bidder may submit their queries to the tendering authority on or before **21-01-2025 at 11-00 hours**. The clarification given in the pre-bid discussion shall be final and binding on the bidder, being a part of the original Bid Documents.

### Note:

1. WBSEDCL reserves the right to reject or accept any Bid or part thereof or all Bids received at its sole discretion without assigning any reason(s) whatsoever.
2. WBSEDCL reserves the right to go to divisible contract, if necessary.
3. WBSEDCL is not necessarily bound to accept the lowest offer.
4. **Tender Cost /Tender Fee is abolished. All participating bidders are therefore exempted from payment of Tender Fee.**
5. No interest shall be payable for Bid Guarantee/EMD.
6. Any extraneous conditions will be treated as non-responsive.
7. The Bids must be submitted in prescribed proforma only, where indicated i.e. Annexures, BOQ and Rate.
8. Bidders shall ensure that all pre-requisites are duly fulfilled by them and if there be any dispute regarding non-submission of any document, WBSEDCL reserves the right to cancel the Bid unilaterally without assigning any reasons.
9. The bidder is expected to examine carefully all instructions, conditions, forms schedules terms, annexure, specifications and drawings of the bidding document. Bids, which are determined to be not substantially responsive to the requirement of the bidding document, may lead to rejection.
10. **All bids in the range of -20% to -80% of the estimated cost shall furnish an Additional Performance Security in the form of Bank Guarantee (Annexure-VII) from any scheduled Bank, which shall be equal to 10% of the Tendered amount.**
11. **Earnest Money (EMD) : Earnest Money Deposit shall be submitted through online mode through the e-Tendering portal (<https://wbtenders.gov.in>). All offline instruments like Bank Draft, Pay Order etc. will be stopped for e-tender procurement. ii. **RTGS/NEFT Payment:** On selection of RTGS/NEFT as the payment mode, the e-procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.

iii. **Submission of EMD through BG:** For submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in e-tender portal and upload scanned copy of BG in the EMD exemption document upload section. Physical copy of BG shall be submitted at the office of tender inviting authority as per respective clauses of NIT. EMD amount can be paid either in online mode or submitted through Bank Guarantee (BG) in full. **Partial payment through online mode and remaining submission through BG is not allowed.**

### B) GENERAL INSTRUCTIONS FOR ONLINE PAYMENT OF EMD :

- i. The bidder will have to mandatorily pay through Net-banking facility once Net-banking mode is opted for payment.
- ii. Status of NEFT/RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.). As such bidders opting to pay through NEFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicity.
- iii. In case actual EMD as per NIT is more than the one shown in E-tender Portal, bidders will have to opt for NEFT/RTGS mode (challan mode). In that case the **total actual EMD amount** is to be paid only through NEFT/RTGS mode (challan mode).
- iv. The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.

### C) REFUND OF EMD AMOUNT:

- i. For unsuccessful bidders, EMD amount submitted against the tender shall be refunded automatically, through an automated process, by NIC portal on receipt of updated status of any bid.
- ii. For successful bid(s), EMD will be refunded from WBSEDCL authority after completion of tendering process and following due procedures.
