Online e-tenders in two-part system [i] Technical Bid and ii) Financial Bid] with item-wise basis are invited by the Project Manager, Rammam Hydel Project, Stage - II, WBSEDCL, Lodhamahat, Darjeeling-734201 from eligible vendors for the 2nd Call i.r.o. *Repair of Gate for 1500 mm X 1570 mm Shingle Excluder Duct (Zone-II) including supply of all the materials and considering all civil and mechanical works at Rammam Hydel Project, Stage-II, WBSEDCL, Lodhamahat, Darjeeling-734201.*

1. **Name of Work:** Repair of Gate for 1500 mm X 1570 mm Shingle Excluder Duct (Zone-II) including supply of all the materials and considering all civil and mechanical works as per the scope specified in Chapter 4: Special Condition of Contract.
2. **Estimated Amount:** Rs. 13,20,173/- (rupees thirteen lakh twenty thousand one hundred and seventy-three only) (Excl. GST)
3. **Earnest Money:** Rs. 33,004/- (Rupees thirty-three thousand and four only)
4. **Eligibility Criteria:** The Bidder must possess minimum eligibility criteria as mentioned below:
 - a. Valid GST Registration Certificate
 - b. PAN Card
 - c. License in respect of prospective bidder such as Proprietorship Firm (Trade License), Partnership Firm (Partnership deed, Trade License), Ltd. Company (Incorporation Certificate, Trade License).
 - d. The Bidder shall have the experience of construction, repair and maintenance of sluice gates, penstock and other structures associated with hydel power projects operated by any Central/State/Private Power Utility for an order value amounting minimum fifty percent (50%) of this estimated price in last seven (07) years.In support of the above, the bidders shall submit the Letter of Award (LOA) and/or Delivery Certificate duly signed by respective ordering authority.

The Bidder shall produce original copy of the documents i.r.o. eligibility criteria, if so, required by WBSEDCL. Any discrepancies found by the tender inviting authority may lead to rejection of the bid and forfeiture of the earnest money.

All the documents in support of bid are also to be scanned and uploaded along with the tender document. Bid submitted/sent by any other mode will not be accepted.

7. Validity:

The tender shall be valid for one hundred and eighty (180) days from the date of opening of technical bid.

8. Conditional / Incomplete tender will not be accepted under any circumstances.

9. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.

10. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by a Bidder in support of eligibility criteria. If any document submitted by a Bidder is incorrect / manufactured / fabricated or false at any stage, his Tender will be rejected and legal action may be taken against him.

11. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s). WBSEDCL reserves its right to take decision keeping its financial interest.

12. WBSEDCL reserves the right to:

- Amend the scope of work to be tendered.
- Reject any or all the offers without assigning any reason whatsoever at any time prior to the Award of Contract, without thereby incurring any liability to the affected bidder(s); and
- Cancel the bidding process and reject all bids, without assigning any reasons thereof.

WBSEDCL will not be liable for any such actions. However, the bidder(s), who wish to seek reasons for such decision of cancellation / rejection, shall be informed by WBSEDCL unless its disclosure reasonably could be expected to affect the sovereignty and integrity of India; the security, strategic, scientific or economic interest of the State; relation with foreign state or lead to incitement of an offence. In such case, the Earnest money submitted by the bidder(s) will be refunded to the bidder without any interest.

13. WBSEDCL reserves the right to assess the bidders' capacity and capability to perform the contract and may relax the qualifying requirements at any stage, if required.

14. No price preference will be allowed to any agency/supplier/contractor based on the size of the company or its geographic location. Co-operative Society / MSME will not be considered with separate status.
