Envelope no. 2(two) containing filled with quote rate duly signed and stamped by the agency. Tender is to be submitted on firm's original letter head in sealed cover addressed to the Project Manager, Jaldhaka Hydel Project, WBSEDCL, Paren, Kalimpong-734503 and shall be super scribed with the Tender notice no. name of the work/materials, name and address of the firm submitting the tender including deadline of submission of bids.
