# **INSTRUCTION TO BIDDER (IB)**

## **IB.1. Introduction:**

**IB.1.1.** West Bengal State Electricity Distribution Company Limited herein after referred to as WBSEDCL invites e-tenders for implementation of GPS based online tracking and monitoring system for all LT and HT Mobile Vans engaged in maintenance job plying under different site offices of WBSEDCL throughout the West Bengal as per detail "Scope of Work" and other terms and conditions furnished in the different clauses of the bid document.

**IB.2. Objective:** WBSEDCL invites tenders for Implementation of Vehicle Tracking System (VTS) for LT and HT Mobile Van of WBSEDCL plying throughout the West Bengal

## **IB.3. Invitation for the BIDs:**

**IB.3.1.** Tender is invited by the Chief Engineer, IT&C Cell, WBSEDCL, Vidyut Bhavan, 3rd Floor, Block DJ, Sector- II, Bidhannagar, Kolkata- 700091, through electronic tendering (e-tendering) for Vehicle Tracking System (VTS) for LT and HT Mobile Van of WBSEDCL plying throughout the West Bengal.

**IB.3.2.** Intending Bidders, desirous of participating in the tender, are to log on to the website <http://wbtenders.gov.in>. The tender can be searched by typing 'wbasedcl' in the search box of the website.

**IB.3.3.** Bidders, willing to take part in the process of e-tendering, are required to obtain Digital Signature Certificate (DSC) in the name of person who will sign the tender, from any authorized Certifying Authority (CA) under CCA, Govt of India (viz. nCode Solution, Safescrypt, e-Mudhra). DSC is given as a USB e-Token. After obtaining the Class 2 or Class 3 Digital Signature Certificate (DSC) from the approved Certifying Authority they are required to register the fact of possessing the Digital Signature Certificates through the registration system available in the website.

**IB.3.4.** Intending bidders are to download the tender documents from the website stated above, directly with the help of the e-Token provided. This is the only mode of collection of tender documents. Details of submission procedure are given in "Instructions to Bidders".

## **IB.4. Eligibility of Bidder:**

**IB.4.1.** The bidder should comply all mandatory conditions clauses as per the relevant Annexures and Forms.

**IB.4.2.** The bidder should not have been blacklisted from any Govt. organization across India from the year of 2017 onwards and undertaking in this regard should be provided by the authorized signatory of the bidder. During contract period if the undertaking submitted by the bidder is found to be false, the order issued on vendor shall be terminated with the forfeiture of the Performance Bank Guarantee (PBG).

## **IB.5. Responsibility of Bidders:**

**IB.5.1.** It shall be the sole responsibility of Bidders to determine and to satisfy themselves by such means as they consider necessary or desirable for all matters pertaining to this contract including, in particular, all factors that may affect the cost, duration and execution of the work.

**IB.5.2.** It must be understood and agreed that such factors have properly been investigated and considered while submitting the bid. Any claim, whatsoever, including those for financial adjustments to the contract, once awarded under these documents will not be entertained by WBSEDCL. Neither any change in time schedule of the contract nor any financial adjustments, arising thereof, shall be permitted by WBSEDCL, which are based on the lack of such clear information of its effect.

**IB.5.3.** The bid shall include all the information as per bid document.

**IB.5.4.** The bidder shall bear all the costs associated with the preparation and submission of bid and WBSEDCL, in no case, shall be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

**IB.5.5.** In order to avoid any problem arising out of network error or server error, bidders are advised to submit the bid, well in advance of the last date and time of submission of the bid.

**IB.6. Formation of cartel & penal Measures:** Any evidence of unfair trade practices, including overcharging, price fixing, cartelization etc. as defined in various statutes, will automatically disqualify the Bidder(s). Repeated occurrence of such evidence of above tenderers may also be viewed seriously by the WBSEDCL authority and penal measures as deemed fit would be imposed on such tenderers.

**IB.8.** If any 'Strike' or 'Holiday', falls on any of the scheduled date, then the next working day (between mentioned working hours) shall be considered as scheduled date and schedule time.

## **IB.9. Pre-Bid Discussion:**

**IB.9.1.** Pre-bid discussion will be held at WBSEDCL as per schedule indicated in “**Key Dates Clause**” above to clarify the queries, if any, from the vendors in respect of tender. Vendors, willing to participate, may attend the meeting (maximum two persons) authorised by them. The letter of Authorization of System Integrator (Bidder) shall have to be produced at the time of attending the meeting.

**IB.9.2.** Relevant queries in soft copy EXCEL format as per **ANNEXURE-VII** must be forwarded to the following mail id: [ceit@wbasedcl.in](mailto:ceit@wbasedcl.in) and [uttamk.jana@wbasedcl.in](mailto:uttamk.jana@wbasedcl.in) with c.c. to [itc.wbasedcl@gmail.com](mailto:itc.wbasedcl@gmail.com).

**IB.9.3.** Non-attendance at the pre-bid discussion will not be a cause for disqualification of the bidders.

**IB.10. Clarification on Bidding Documents:** If there is any ambiguity/confusion in the meaning of any clause of the bid document, such queries must be sent to the email IDs as mentioned in IB9.2 three days prior to the date of Pre-bid discussion. Such query received from vendors prior to pre-bid discussion shall only be discussed in the pre-bid discussion. **No other query except the written submitted ones will be clarified during pre-bid discussion.** If any changes are decided in pre-bid meeting the same will be uploaded in the website <http://wbtenders.gov.in> and no other communication shall be made afterwards on the issues discussed in the pre-bid meeting. The clarification given in pre-bid discussion shall be final and binding on the bidder.

**IB.11. Amendment / Addenda of Bidding Documents:** At any time, prior to the deadline of submission of Bid, WBSEDCL may, for any reason, modify the Bidding Documents, if required, by issuing Addenda / Amendments and the same will be uploaded in the website (<http://wbtenders.gov.in>) only in due time. WBSEDCL shall not have any obligation to inform the vendor through any other mode of communication.

**IB.12. Language of the Bid:** The bid so prepared by the bidder and all other correspondences and documents relating to the bid, exchanged by the bidder and WBSEDCL, shall be written in English Language only.

**IB.13. Currencies of Bid and Payment:** All prices shall be quoted by the bidder in ‘Indian Rupees’ (INR) only. Payment is also to be made in ‘Indian Rupees’ (INR) only.

**IB.14. Period of validity of Bid:** The bid shall remain valid for acceptance up to 180 (One hundred and eighty days) from the date of opening of tender. WBSEDCL may request to extend Validity of the bid beyond 180 (One hundred and Eighty) days if required so, without any change in offer.

## **IB.15. Earnest money [Bid Guarantee]:**

**IB.15.1.** The bidder desirous of taking part in a tender invited by WBSEDCL shall login to the e Procurement portal of Government of West Bengal <https://wbtenders.gov.in> using his login ID and password.

**IB.15.2.** The bidder shall select the tender to bid and initiate payment of EMD of Rs. 11,61,563/- (Rupees Eleven Lakhs Sixty-One Thousand Five Hundred and Sixty-three only) including 18% GST. [2.5% of estimated price of Rs. 4,64,62,500/-].

**IB.15.3.** EMD may be submitted either through the following modes i) Through online payment or (ii) In the form of BG. The details of which are elaborated below:

**IB.15.3.1. Net-banking through Payment Gateway.**

RTGS/ NEFT Payment: On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/ NEFT transaction. The bidder will print the challan and use the pre- filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e Procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.

**IB.15.3.2. Submission of EMD through BG:** For submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in e-tender portal and upload scanned copy of BG in the EMD exemption document upload section. Original BG shall be submitted at the office of tender inviting authority as per respective clauses of NIT.

**IB.15.4.** Partial payment through online mode and remaining submission through BG is not allowed. In case the EMD is submitted in the form of irrevocable Bank Guarantee, it is to be submitted as per format in ANNEXURE-IV and shall remain valid initially for a period of six months from the last date of submission of the bid document and claim period will be further 3 months. **IB.15.5. General Instructions for Online Payment:**

**IB.15.5.1.** The bidder will have to mandatorily pay through Net-banking facility once Net banking mode is opted for payment.

**IB.15.5.2.** Status of NEFT/ RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.). As such bidders opting to pay through NEFT/ RTGS mode shall make payment well before 24 Hrs. to avoid any complicity.

**IB.15.6. Refund/Settlement of EMD Amount:**

**IB.15.6.1.** For unsuccessful bidder(s), EMD amount as submitted against the tender shall be refunded automatically, through an automated process, by NIC portal on receipt of updated status of any bid.

**IB.15.6.2.** For successful bidder(s), EMD will be refunded from WBSEDCL authority after completion of placement of LOA, submission of PBG and execution of contract agreement following due procedures.

**IB.15.6.3.** The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.



**IB.15.6.4.** For any queries related to payments and refunds, bidders will have to communicate with ICICI Customer Support, viz, 033-40267512/ 13 since payment gateway facility used by E-tender portal is maintained by ICICI.

**IB.15.7.** Successful Bidder(s) shall have to mandatorily create vendor ID through WBSEDCL Web Portal Vendor Corner, if not created earlier.

**IB.15.8.** For 'Bid Guarantee' submitted in the form of BG, the said Guarantee of the unsuccessful vendor(s)/Bidder(s) will be returned against their written claim within one month from the date of placement of order and execution of contract agreement with the selected Bidder.

**IB.15.9.** For 'Bid Guarantee' submitted as BG, the Bid Guarantee of the successful vendor(s)/Bidder(s), will be returned within 30 (thirty) days from the date of acceptance of Performance Guarantee to be submitted as per Performance Guarantee Clause of bid document.

**IB.15.10.** No interest shall be payable by WBSEDCL on the above Bid Guarantee.

**IB.15.11.** The Bid Guarantee shall be forfeited for any of the following reasons:

**IB.15.11.1.** If during the period of bid validity, the bidder withdraws or modifies the bid in part or as a whole.

**IB.15.11.2.** If the undertaking provided regarding blacklisting is found to be false.

**IB.15.11.3.** If the successful Bidder fails to accept the order unconditionally as per "Acceptance of Order" clause.

**IB.15.11.4.** If the successful Bidder fails to submit the Contract Agreement as per relevant clause.

**IB.15.11.5.** If the successful bidder fails to furnish the contract performance guarantee as stipulated in PBG clause of bid document.

**IB.15.11.6.** If the successful bidder fails to extend the validity period of EMD as per "Earnest Money" Clause of bid document, as and when required.

**IB.15.11.7.** If any cartel is formed by the bidder(s)/tenderer(s) in their quotation.

**IB.16. General guidance for e-Tendering:** Instructions/Guidelines for electronic submission of the tenders have been mentioned below for assisting the bidders to participate in e-Tendering.

**IB.16.1. Registration of Bidders:** Any bidder willing to take part in the process of e-Tendering will have to be enrolled & registered with the e-Procurement system, through logging on to <https://wbtenders.gov.in>.

**IB.16.2. Digital Signature certificate (DSC):** Each bidder is required to obtain a class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders.

**IB.16.3.** The bidder can search and download NIT & Tender Documents electronically from the <https://wbtenders.gov.in> website using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

**IB.17. Signing of Bids:**

**IB.17.1.** The bid shall be downloaded from the website [www.wbtenders.gov.in](http://www.wbtenders.gov.in) and shall be signed by a person / person(s) duly authorized by the bidder.



**IB.17.2.** To be qualified for evaluation and finalization of contract, Bidder/ Bidders shall submit a written power of attorney, authorizing the signatory of the Bid to act on behalf of the Bidder in the form and manner which is acceptable by WBSEDCL.

**IB.17.3.** All the pages of the bid and where, entries/amendments have been made, shall be signed by the person/persons signing the bid.

**IB.17.4.** The complete bid shall be without alterations, interlineations or erasers, except those to accord with instructions issued by WBSEDCL or as necessary to correct errors made by the bidders, in which case such corrections shall be initialled by the person/persons signing the bid. Bids not duly signed shall be treated as cancelled.

**IB.18. Submission of Bid:** Bids shall be submitted as under:

**IB.18.1. General process of submission:** Tenders are to be submitted online through the website ([www.wbtenders.gov.in](http://www.wbtenders.gov.in)). All the documents uploaded by the Tender Inviting Authority form an integral part of the contract. Tenderers are required to upload all the tender documents along with the other documents, as asked for, in the tender, through the above website within the stipulated date and time as given in the Tender. Tenders are to be submitted in two folders - one is Technical Proposal and the other is Financial Proposal. Documents for Technical Proposal are to be submitted at pre-defined folders. Price bid under financial proposal is to be submitted at pre-defined folder named: BOQ.

The tenderer shall carefully go through the documents and prepare the required documents and upload the scanned documents in Portable Document Format (PDF) to the portal in the designated locations of Technical Bid.

The bidder needs to download the Forms / Annexures/ BOQ, fill up the particulars in the designated Cell and upload the same in the designated location of Technical folder / Financial folder. The documents uploaded shall be virus scanned and digitally signed using the Digital Signature Certificate (DSC). Tenderers should take note of all the addendum/corrigendum related to the tender and upload the latest documents as part of the tender. Original copies of the uploaded documents may be submitted for physical verification if required by the Tender Inviting Authority at the time of technical evaluation.

**IB.18.2. Part 1: Techno Commercial Proposal:** The Techno Commercial Proposal shall contain scanned copies and/or declarations in the following standardized formats in two covers (folders).

**IB.18.3. Part 2: Financial Proposal (Price Bid):**

**A. Bill of Quantities (BoQ):** The bidder shall quote the rate in the space marked for quoting rate in the Price Bid Sheet of the downloaded BOQ file.

\*Any deviation in the format, content (Other than entry of the quoted price at the desired blank spaces) of the Price bid/BOQ will render the tender liable to be summarily rejected.

**IB.19. Submission of original copies of documents of Earnest Money Deposit:**

**IB.19.1. Mode of Payment:** In case the EMD is submitted in the form of Bank Guarantee (BG) of any scheduled Bank under the jurisdiction of Reserve Bank of India, the original copies of such BG towards EMD shall be submitted in a sealed envelope in the office as stated below within the date and time as specified in the NIT. If the bidder fails to submit the original copies within the due date and time his tender will not be opened and his bid will stand rejected.

**IB.20.** No price preference will be allowed to any tenderer based on the size of the industry or its geographic location. Co-operative Society will not be considered with separate status.

**IB.21. Late Submission of Bid:** Bidder shall take all possible measures to submit the bid within the schedule date & time at specified location prescribed elsewhere in the bidding document. Late submission of bid for whatever reason shall not be accepted.

**IB.22. Opening and evaluation of tender:**

**IB.22.1. Opening of technical proposal:**

- IB.22.1.1.** Technical proposals will be opened by the Tender Inviting Authority or his authorized representative electronically from the website stated above, using their Digital Signature Certificate.
- IB.22.1.2.** Technical proposals for those tender whose original copies of BG or online payment confirmation towards EMD have been received with power of attorney will only be opened. Proposals corresponding to which the confirmation towards EMD from the respective bank has not been received, will not be opened and will stand rejected.
- IB.22.1.3.** All bids found to be responsive as per above mentioned clause will be examined in respect of "Mandatory Requirements" & other qualifying requirements as detailed in the bid document. Bids which do not satisfy the "Mandatory Requirements" and qualifying requirements will not be considered for technical evaluation.
- IB.22.1.4.** The bidder shall not submit any commercial deviation from the stipulation of Bid document. If the bidder submits any commercial deviation, his Bid may be liable for rejection.
- IB.22.1.5.** Techno-commercial Deviations, if any, must be brought out in the specified Deviation Schedule (Annexure-III). Techno-commercial deviations indicated elsewhere will not be considered in any circumstances. WBSEDCL during Techno Commercial Evaluation will examine these deviations. Negative deviations will not be accepted in any circumstances and shall be considered as non-responsive and shall be liable for rejection. When there is no deviation, this sheet is to be submitted with the offer duly signed with an endorsement indicating "No Deviation". Deviations not indicated here will not be taken into consideration.
- IB.22.1.6.** The summary list of bidders, whose bids will be found techno-commercially eligible, will be uploaded in the web portal. Date of opening of financial bid will be intimated to the techno-commercially qualified tenderers.

### **IB.22.2. Opening of financial proposal (price bids):**

- IB.22.2.1.** Financial proposals submitted by the tenderers in the prescribed format (**BOQ Format**) and declared techno-commercially eligible, will be opened electronically by the Tender Inviting Authority from the web portal stated above on the prescribed date.
- IB.22.2.2.** No deviation in any form in the price-bid sheet is acceptable.
- IB.22.2.3.** The encrypted copies will be decrypted and evaluated online.
- IB.22.2.4.** After opening of the financial proposal, the preliminary summary result containing inter-alia, name of bidders and the rates quoted by them will be uploaded.
- IB.22.2.5.** The Tender Accepting Authority may ask any of the tenderers to submit analysis to justify the rate quoted by that tenderer.
- IB.22.2.6.** For any discrepancy in the number of figures and words, the quoted amount in figure will prevail.

### **IB.22.3. Evaluation and Comparison of Bids (Price bids):**

- IB.22.3.1.** On examination of documents submitted under different covers WBSEDCL will evaluate and compare the bids determined to be substantially responsive at each step.
- IB.22.3.2.** Final evaluation by any bidder will be made as mentioned:
  - IB.22.3.2.1.** **Quoted basic as mentioned in the BOQ.**
- IB.22.3.3.** While evaluation, the Tender Inviting Authority or his authorized representative may summon of the bidders and seek clarification / information or additional documents or original hard copy of any of the documents already submitted and if these cannot be produced within the stipulated timeframe, their proposals will be liable for rejection.

**IB.23.** Conditional Rebate / Discount, if any, offered by any Bidder shall be outside the purview of commercial terms & conditions & shall not be considered during Bid evaluation.

**IB.24. Time Schedule:** The basic consideration and the essence of the Contract shall be the strict adherence to the time schedule specified in the bidding document and incorporated in the contract for execution of entire work. Date of signing of 'Contract Agreement' of LOA shall be considered as zero date. Successful bidder shall submit their installation plan after placement of LOA.

**IB.25.1.** Price offer shall be submitted in the prescribed format only.

**IB.25.2.** No deviation in any form in the Price Bid Sheet is acceptable.

#### **IB.26. Tax and Duties and other Levies:**

**IB.26.1.** The Bidder(s) shall be solely responsible for the taxes that may be levied on the Bidder(s) persons or on earnings of any of his employees and shall hold the employer indemnified and harmless against any claims that may be made against the Employer. The Employer does not take any responsibility whatsoever regarding taxes under "Income Tax Act, 1961" for the Contractor or his personnel. If it is obligatory under the provisions under the "Income Tax Act, 1961" deduction of Income Tax at source shall be made by the Employer.

**IB.26.2.** GST shall be admissible based on rule and rate in force and will be payable extra. Bidder should be registered under GST act.

**IB.27. Statutory Obligation:** Statutory obligations as per law of the land are to be complied.

**IB.28. Variation during execution:** The provisional quantities of various items are shown in the Price Schedules. WBSEDCL, during execution of the contract, reserves the right to increase or decrease the quantity with  $\pm 25\%$  (Twenty five percent) but without any change in unit price or other terms and conditions.

#### **IB.29. Issuance of LOA: Methodology of award of Contract: -**

**IB.29.1.** WBSEDCL will award the contract to the vendor whose bid has been determined to be substantially responsive and has been determined the lowest evaluated bid, provided further that the bidder is determined to be qualified to perform the contract satisfactorily. ### **IB.37. Conflict of Interest:**

## **SCOPE OF WORK (SW)**

### **SW.1. Scope of Work: The project shall be on a turnkey basis.**

Vehicle Tracking System (VTS) will have to be implemented as an end-to-end solution for approx. 1400 vehicles. The quantity is indicative only. It may increase/decrease up to twenty-five percent ( $\pm 25\%$ ) at the time of implementation.

### **SW.2. Key Features of Vehicle Tracking System:**

- SW.2.1.** To provide Vehicle Tracking System (VTS) and associated services to manage vehicle movement within the command area of WBSEDCL on open standard. The solution should be COST product. The project will be implemented on a turnkey basis.
- SW.2.2.** Installation, commissioning and testing of minimum IP-65 enabled VTS devices.
- SW.2.3.** Devices of a proven design and performance that have been tested under severe conditions similar to Indian environment/temperature/road conditions. The device specification as per Annexure-II with sufficient back-up of internal memory and battery. No external equipment will be attached to the LT and HT maintenance vehicles mentioned above.
- SW.2.4.** Quoted VMU device shall be updated and new generation device as per Annexure-II. In no cases old and used devices will be allowed.
- SW.2.5.** Providing hardware/software, servers etc. on cloud concept is required for smooth working of VTS.
- SW.2.6.** Integration of VTS with WBSEDCL existing CRM system.
- SW.2.7.** Providing web browser-based and mobile based application for VTS.
- SW.2.8.** The Geo positioning data is to be recorded and stored in a secure and dedicated Database within India.
- SW.2.9.** The successful bidder will be responsible for the purchase, installation, testing, integration of all components in the system and hosting of applications.
- SW.2.10.** The successful bidder will be negotiating for communication related issues with communication service provider/s in order to facilitate functional VTS based on Geo positioning data for maintaining maximum uptime of the system.
- SW.2.11.** The basic system will include geo referencing system, satellite technology, combined with wireless communications and software to deliver real-time digital maps, complete with vehicle locations and road maps.
- SW.2.12.** Installation of minimum IP65 devices for all the vehicles (Approx- 1400 vehicles initially which may increase or decrease  $\pm 25\%$ ). In case of malfunctioning of Device, the responsibility to replace it lies with successful bidder within stipulated Time Frame. This would be governed by SLAs defined in Annexure-XII. During the installation of device, the initial data of vehicle like Vehicle number, CCC name / Sub-station name other necessary data as per requirement of WBSEDCL to be collected by the successful bidder and create the initial database with the help of concerned person of respective WBSEDCL site offices. The successful bidder will be responsible for time to time update of the data if it is changed at site.
- SW.2.13.** Provide and customized software as per the following details:  
Provide Map Data of West Bengal on 1:5000 (cm) scales with the following details as selectable layers with their names superimposed (on selection);
  - A. Geographical Boundaries:**
    - I) State, II) District, III) Sub- Division IV) Block, V) Village- Panchayat
    - May have to update the boundaries if new administrative entities are created by the government.

## **B. Name as point data of the**

I) Administrative headquarter

II) Roads with their names on mouse over- Roads including National Highways, State Highways, Major District roads, village roads and other roads need to be displayed on the map.

- SW.2.14.** The Map requires customizing to make it be geo-fencing on the jurisdiction of WBSEDCL with the help of Station Managers for CCC (LT Van) and Divisional Managers for Division (HT Van) respectively.
- SW.2.15.** Customize the Map to provide physical route mapping with important landmarks like hospital, school, petrol pumps etc.
- SW.2.16.** Real time report of the movement of the vehicle on the map to the users based on their privileges. The successful bidder will be required to maintain a dynamic reporting system (updating frequency must be equal to 15 seconds) where concerned users will be allowed to create their reports based on the available data base. The successful bidder is also expected to provide customized MIS report as per requirements that are shared at any stage by WBSEDCL.
- SW.2.17.** Non-editable database level access shall have to be given to WBSEDCL for generation of any instantaneous reports as and when required by the Authority of WBSEDCL.
- SW.2.18.** Create user management system on the software with rights and privileges as defined by the WBSEDCL. Application software is required to be common for all the users and has option for customization & allows for changes as and when required without any extra charges. Initial user and its database creation are the task where successful bidder is required collecting all user related data from site office of WBSEDCL and creating the initial database with the help of site officers.
- SW.2.19.** Day wise exceptional reports like distance travelled by any Mobile Van on a day, count of call closed and count of call opened etc. will be sent to Divisional Manager of Respective Division through auto generated email at the end of the day.
- SW.2.20.** Monthly utilization report of each vehicle will be sent to the Divisional Managers, Regional Managers and Zonal Manager of the respective Divisions, Regions & Zones respectively through auto generated email at the end of the month.
- SW.2.21.** Portal view option will remain live for at least six months after end of the Contract. In this period WBSEDCL can view the previous records stored in the database.
- SW.2.22.** Consolidated data must be stored for generation of Utilization report of all Mobile Van at any point of time up to six months from the end of contract.
- SW.2.23.** Providing access to the VTS for about 3000 users through both web and mobile application. For a particular user if he/she is entitled as per decision of WBSEDCL to have user id both in Desktop and Mobile application then the id and credential should be same but there should be provision to log and monitor his/her activities distinctly by each session and devices.
- SW.2.24. SMS Alerts:**
- SW.2.24.1.** SMS alerts to specific numbers when the vehicle leaves their jurisdiction i.e. Geo-fencing alert. — Divisional Managers of concerned Divisions & Station Managers of concerned CCCs.
- SW.2.24.2.** SMS alert when the Geo Positioning unit was cut off from the vehicle battery or Geo Positioning supported device is stop working by any means ---- Site officers of the concerned site and Divisional Manager of the concerned Division.

- SW.2.24.3.** All type of SMS alert should be centrally configurable as and when required of WBSEDCL with provision of activation and deactivation.
- SW.2.25.** All of the above is in addition to the real time Geo Positioning data on daily basis display of the location, direction, speed, distance travelled etc. of the vehicle and a 365 days history of the tracking path from desktop application.
- SW.2.26.** In case of damage to the Geo Positioning device already installed, the successful bidder shall have to submit a report within 72 hours of its status and activity towards replacement of the same. The vehicle which are on duty and not connected to Web server GPRS for more than hour should be contacted by successful bidder and reason need to be identified, reported and appropriate action need to be taken by the successful bidder. The importance of this provision is that the tamper proofing should be sufficiently strong and should not allow the vehicle owner to transgress. In case the vehicle owner forces his way to the device then it should become evident from the breach or tampering of the device.
- SW.2.27.** The successful bidder shall be responsible for updation (if required) of all Software and Hardware for successful operation of the project during the contract period.
- SW.2.28.** The Geo Positioning receiver shall have in-built battery support for minimum 8 hours with internal rechargeable battery, capable of charging from the vehicle power.
- SW.2.29.** The required maps (Google maps/Digital maps/Customized maps licenses) have to be provided by the successful bidder at their own cost and the map data required to be updated quarterly.
- SW.2.30.** The successful bidder should provide the required number of servers and different types of servers which should be suitable to operate the system and run the applications of VTS to take care of approx. 1400 units and additional vehicles in future. In addition, the successful bidder shall implement their custom-built application software for tracking of vehicles, with suitable high-quality maps etc.

- SW.2.32.** The server should be capable to fulfill entire functionality as per the scope for approx. 1500 Vehicles for 5 years.
- SW.2.33.** The VTS server required to receive Customers complaint details viz docket number, consumers detail, consumer location (latitude, longitude), jurisdiction of CCC, division, status. The VTS system needs to plot it on Map at its actual location with some graphical symbol. The details will be shown while mouse hovering on it and there should be provision for display it in details tabular forms. If no latitude and longitude is included in the details of docket received from WBSEDCL existing CRM server then there should the scope to display it as tabular form to appropriate user as per jurisdiction of CCC and or division.

- SW.2.34.** Integration of VTS with WBSEDCL existing IT/OT system as per following manner:
- SW.2.34.0.** Predefined data will be sent at least in 15 minutes interval in PUSH Mode from WBSEDCL system to VTS server using web service technology as REST over HTTPS protocol with JSON data format. Details format of data will be shared at the time of implementation.
  - SW.2.34.1.** Two nos. of APIs will be developed by the vendor for incremental data receive. One API will be used to consume the consumer details of the open docket. Another API will consume only closed docket number. However, scope should be open for consuming additional attribute details in future, if any.
  - SW.2.34.2.** The attributes of the call details will contain the relevant fields like: CUSTOMER Care Centre Code, Consumer Id, Consumer Name, Address, Docket Number, Docket description, problem type, Latitude, Longitude, Docket Creation Date, Docket Status so as to make the consumer details identifiable on hierarchical basis.
  - SW.2.34.3.** The VTS system needs to plot it on Map at its actual location with some graphical symbol. The details will be shown mouse hovering on it and there should be provision for display it in details tabular forms. If no latitude and longitude is included in the details of docket received from WBSEDCL existing CRM server, then there should be scope to display it as tabular form to appropriate user as per jurisdiction of CCC and or division.
  - SW.2.34.4.** Whenever any docket is closed or status is changed the information is required to be received from CRM server to VTS server and the VTS application should instantly remove the close docket from the graphical display from Map and update the details tabular display of docket status.
  - SW.2.34.5.** The communication with CRM system of WBSEDCL will be restricted, limited and view only with VTS system.
  - SW.2.34.6.** The VTS system will require accessing the CRM data of docket from the WBSEDCL server in PUSH mode.
  - SW.2.34.7.** Open docket data from CRM server are required to PUSH to the VTS server in some predefined format with necessary encryption instantaneously as per existing hardware, software and network security measurement of WBSEDCL. VTS system should have to develop required application to pull these data.
  - SW.2.34.8.** The vendor also has to provide APIs to WBSEDCL for fetching all geometric and attribute data of all vehicles. The data should be refreshed after each 15 second interval.
  - SW.2.34.9.** Data of existing VTS system of WBSEDCL (like geofence, vehicle number, administrative hierarchy of WBSEDCL) need to be migrated in proposed VTS system.
- SW.2.35.** The Successful bidder will assign a Project Manager who will provide the management interface facility and has the responsibility for managing the complete service delivery during the contractual arrangement.

- SW.2.36.** Project Manager will provide strategic and tactical recommendations in relation to technology related issues. He / She will identify and resolve problems and issues together with WBSEDCL.
- SW.2.37.** Successful bidder requires providing system generated quarterly VTS "UPTIME REPORTS" for payments and also the same "UPTIME REPORTS" shall be visible in daily basis through portal.
- SW.2.38.** Whenever the Vehicles will be changed at the sites the successful bidder require to dismantle the VTS devices with all its accessories and install the same in the new vehicles mentioned by WBSEDCL without any extra cost on a mutually fix date but within 72 hours from information of such change from WBSEDCL. During this process if damage or loss occurs either or on both vehicles and the VTS devices itself, then the successful bidder required to compensate all of such losses at par actual. Beside if any cable, power cord, consumable required during the change of vehicles then the cost also need to borne by the successful bidder. The successful bidder also requires building and modifying the database and other information for these new vehicles without any additional cost.
- SW.2.39.** The application software should have following features:  
 (i) Connectivity: Other Systems.  
 (ii) Browser: Windows 10 or higher, Log of all administrative actions as well as all user logins shall also be maintained.  
 (iii) Graphics: (a) User Friendly GUI  
 (b) Position on the digitized map  
 (c) Animated Icons in different colors to represent Vehicles and docket location.  
 (d) Display Vehicle Registration. No. and other details on mouse over the vehicle icon.  
 (iv) Zoom: Minimum three level of zoom.  
 (v) Reports: Customized as per WBSEDCL requirement. Graphical representation/pie-chart will be given in the dashboard.
- Note: Only minimum requirements are given above.
- SW.2.40.** Installation and Commissioning of the equipment as per quantity mentioned in price bid sheet (BOQ) and as per standards and protocol specified in techno-commercial bid sheet in ANNEXURE -II.

### **SW.3. Facility Management Service (FMS):**

- SW.3.1.** The successful bidder shall be required to provide the services so as to manage entire VTS system including all equipment installed by them, including hardware, software & networks and related modules installed & commissioned by the successful bidder for the utility in order that they have maximum availability to enable utility to realize its desired objectives.
- SW.3.2.** Facility Management Services by deploying one (1) person with suitable accessories like laptop, mobile etc. shall be provided by successful bidder in order that maximum uptime & performance levels of VTS systems installed is ensured. In absence of deputed FMS personal, suitable substitute to be deployed.

- SW.3.3.** To achieve the desired Service, the person deployed by successful bidder at Vidyut Bhavan (HQ) may need to proactively interact, coordinate and collaborate with the other Service Providers as well as site offices of WBSEDCL as required. He/she will act as the Single Point of Contact (SPOC) for all issues relating to the Service Levels. The role of FMS shall be started next day after final work completion of the project.
- SW.3.4.** The successful bidder shall be responsible for management of all the systems as per scope of work with services rendered as per Contract agreement between WBSEDCL & successful bidder.
- SW.4. Operational Training:** Necessary operational training of software for at least two persons of each location to be provided by the successful bidder. The successful bidder shall be responsible for effectively providing training to the various stake holders owing operations. Training needs to be conducted based on a requisite mix of theory & practical operational sessions. The trainings should be conducted in Bengali and English language.
- SW.5. Commissioning Certificate:** Successful bidder shall complete installation & commissioning of all equipment with creating the initial database of user management console and front-end application (Desktop & Mobile Apps) with successful trial-run after adequate training. The concerned Site Officer for all site offices shall sign "Commissioning Certificate" only after successful completion of above-mentioned job as per the format for Commissioning Certificate is available in Annexure-XIV. If any alteration / modification shall be required on the system generated uptime report to incorporate the device failure due to the external reason as describe in sl. no. 7 as per Annexure- XII supporting document shall be submitted.
- After analysis of the above-mentioned report successfully, the Controlling Officer shall be issued 'Up-time Certificate' as per Annexure- XV.
- SW.7.** 2% device of total quantity under vehicle tracking project will be replaced by successful bidder free of cost if any damage/stolen of devices will occur during the entire period of contract.

## **General Conditions of Contract [GCC]**

### **GCC.1. General Terms:**

- GCC.1.1.** For timely completion of the project, WBSEDCL reserves the right to divide/split/modify/cancel the entire work during placement of order without showing any reason whatsoever.

- GCC.1.3.** The bidder has to furnish all the information as required regarding their offer.
- GCC.1.4.** Quotation from any sub-vendor(s) will not be entertained.
- GCC.1.5.** Any form of joint-venture (JV) will not be entertained.
- GCC.1.6.** The bidder shall satisfy WBSEDCL with his ability to complete the works positively within the stipulated time.
- GCC.1.7.** Bidders are encouraged to make the maximum use of human resources available locally in West Bengal, provided that these meet the technical requirement as specified.
- GCC.1.8.** The Company reserves the right, to reject any or all the tenders, at its discretion, without assigning any reason whatsoever.
- GCC.1.9.** WBSEDCL reserves the right to review the bidder's capability and capacity to perform the work before awarding the Contract.

**GCC.9. Contract Value:** The contract value of the project will be the total amount for the entire period of contract as price schedule sheet (BoQ). (Excluding Tax and Duties).

## **GCC.10. Performance Guarantee:**

**GCC.10.1.** As Contract Guarantee, the successful bidder has to furnish a Performance Guarantee in the form of Bank Guarantee on non-judicial stamp paper of Rs 100 amounting to 3% (Three) of the value of the order (subject to further variation of PBG rate as per the Govt. circular in future) from any Indian Scheduled Bank as per proforma enclosed (**Annexure IX**), to guarantee faithful execution of the order in accordance with the terms and conditions stipulated in both the orders.

**GCC.10.2.** Additional security of 10% of the quoted price may be submitted by the bidder, in case the offer rate is abnormally lower than the estimated cost, as per the proforma enclosed (**Annexure X**).

**GCC.10.3.** The Performance Guarantee shall be submitted to the CE, IT&C Cell, 3rd Floor, 'D' Block, Vidyut Bhawan, WBSEDCL

**GCC.10.4.** The Performance Guarantee shall cover the satisfactory performance of the entire project periods. For any failure towards satisfactory performance on the part of the Bidder(s), the Bank Guarantee will be liable to encashment and forfeiture.

**GCC.10.5.** Performance Guarantee furnished in any other form will not be accepted.

**GCC.10.6.** Performance Guarantee will not carry any interest.

**GCC.10.7.** The above Performance Guarantee is to be submitted within thirty (30) days from the date of issue of the order and shall remain valid up to 6 years with claim period of another 3 (three) months from the date of placement of LOA.

In case the contract is renewed, the successful bidder has to extend the validity of the Performance Bank Guarantee till the end of the renewed contract period with a validity of 6 months days beyond the end of the renewed contract period.

**GCC.12. Cancellation/Termination of Order:** WBSEDCL reserves the right to terminate the contract either in part or in full due to reasons of non-Compliance of stipulated activities laid down in different clauses under this contract, also have the right to invoke and appropriate the entire amount of Bank Guarantee without citing any cause thereof. The following causes may also lead to cancellation of LOA.

- GCC.12.1.** The successful bidder fails to submit written unconditional acceptance of order within 15 (Fifteen) days from the date of issuance of the order.
- GCC.12.2.** The successful bidder fails to sign Contract Agreement within 30 (thirty) days from the date of issuance of the order.
- GCC.12.3.** If the successful bidder fails to submit the Performance Bank Guarantee as per stipulated format, with requisite validity and within the specified time period with 30 (thirty) days from the date of issuance of the order.
- GCC.12.4.** If the successful bidder fails to implement the project successfully in all respect.
- GCC.12.5.** If the successful bidder fails to replace the products and if the specification is found to be mismatched with quoted specification within the stipulated time frame.
- GCC.12.6.** If the successful bidder fails to replace the parts/ devices along with the software within the stipulated time frame.

**GCC.13. In brief, strict confidentiality shall be maintained with respect to the contents of the data to be handled by the vendor and, any violation of this confidentiality clause may be treated as breach of trust and would lead to any or all of the penal actions as detailed below:

1. Instant termination of the contract

**GCC.18.3.** The necessary legal affairs and / or court case shall be exclusively within the jurisdiction of Calcutta High Court or any subordinate court having competent jurisdiction at Kolkata only.

**GCC.19. Limitation of liability:** Except in cases of gross negligence or willful misconduct:

**GCC.21. **GCC.22. - (iv) "Up-time Certificate" (Annexure XV) certified by the Controlling Officer after satisfactory submission of system generated uptime report for all the VTS enable vehicles under the jurisdiction of WBSEDCL as per SLA (Annexure XII) is required to be submitted on quarterly basis after end of each quarter.

**GCC.24. Terms of Payment:**

## **ANNEXURE-XII**

### **Service Level Agreement (SLA)**

'Uptime' formula is based on data packet received from the VTS devices. The 'Uptime' calculation shall take into consideration the following cases:

- (a) The specific period vehicles are under maintenance.
- (b) The specific period for device de-installation & re-installation as required by WBSEDCL.
- (c) The specific period for VTS device theft from Vehicles or accident of the Vehicles.
- (d) Damage caused by force of nature, external causes, or act of any third party.

For all the above, confirmation shall be required from site-offices either through letter or E-mail for consideration of data packets for uptime calculations.

The successful bidder shall provide a quarterly system generated report on VTS Uptime computation based on definition provided in the tender document i.e. for all VTS devices installed. Any issues related to the performance of the VTS devices shall be rectified within the quarter by the bidder.

The quarterly uptime details will be made available electronically to WBSEDCL on daily basis. WBSEDCL may audit or have audited the successful bidder's uptime calculation, at their cost.

#### **CALCULATION OF QUARTERLY UPTIME OF VTS DEVICES:**

The definition and calculation of 'VTS Uptime' is given below:

1. Definition - The 'Uptime' is defined as availability of " data packet" at a given period of time.
2. Uptime of devices shall be calculated by the formula "X/Y" given below:
  - (i) 'X' is the actual number of data packets received from each device quarterly.
  - (ii) 'Y' is the total number of data packets to be received from each devices at an interval of Max. 15 Sec, quarterly.
3. Following Data is considered for calculating the uptime:
  - i. Data sampling & uptime will be done at an interval of 15 sec.
  - ii. Data refreshment is done automatically at maximum interval of 15 sec.
5. The total number of data packets during a quarter is calculated based on the number of data packets which should be ideally generated considering data updation at an interval of 15 second i.e. (4 x 60 min x 24 hrs. x 90 days).
6. Exclusions for calculation of 'X' –
  - (a) Damage of the VTS device due to WBSEDCL's fault (to be proved by the successful bidder as per point no 8 below) will not be considered as successful bidder's liability and hence credit will be given to the successful bidder for the same.

(b) Other causes like vehicles meeting with accidents, Police cases, Suspension/Blacklisting, will not be considered as vendor's liability.

**7. Administration of finalizing the percentage visibility:** Vehicle Tracking System to have online module for certifying the cause of visibility loss. If a vehicle is not visible in spite of being on job-operation on any given day, the Site In-Charges of respective WBSEDCL sites will be required to certify the following causes –

- (a) Accidents if any
- (b) Police case / seizure
- (c) Other unfair means.

8. Implications of clause 6 & 7 above:

(a) In case 7(a), 7(b) & 7(c) is chosen, the successful bidder will be given full credit for the day & further till the day vehicle again serviceable.

(b) For cases of Device missing or damaged, successful bidder will not be given credit unless he conclusively proves the same within 7 working days. In this case, onus will be on successful bidder to prove the same.

(f) Damaged or missing device as per sl. no. 7, will have to re-install by the vender within 15 working days of the incident.

For all the above mentioned reason a confirmation shall be required from site-offices either through letter or E-mail.

9. A call must be logged by the site officers against the case of damage / non-working of VTS device.

10. Example for calculation of VTS uptime for particular device -

For a duration of 24 hrs.(1 day)

Data updation interval – 15 sec.

Say, Actual no of prompts received – 5000.

No of prompts to be received =  $24 \times 60 \times 60 / 15 = 5760$

Uptime =  $5000 / 5760 = 86.81\%$

11. A report will be generated based on the above formula and after the absorption of the losses of data due to the above-mentioned causes and will be called the "**UPTIME REPORT**".

12. The **overall uptime** calculation will be the weighted summation on the total number of vehicles based on the "UPTIME REPORT".

13. The **overall downtime** is "**100 – overall uptime**".

14. Amount deduction due to downtime greater than 1%.


