**Scope:** - The scope of work in brief shall include Supply, loading at factory, transportation of LT Distribution Kiosk for 63KVA Transformer (SMC/FRP) Structure to Midnapore Divisional store, unloading at Midnapore Divisional store including guaranteed obligation of complete supply of materials in conformity to the technical specification enclosed herewith, for ongoing Maintenance work safety, SI Work and Govt. Connection of LT network under Midnapore Division, WBSEDCL.

N.B. : Authorized Dealership certificate of the original manufacturers of the items shall be allowed to participate in the tender on request of the manufacturer. Or relevant ISI Standard as maintained in make Syntex/Macedon will be allowed with authorized Dealership Certificate. WBSEDCL may consider placement of order on the dealer on behalf of the said manufacturer and/or they may be allowed to receive payment, on behalf of the co., provided that all responsibilities & warranties, as per terms of the tender specification

1. Intending Bidders shall login to the e-Procurement portal of Government of west Bengal <https://wbtenenders.gov.in> using his login Id and password
2. Earnest Money Deposit (EMD) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority.
3. E-tender portal is maintained by NIC and payment gateway facility available in e-tender portal is maintained by ICICI Bank.
4. Facility for collecting EMD via offline mode has been discontinued in e-tender portal as per order.
5. As per the procedure defined for online collection in e-tender process, EMD amount



deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). 8. Successful bidder (s) shall have to create vendor id through WBSEDCL web portal vendor corner, if not created earlier.

19. ### **27.1 Technical :**

The bidder must have successfully completed construction of similar nature of work having contract value not less than 50% of the estimated cost in a single contract during last five years for sl. no.1 in a single order. All the required License and enlistment must be produced for such kind of Works.

### **27.2 Commercial & Financial :**

**27.2.1** The average annual turnover of the bidder for best two years out of the financial years 2021-22 , 2022-23 , 2023-24 shall be minimum 20( Twenty) lakhs for sl.no.1, (Annexure-I).

**27.2.2** The working capital and credit facility taken together either for 2020-21 , 2021-22, 2022-23, 2023-24 shall be minimum 40 Lakhs (Financial Capability proof certificate from bankers, one year from date of Publication of NIT).

Technical Specification of 'LT Distribution Box For 63KVA DTR With Double Feeder Conception System' suitable for installation on pole mounted DTR Sub-Station structure for safeguard & protection of DTR LT Side in the existing or new DTR's pole mounted structure.

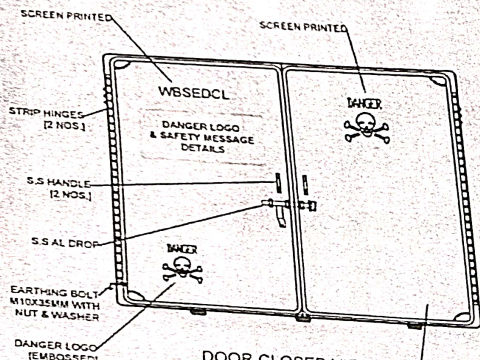
## Scope: -

The LT Distribution Box For 63KVA/100KVA DTR Within Double Feeder/Panel will be used for safeguard & protection of DTR LT Side Fuse Unit system with DTR's pole mounted structure.

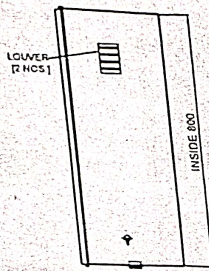
## Detailed Specification –

1. The Inside Dimension of LT Distribution Box for distribution sub-station should be of size: H-800mm X W-1000mm X D-300mm & made of Sheet Molding Compound (SMC) by the process of Hot Press Compression Molding Confirming to IS: 13410-1992; Grade - S3 & IS: 14772-2020. The Box shall be Double Door type as per enclosed drawing.
2. The Thickness of Overall SMC LT Distribution Box should be 2.5mm (min).
3. No Negative tolerance on Size & Thickness is admissible.
4. The SMC Base Door should not be softened or bend on heating.
5. Door Should be fitted to base by Stainless Steel (SS) concealed type continuous hinge.
6. The Incoming Phase Bus Bars will be 3 Nos. & shall be of size 240mm x 40mm x 10 mm as shown. The Outgoing Phase Bus Bars are to be fitted in stepped manner for double feeder conception as mentioned in the "Door Open View & Side View" of the enclosed drawing. The above arrangements shall be paced upon a 4mm SMC Sheet. Please refer the Drawing for details.
7. Also, there should be fitted a common Aluminum Neutral Busbar (240mmX25mmX6mm) as per Drawing.
8. Sufficient Hole of standard diameter to be provided for incoming & outgoing feeder cable as per Drawing.
9. Sufficient Ventilation system to be provided as per drawing.
10. Logo of WBSEDCL, Danger & Safety Message as per drawing enclosed to be provided in the front of the Distribution box.
11. Detailed GA Drawing is enclosed and parameters to be adhered to.

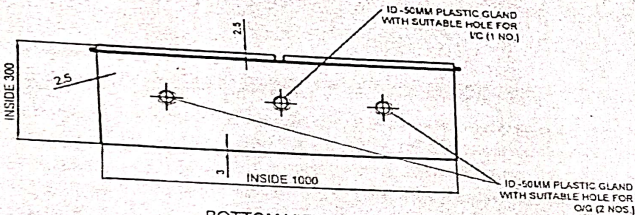




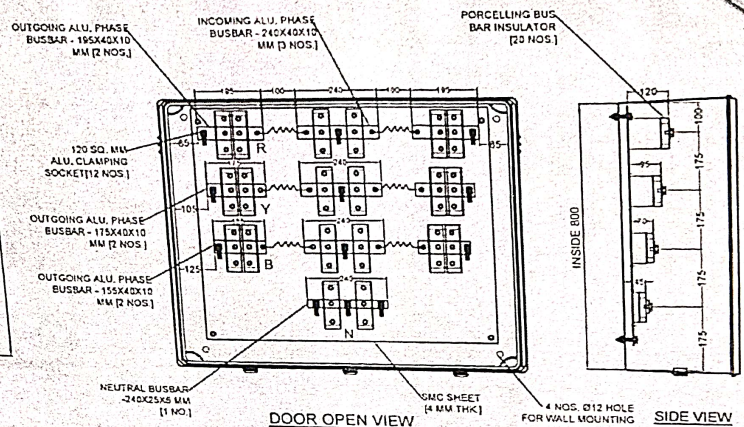
DOOR CLOSED VIEW
