Terms & conditions of the Tender Notice:

- 1. Intending eligible bidders desirous of participating in the tender will have to be enrolled and registered with the Government of West Bengal e-Procurement System and may download the tender document from the website https://wbtenders.gov.in directly with the help of Digital Signature Certificate (DSC). The tender can be searched by typing WBSEDCL in the search engine provided in the above mentioned website.
- 2. Bidders willing to take part in the process of e- tendering are required to obtain Class-II or Class-III Digital Signature Certificate (DSC) in the name of person who will sign the tender, from any authorized Certifying

Authority (CA) under the Controller of Certification Agencies (CCA), Govt. of India. The bidders are required to register the fact of possessing the Digital Signature Certificates through the Registration System available in the website. Tenders shall be submitted online and intending bidders should download the tender documents from the website stated above, directly with the help of the DSC. This is the only mode of collection of tender documents. Details of submission procedure are given in 'Clause No.-10' of Instructions to Bidders (ITB)'.

- 3. Earnest Money Deposit shall be submitted through online mode through the e-Tendering portal (https://wbtenders.gov.in). All offline submission of payment instruments like Bank Draft, Pay Order etc. have been stopped for e-tender procurement. In case of unsuccessful/rejected bids, the EMD shall be refunded directly from the e-Tendering portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms. Further details in respect of online payment as well as refund of EMD are provided within the EMD clause (Section-II, Instruction to Bidders, Clause No. 14).
- 4. Technical Bid and Financial Bid are to be submitted online through the website https://wbtenders.gov.in with the help of the Digital Signature Certificate within the stipulated date and time.
- 5. The Financial Proposal of the prospective bidder will be considered only if the Technical Proposal of the bidder is found qualified by the Tender Inviting Authority. The decision of the Tender Inviting Authority will be final & binding on all concerned and no challenge against such decision will be entertained. The list of Techno-commercially qualified Bidders along with the ones whose bids are rejected will be displayed on the website.
- 6. Eligibility criteria of the Bidder for participation in the tender:
 - The bidders having credential for supply & delivery of any type of electrical equipment /gadget to Power /Process Utilities / Govt. Departments/Other reputed company on earlier occasions within last five financial years will only be eligible in the tender. In addition, they should fulfill the technical criteria & financial criteria as required under technical / financial credential clause.
 - ii) The bidder shall have the capability of execution of single order amounting 30% of estimated value (i.e. **1.60 lakh**) in last five (5) years.
 - iii) The bidder shall have average annual turnover amounting to 30% of estimated value (i.e 1.60 lakh) for the last three (3) financial years & Working capital of Rs. 1.15 Lakh.
 - iv) No consortium/ joint venture (JV) will be allowed.

- 7. Bids shall remain valid for a period not less than 180 (One hundred eighty) days from the date of opening of Price Bid. If the bidder withdraws the bid before the period of bid validity, the earnest money deposited by him will be forfeited forthwith without assigning any reason thereof.
