SECTION – II INVITATION OF BID

1. SCOPE OF WORK:-

- a) Construction of One no. Bay at Jalangi 33/11 KV S/S for Jalangi-Sagarpara 33KV LILO Source.
- b) Construction of 02 nos. Bay along with all the required support structure and Equipment installation at Proposed Sagarpara 33/11KV S/S (As per attached BOQ).
- c) Laying of 33KV XLPE Cable along with all the necessary arrangement (As per attached BOQ).
- d) Laying of 11 KV XLPE Cable and Installation 11KV Switch gear (As per attached BOQ).
- e) Mat Earthing.
- f) Installation of 11KV Isolator at Switch yard and others related works as per attached BOQ.

2. 2.1. TECHNICAL ELIGIBILITY CRITERIA OF THE BIDDER

Part I: Electrical Work of 33/11 KV Sub-Station: -

All categories of intending Bidders, who have satisfactorily completed having experience of electrical work related to construction/augmentation of 33 KV/11 KV voltage class or higher voltage capacity Sub-Station and 33 KV UG Cable laying work in last 7 years (date of completion of work should be on or after 07.02.2018)

2.2. FINANCIAL ELIGIBILITY CRITERIA OF THE BIDDER

a) Three similar completed works of executed value of each not less than the amount equal to 40% of the estimated cost i.e. Rs. 30,58,518.00.

Or

b) Two similar completed works of executed value of each not less than the amount equal to 50% of the estimated cost i.e. Rs. 38,23,147.50.

- c) One similar completed work of executed value not less than the amount equal to 80% of the estimated cost i.e. Rs. 61,17,036.00.
- N.B.: Completion Certificates indicating Name of the Work, Ordered Amount, Executed Amount, Date of commencement and completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer/Assistant Engineer or equivalent rank and above will be treated as valid credential. Also uploading of copy of work order and schedule of work as supporting documents of completion certificate is mandatory.

2.3. COMMERCIAL ELIGIBILITY CRITERIA OF THE BIDDER

- a) Average annual turnover during last three financial years (i.e. 2021-22, 2022-2023 and 2023-24) shall not be less the 30% of the estimated cost i.e. Rs. 22,93,888.50.00 (CA certified copy is to be enclosed).
- b) Working capital in the year, proceeding the year of bid submission (i.e. in financial year 2023-24) shall not be less than 30% of the estimated cost i.e. Rs. 22,93,888.50.00 (CA certified copy is to be enclosed).
- c) In case documents certifying credit facility from a scheduled Bank is submitted, the requirement given in clause no (b) shall be judged by adding available credit facility and working capital taken together.
- d) Annual audited Financial Report for last three financial years (i.e. 2021-22, 2022-23 and 2023-24) to be submitted for verification in respect of bidders for whom audit of account is mandatory. For those whose audit of accounts is not mandatory they shall submit copy of IT returns along with related enclosures (Form 3CA/3CB and particulars are reported in the Form 3CD u/s 44AB of Income Tax Act'1961) for last five financial years (i.e. 2019-20, 2020-21, 2021-22, 2022-23 and 2023-24).
- **Necessary documentary evidence as detailed herein above shall have to be uploaded by the bidder to ascertain the commercial eligibility criteria.

3. OTHER STATUTORY REQUIREMENTS: -

The Bidder shall furnish the following documents

- a. EPF registration certificate with paid challan for the month of December 2024.
- b. I.T. Return for last three financial years (i.e. 2021-22, 2022-23 and 2023-24) and PAN Card.

- c. Professional Tax Certificate with payment challan for FY 2024-25.
- d. ESI Registration Certificate and Challan for the month of December 2024.
- e. Trade License in respect of the prospective Bidder, Proprietorship Firm (Valid Trade License), Partnership Firm (Partnership Deed, Valid Trade License and Power of Attorney), Pvt. Ltd.& Ltd Company (Incorporation certificate i.e. MOA and AOA, Valid Trade License and Power of Attorney), Relevant board resolution may be submitted in case of Pvt. Ltd. and Ltd Companies and Co-operative Society (Society Registration Copy, Valid Trade License, Current Year No Objection Certificate issued by the Assistant Register of Co-Op(S)(ARCS), Valid bye laws and Power of Attorney).

N.B: Any MOU/Temporary Agreement/Joint Ventures/Consortium/ any other arrangement to constitute an Entity having no statutory Registration Certificates (Non-Permanent Establishment) beyond the above-mentioned entities for the purpose of applying as prospective bidder will not be considered as valid document.

- f. GST Registration No. Certificate and GST return form 3B for the month of December 2024.
- g. Performance as prime contractor for execution of similar nature of work for last **7(Seven)** years.
- h. Information regarding any **past and current litigation** with WBSETCL /Govt. / PSU in which the bidder is involved the party's concerned and disputed amount.
- i. List of Machinery and key personnel.
- j. Self-attested copy of Electrical Contractor's License with validity in the name of bidder.
- k. Self-attested copy of Electrical Supervisor's Certificate of competency issued by the Licensing Board, Government of West Bengal/India (Current engagement of Electrical Supervisor at prospective bidder's firm needs to be established through notary attested contract agreement on Non-Judicial Stamp Paper).
- 4. Bidders willing to take part in the process of e-tendering are required to obtain Digital Signature Certificate (DSC) in the name of person who will sign the tender, from any authorized Certifying Authority (CA) under CCA, Govt of India (viz. nCode Solution, Safescrypt, e-Mudhra). DSC is given as a USB e-Token. After obtaining the Digital Signature Certificate (DSC) from the approved Certifying Authority they are required to register the fact of possessing the Digital Signature Certificates through the registration system available in the website.
- 5. The prospective Bidders or any of their constituent partners shall neither have **abandoned or rescission** any work nor any of their contract has been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders)
- WBSEDCL reserves its right to take decision keeping its financial interest. The provisions of Purchase Policy of WBSEDCL with subsequent amendment will be applicable.
- 7. If the offer is submitted without or inadequate Earnest Money, the bid will not be opened. In case of incomplete offer, the tender will be liable for rejection and Earnest Money Deposit will be forfeited.
- 8. The offer against tender should remain valid for a minimum period of 180 days from the date of *submission* of the Price bid or Revised Price bid if any. However, WBSEDCL may, on the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
- 9. Any evidence of unfair Trade Practices including over charging, price fixing, cartel etc. as defined in various statutes, will automatically disqualify the bidders.
- 10. WBSEDCL is not bound to accept the lowest tender and reserves the right to cancel any or all the tenders unilaterally.
- 11. Any bidder against whom **FIR/Complaint** is lodged with Police by WBSEDCL shall not be eligible to participate in the bidding process.
- 12. Other information as well as terms and conditions, which are not covered above, will be available in Instructions to Bidders, General Conditions of Contract of this tender along with the Revised Purchase Policy and Civil Works Policy of WBSEDCL.
- 13. Price Bid of a bidder will be considered only if his Techno-commercial Bid is found acceptable by WBSEDCL. Decision of WBSEDCL will be final and absolute/binding in this respect. The list of techno-commercially qualified bidders will be displayed in the said website in due course.
- 14. Conditional / Incomplete tender will not be accepted under any circumstances.

- 15. The bidder is expected to examine carefully all instruction, conditions, forms, schedules terms, annexure, specifications and drawings of the bidding document. Bids, which are determined to be not substantially responsive to the requirement of the bidding document, may lead to rejection.
- 16. The Bidder at the Bidders own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. The costs of visiting the site shall be at the Bidders own expense.
- 17. EMD can be deposited in the online mode only.
- 18. For deposition of EMD through online mode (Bank Name-ICICI Bank Ltd., A/C No.-193405000657, Account Title- West Bengal State Electricity Distribution Company Ltd., Account Type –Current, IFSC Code-ICIC0001934, MICR Code-700229096, ICICI BANK LTD., BLOCK-A, ECOSPACE BUSINESS PARK, RAJARHAT, KOLKATA-700156.) following options are available for payment of EMD for the intending bidders-

i. Net-banking through Payment Gateway.
ii. RTGS/NEFT Payment: On selection of RTGS/NEFT as the payment mode, the e-procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.

Bidders are also advised to submit EMD of their bid, at least 1 working day before the bid submission closing date as it requires time for processing of payment of EMD.

Exemption from deposition of earnest money deposit (EMD) shall not be allowed under any circumstances. No interest shall be payable for Earnest Money.

- 19. The eligibility of a Bidder will be ascertained on the basis of the decuments submitted by a Bidder in support of eligibility criteria. If any document submitted by a Bidder is either Incorrect / manufactured / fabricated or false at any stage, his Tender will be out rightly rejected and legal action will be taken against him.
- 20. The participating bidders may please note that the successful bidder shall have to submit an Indemnity Bond and an Agreement in the prescribed format before commencement of the work.
- 21. The WBSEDCL reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
- 22. The documents uploaded by the bidders should be legible otherwise the bid will be rejected without any prejudice.
- 23. Bid evaluation will be conducted only on the basis of final documents uploaded by the bidders within last date and time of online bid submission.
- 24. Successful bidder(s) shall have to mandatorily create vendor id through WBSEDCL Web Portal Vendor Corner if not created earlier.
- 25. Constructional Labor Welfare Cess @ 1% (one percent) of cost of construction will be deducted from every Bill.
- 26. Additional Performance Security which shall be equal to 10% of the tendered amount must be furnished by the successful bidder if the accepted bid value is 80% or less of the estimate put to tender (L1 bid in the range of -20% to -80%). The additional Performance Security shall be submitted in the form of Bank Guarantee from any scheduled bank valid for a period of 1 (one) year, as per specified format marked 'Annexure A' enclosed with this NIT, before issuance of the Work Order. This is in compliance of the terms of Memorandum No. 4608-F(Y) dated 18.07.2018 of the Finance department, Government of West Bengal.
