Online e-tenders in two-part system [i) Technical Bid and ii) Financial Bid] with item-wise basis are invited by The Addl. Chief Engineer & Project Manager, Rammam Hydel Project, Stage - II, WBSEDCL, Lodhamahat, Darjeeling-734201 from Bonafide eligible, resourceful and experienced agency having requisite credentials of *"Installation and commissioning of Pelton Runner along with dismantling of existing damaged runner and returning it to store for 01 (one) no. 12.75 MW T-G set installed within the Power House of Rammam Hydel Project, St-II"* at Rammam Hydel Project, Stage-II, WBSEDCL, Lodhamahat, Darjeeling-734201.

- 1. Name of Work:** *"Installation and commissioning of Pelton Runner along with dismantling of existing damaged runner and returning it to store for 01 (one) no. 12.75 MW T-G set installed within the Power House of Rammam Hydel Project, St-II"*
- 2. Estimated Amount:** Rs. 3,00,000.00/- (Rupees Three Lakh only), without GST
- 3. Earnest Money:** Cost of earnest money against this tender is Rs 7,500/- for all bidders.
- 4. Eligibility Criteria:** The Bidder must possess minimum eligibility criteria as mentioned below:
 - a. Valid GST Registration Certificate
 - b. PAN Card
 - c. License in respect of prospective bidder such as Proprietorship Firm (Trade License), Partnership Firm (Partnership deed, Trade License), Ltd. Company (Incorporation Certificate, Trade License).
 - d. The Bidder must have satisfactorily completed works related to servicing of different electromechanical parts like runners, bearings, sluice gates, gate valves etc. in any hydroelectric power station in India.In support of the above, the bidders shall submit the copy of Letter of Award (LOA) and respective Delivery Certificate and/or Completion Certificate duly signed by respective ordering authority.

6. The Intending bidders may download the tender documents from the website <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate. The Interested bidders may submit the bids online at <https://wbtenders.gov.in>. Bids are to be submitted online only. All the documents in support of bid are also to be scanned and uploaded along with the tender document. Bid submitted/sent by any other mode will not be accepted.

7. Scope of Work:

- i) Transportation of used and healthy runner from RHP store to Power House.
- ii) Dismantling of the auxiliary shaft and shifting it to the service bay.
- iii) Dismantling of the damaged runner from the main shaft and shifting the same to the service bay.
- iv) Installation of the used and healthy runner to the main shaft and aligning it properly with reference to the center of the nozzles.
- v) Refixing of the auxiliary shaft to its existing position.
- vi) Shifting of the damaged runner to the RHP, St-II store.
- vii) Commissioning including running the T-G set and observing its behavior at no-load and in loaded condition up to the satisfaction of the controlling officer including all test procedures.

For detailed scope of work, the bidders are requested to go through **Cl. No. 2 of SCC**.

8. **Validity:** The tender shall be valid for one hundred and eighty (180) days from the date of opening of technical bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled.

9. Conditional / Incomplete tender will not be accepted under any circumstances.

10. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice. Evaluation of bid will be done only considering documents provided.

11. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by a Bidder in support of eligibility criteria. If any document submitted by a Bidder is either incorrect / manufactured / fabricated or false at any stage, his Tender will be rejected and legal action may be taken against him along with forfeiture of Earnest Money.

12. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s). WBSEDCL reserves its right to take decision keeping its financial interest.

13. WBSEDCL reserves the right to:

- Amend the scope of work to be tendered.
- Reject any or all the offers without assigning any reason whatsoever at any time prior to the Award of Contract, without thereby incurring any liability to the affected bidder(s); and
- Cancel the bidding process and reject all bids, without assigning any reasons thereof.

WBSEDCL will not be liable for any such actions. However, the bidder(s), who wish to seek reasons for such decision of cancellation / rejection, shall be informed by

WBSEDCL unless its disclosure reasonably could be expected to affect the sovereignty and integrity of India; the security, strategic, scientific or economic interest of the State; relation with foreign state or lead to incitement of an offence. In such case, the Earnest money submitted by the bidder(s) will be refunded to the bidder without any interest.

14. WBSEDCL reserves the right to assess the bidders' capacity and capability to perform the contract and may relax the qualifying requirements at any stage, if required.
15. No price preference will be allowed to any agency/supplier/contractor based on the size of the company or its geographic location. Co-operative Society / MSME will not be considered with separate status.
