- 1) Name of the Work: Demolition of 2 nos. of 2-storied quarter buildings within the premise of Dabgram 33/11 kV Sub-station under Siliguri Town Division.
- 2) Eligibility Criteria: The Bidder must possess valid up to date <u>Trade Licence</u>, <u>Professional Tax Registration Certificate/Registration No. (P. Tax Registration Certificate/Enrolment Certificate as applicable)</u>, <u>current professional tax payment certificate along with payment challan</u>, <u>PAN</u>, <u>GST registration certificate</u>, <u>Latest GSTR-3B & Civil related credential*</u> and digitally signed copy of the same shall be submitted along with the online application through portal.

(*The bidder must have successfully completed any civil works like demolition, erection, construction, maintenance etc. in last 7 years (i.e. upto 30.11.2024) of value not less than Rs.2,30,942/- under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government. Satisfactory Completion Certificate indicating estimated amount and/or Ordered Amount, Value of work-done and Date of completion of the work and detail communicational address along with contact details of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. The bidder is to upload the LOA/Execution Order/PO in full along with the BOQ showing the full description of items in respect of the work for which completion certificate is being uploaded. Delay in completion of work, if any, must be mentioned in completion certificate along with the reason.)

3) Intending bidders should download the auction documents from the website http://www.wbtenders.gov.in directly with the help of Digital Signature Certificate (DSC). Necessary Earnest Money Deposit (EMD) should be remitted through

online mode. EMD collected via online mode will be settled automatically from e-tendering portal maintained by National informatics Centre (NIC) wherein EMD for rejected or unsuccessful bids shall be refunded in the bank account of participating bidders directly from NIC Portal. However, for successful bidder the Earnest Money will be converted into Security Deposit.

- 4) All bids are to be submitted duly digitally signed by the Bidder through the website https://wbtenders.gov.in. (Details of which has been narrated in 'Instruction to Bidders') as per Schedule stated below.
- 5) Any MOU/Temporary Agreement/Joint Ventures/Consortium/Any other arrangement to constitute an Entity having no statutory Registration Certificates (Non-Permanent Establishment) for the purpose of applying as prospective bidder will not be considered as valid.
- 6) Performance as prime contractor applying as prospective bidder for execution of similar nature of work for last seven years will only be considered.
- 7) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt/Govt Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. A declaration on Rs. 100.00/- Non-Judicial Stamp duly notarized by Notary Public, in this respect has to be furnished by the prospective bidders.
- 8) No conditional/incomplete/inadequate/wrong submission of Tender Documents and facts will be accepted under any circumstances and no further prayer for consideration will be entertained.
- 9) The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
- 10) No mobilization advance and secured advance will be allowed.
- 11) A prospective Bidder shall be allowed to participate in the auction either in the capacity of individual or as a partner of firm, Society, Company, Registered Unemployed Engineers Co-operative Society/Registered Labour Co-operative Society. If found applied severally in a single job, all his offers will be rejected for that job.
- 12) Bid shall remain valid for a period not less than 180 (one hundred twenty) days from the date of opening of Financial Bid. If the bidder modifies/withdraws the bid during the interval between the deadline for submission of bids and the expiry of the period of bid validity, the bid will be cancelled with forfeiture of earnest money deposit (EMD).

- 15) The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
- 16) Exemption from deposition of earnest money deposit (EMD) shall not be allowed under any circumstances.
- 17) Conditional / Incomplete bid will not be accepted under any circumstances.
- 18) The intending Bidders are required to quote the rate online only through auctioning process.
- 19) During scrutiny, if it comes to the notice of the auction inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice and appropriate course of actions shall be taken accordingly.
- 20) Canvassing in connection with the tender is strictly prohibited in the Auction submitted by the Bidder.
- 21) The eligibility of a Bidder will be ascertained on the basis of the documents submitted by a Bidder in support of eligibility criteria. If any document submitted by a Bidder is incorrect/ manufactured / fabricated or false at any stage, his Tender will be out rightly rejected and legal action will be taken against him.
- 22) The participating bidders may please note that the successful bidder shall have to submit an Indemnity Bond along with Agreement in the prescribed format before commencement of the work.

- 23) The WBSEDCL does not bind itself to accept the highest bidder and reserves the right to reject any or all bid(s) or to split the whole work to more than one contractor without assigning any reason whatsoever.
- 24) The WBSEDCL reserves the right to cancel the N.I.A. due to unavoidable circumstances and no claim in this respect will be entertained.
- 25) **Payment**: 100% payment of auctioned obtained value along with applicable 18% GST & TCS shall be paid by you before commencing of work.
- 26) Earnest Money Deposit: Intending bidder(s) shall submit Earnest Money Deposit (EMD) as mentioned prior. Bid submitted without EMD fee shall be rejected. At no circumstances, waiver of EMD shall be allowed. After successful completion of auction formalities, the EMD of the unsuccessful bidders shall be refunded through WB Tender Portal. In any case the auction, if gets cancelled due to any unavoidable circumstances, the EMD of all the participants shall be refunded as per norms of WBSEDCL. However, the EMD money of the successful (H1) bidder shall be converted in tune to the Security Deposit for the work, which shall be refunded after successful completion of work.
- 27) **Security Deposit:** The EMD(2%) deposited with the tender will be converted into initial Security Deposit. The successful bidder shall have to deposit balance security deposit after placement of order (before commencement of work) to constitute total security deposit to the tune of 10% of the contract price.
- 28) The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL.
- 29) The price will be firm and no change in price will be considered under any circumstances.
- 30) The goods & service tax must be paid by successful bidder as per GST statute.
- 31) The Chief Enineer (Dist.-North), Siliguri, WBSEDCL shall be the Controlling Officer.

- 36) **Liquidated Damages (LD):** If the contractor fails to complete the work successfully within the time specified in the contractor any extension thereof, the company shall recover from the contractor (through submitted Security Deposit as liquidated damages a sum of half percent (0.5%) of the contract value of works for each calendar week of delay or part thereof of delay subjected to Force Majeure. The total recovery against liquidated damage shall not exceed ter percent (10%) of the contract value of the work.
- 37) **Extension of Time:** An extension of time without imposition of liquidated damage, may be granted for delay ir execution of work provided there is no fault whatsoever on the part of the contractor. Such extension may only be granted on the basis of application to be submitted by the contractor who has to establish that the extension of time required by him was not due to his fault.
- 38) All declarations and annexures must be submitted by bidder(s) as applicable while applying for the auction.
- 39) IN NO CASE LESS QUOTE FROM THE RESERVED BASE PRICE SHALL BE ACCEPTED. In case of any bidder quote less than the reserve base price, his application shall be immediately rejected.
