SCOPE OF WORK:

The specification/contract is intended to cover execution of civil work proposed for SI.No.-1 "Repair and Maintenance of Switch yard Cable trench, Pathway, equipment foundation and Control Room Bullding at Beraberia 33/11KV Sub-Station, Dist Purba Medinipur" and any other works required for completion of the works in all respect as per technical specification, schedule of works and approved drawings.

SUBMISSION OF TENDER:

The tender will be submitted in two bid systems i.e. Techno-Commercial bid & Financial bid, online only through the Website

4. ELIGIBILITY CRITERIA OF THE BIDDER:

4.1 Technical:

The bidder must have successfully completed the similar nature of work (inside the 33/11 kv sub station) not less 80%/60%/40% (Eighty/Sixty/Forty percent) of the estimated cost in a Single/Two/Three contracts respectively during last 05 (five) years.

4.2 Commercial & Financial:

- 4.2.1 The average annual turnover during last three year shall not be less than 30% of the estimated cost (Annexure-I).
- **4.2.2** Working capital in the year preceding the year of bid submission shall not be less than 30% of the estimated cost.
- 4.2.3 Bidder must submit the upto date documents of GST and GST return of current and previous 2 (Two) years.

4.3 The Bidder must include following documents to substantiate the qualifying Requirement such as:

- 4.3.1 Monetary value of similar work performed by the bidder in last five year (copy of order and completion certificate to be enclosed)(Annexure-II).
- **4.3.2** Major items of construction equipment proposed to carry out the Contract (Annexure-III).
- **4.3.3** Qualification and experience of key site management and technical personnel proposed for the contract (**Annexure-IV**).
- **4.3.4** Reports on financial standing of the bidder, such as profit and loss accounts & balance sheets and Auditor's report etc. for the last financial year i.e. 2023-24 and I.T return for financial year

- 2021-22, 2022-23, 2023-24 should be uploaded.
- 4.3.5 Information regarding any litigation, current or during last five years in which the bidder is involved, the parties concerned and the disputed amount.
- 4.3.6 Photocopy of following documents:
 - i) P. Tax with valid certificate.
 - ii) PAN Card.
 - iii) P.F Registration No. and E.S.I. along with challans.
 - iv) G.S.T. Registration Certificate/ Number.
 - Documents related to Statutory Compliance of manpower mobilised at site for the successful lowest bidder.
- 4.3.7 Photocopies of all documents should be self authenticated.
- 4.3.8 Not withstanding anything stated above, the owner (WBSEDCL) Reserves the right to assess the capacity and capability of the bidder to Execute the work, should the circumstances warrant such assessment in The overall interest of the owner.
- 4.3.9 Even though the bidders meet the above qualifying criteria, they are Subject to be disqualified if they have
 - i) Made misleading or false representation in the forms, statements and Attachments submitted in proof of the qualifying requirements and/or
 - ii) Record of poor performance such as abandoning the work, not Properly completing the contract, inordinate delays in completions, Litigation history or financial failure.
- 4.3.10 One Affidavit before Notary will have to be uploaded online mentioning the correctness of the documents uploaded along with this tender.
