

- 1. Techno-Commercial Requirements of the Bidder (Must Conditions):
 - Experience of having successfully completed civil works during last 7 (seven) years with fulfillment of any of the following criteria:
 - a) 3 similar completed works, each costing not less than 40% of the estimated value or,
 - b) 2 similar completed works, each costing not less than 50% of the estimated value or,
 - c) One similar completed work, costing not less than 80% of the estimated value.
 - Valid PAN, EPF code no., GST registration no., current Professional tax payment certificate.
 - Copy of IT Return for last 3 (three) financial years.
- 2. For e-filling of bids, intending bidder shall download the bid documents from the website: https://wbtenders.gov.in directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule below.

Earnest Money Deposit shall be mandatorily deposited online through the website https://wbetenders.gov.in via Net-banking via Payment Gateway or RTGS/NEFT Payment, as elaborated in the Section "Instructions to Bidders" of the bid document. There is no option for offline submission of EMD through DD/Pay order/Banker's cheque/BG etc. There is no tender cost for this tender.
- 4. Price Bid of a bidder will be considered only if his Techno-commercial Bid is found acceptable by WBSEDCL. Decision of WBSEDCL will be final and absolute in this respect. The list of techno-commercially qualified bidders will be displayed in the said website in due course.
- 5. No mobilization advance and secured advance will be allowed.
- 6. GST & labour cess are not included in the estimated cost and shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules.
