Intending bidders desirous of participating in the tender are to log on to the website <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a> for the tender. The tender can be searched by typing WBSEDCL in the search engine provided in the website.

Bidders willing to take part in the process of e-tendering are required to obtain Digital Signature Certificate (DSC) in the name of person who will sign the tender, from any authorized Certifying Authority (CA) under CCA, Govt of India (viz. nCode Solution, Safescrypt, e-Mudhra). DSC is given as a USB e-Token. After obtaining the Class 2 or Class 3 Digital Signature Certificate (DSC) from the approved Certifying Authority they are required to register the fact of possessing the Digital Signature Certificates through the registration system available in the website.

Tenders are to be submitted online and intending bidders are to download the tender documents from the website stated above, directly with the help of the e-Token provided. This is the only mode of collection of tender documents. Details of submission procedure are given in "Instructions to Bidders".

# Terms & conditions of the Tender Notice:

- The e-tender will be of <u>single part</u> for empanelment of meter manufacturers. The empanelment will remain valid for at least a period of two years with provision for further extension of one year. Interested meter manufacturers <u>should submit their sample meter at our Distribution Testing Department</u> within the scheduled date mentioned above. The relevant papers as per format should be uploaded in the portal of the e-tender. The sample meter should comply the technical requirements of our technical specification uploaded against the tender.
- The tenderer or their duly authorized representative should attend the Pre-bid Meeting at the stipulated date and time. Queries related to the tender document, should be sent through e-mail to procurementdept@wbsedcl.in and cedtd@wbsedcl.in.

# 3. Following payment options are available for paying Fixed EMD amounting to Rs. 5,00,000/- through Online mode:

i. Net-banking through Payment Gateway.

ii.RTGS/NEFT Payment: On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e-Procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.

In case actual **EMD amount** as per NIT is **more than the one shown in e-tender portal**, the bidder shall mandatorily opt for **NEFT/RTGS(Challan mode)**. In that case, the **total actual EMD amount** is to be paid only through NEFT/RTGS mode (Challan mode). Challan, thus generated will contain the amount which has been mentioned in e-tender portal. However, for payment of actual amount calculated as per NIT, bidders shall **strike out** the

amount in Challan and **manually put actual EMD amount** while following the due payment procedure at respective Bank.

iii. Submission of EMD through BG: For submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in e-tender portal and upload scanned copy of BG in the EMD exemption document upload section. Bank Guarantee (BG) should be drawn on any Scheduled Bank drawn as per the Proforma of Bank Guarantee for Earnest Money, given with this tender documents vide Annexure-III with initially valid for upto 42 (forty two) months from the due date of submission of tender and with a claim period of another 3 (three) months, subject to further extension if required, in favour of West Bengal State Electricity Distribution Company Limited payable at Kolkata.

Physical copy of BG shall be submitted at the office of tender inviting authority as per respective clauses of NIT.

- 5. The Earnest Money Deposit of the participating manufacturers will be refunded after expiry of the total empanelment period.
- 6. The bidder shall submit **along with the offer** necessary documents in support of their previous supply of the items of the tender to WBSEDCL/Other Power Utilities/Other Govt. Departments.
- 7. No agent is allowed to participate in the Tender. Original manufacturers will only be allowed in the tender.
- 8. Techno-commercial evaluation of bid document will be done at Procurement & Contracts Department. The testing of sample meter will be done at our Distribution Testing Department at a pre-scheduled date in presence of the representative of respective meter manufacturer. The list of eligible and qualified meter manufacturers will be finalised by in-house committee, on the basis of sample testing report and techno-commercial evaluation of the bid submitted online.

In case of manufacturers who deposit "sample meter" and fail in 1<sup>st</sup> sample testing, they will get a chance to improve their product and offer for retesting at our Distribution Testing Department through a prayer to be submitted at Procurement & Contracts Department. Retesting may be done after expiry of at least three months from the date of completion of entire 1<sup>st</sup> sample testing. Sample for retesting may be submitted maximum upto two times during the entire period of empanelment. For retesting of sample meter, non-refundable amount of Rs.20,000/-+GST, will have to be deposited by the respective meter manufacturer. The approved meter will be kept as 'Prototype Sample' of individual manufacturers for the entire period of empanelment. List of empanelled manufacturers for a particular type of meter, will be posted in WBSEDCL website. Limited tender will be floated later on, among empanelled vendors, for procurement of meters of that type, as per site requirement for six months consumption.

# **Instructions to Bidders**

# · Eligibility for participation:

- Original manufacturers of the tendered items will only be eligible in the tender.
- The bidders shall have credential for supply of the tendered items to WBSEDCL / other Power Utilities / other Govt. Departments in earlier occasions within last three financial years.
- Summary statement (Vide Form-VI) of average annual turnover for a period of the last three financial years, certified by the Auditor appointed under Companies Act, 2013, should be submitted for enlistment.

During tender for procurement, pro-rata annualised value of the orders in bidder's hand corresponding to the contract period of the tender alongwith the estimated value of the offer of the bidder should not exceed 150% of the Average Annual Turnover of the last three completed financial years.

#### General guidance for e-Tendering :

Instructions/Guidelines for electronic submission of the tenders have been mentioned below for assisting the bidders to participate in e-Tendering.

#### Registration of bidder :

Any bidder willing to take part in the process of e-Tendering will have to be enrolled & registered with the e-Procurement system, through logging on to <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a>.

#### • Digital Signature certificate (DSC):

Each bidder is required to obtain a class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders.

#### 6.1 General process of submission

Tenders are to be submitted online through the website <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a>. All the documents uploaded by the Tender Inviting Authority form an integral part of the contract. Tenderers are required to upload all the tender documents along with the other documents, as asked for in the tender, through the above website within the stipulated date and time as given in the Tender. The tenderer shall carefully go through the documents and prepare the required documents and upload the scanned documents in Portable Document Format (PDF) to the portal in the designated locations of Technical Bid.

The bidder needs to download the Forms / Annexures, fill up the particulars in the designated Cell and upload the same in the designated location of Technical Bid.

The documents uploaded shall be virus scanned and digitally signed using the Digital Signature Certificate (DSC). Tenderers should take note of all the addendum/corrigendum related to the tender and upload the latest documents as part of the tender.

- 3. GSTIN no. of factory premises, from where goods will be dispatched and relevant HSN code of the material, are to be mentioned in a separate sheet and uploaded in the bid.
- 4. Evaluation of the price bids will take into account the Unit Landed Cost of the material/equipment at the final destination. For the purpose of evaluation, the Unit landed cost will be arrived at by adding the Ex-works, F&I charges and GST as applicable.
- 5. TDS on GST will be applicable.
- 6.
