

c. Any defect cropped up within defect liability period, the same shall be rectified by you at your own cost and within time frame as decided by the controlling officer. Such defect shall be intimated to you in writing.

7.0 Force Majeure:

- a. The Contractor shall not be liable to pay any liquidated damage for delay/failure to perform the contract for reasons of force majeure such as acts of God, acts of the public enemy, acts of Governments, fire, flood, epidemics, quarantine restriction, strikes, freight embargos and provided that the contractor shall within 10 (ten) days from the beginning of such delay notify the Company in writing of the cause of delay.
